**Confirmation of Minutes**

On motion by Don Altman, the minutes of the meeting of the Bid Committee held on October 12, 2005, were confirmed.

**41.1 Contract 05NY&SC-320WS- Tender Call 206-2005 - Water Service Replacements at Various Locations in North York and Scarborough Districts**

The Bid Committee considered a report (October 4, 2005) from the Acting General Manager of Toronto Water and the Acting Director of Purchasing and Materials Management, advising on the results of the Tender Call issued for Water Service Replacements at Various Locations in North York and Scarborough Districts, in accordance with specifications as required by Toronto Water, and requesting authority to award a contract to the recommended bidder.

Recommendation:

It is recommended that Contract 05NY&SC-320WS, Tender Call 206-2005, for Water Service Replacements at Various Locations in North York and Scarborough Districts, be awarded to CG Construction Services Ltd., in the amount of \$881,683.10, including all taxes and charges, being the lowest bid received.

On motion by Kevin Connors, the Bid Committee adopted the staff recommendation in the Recommendation Section of the report.

**41.2 Contract 05FS-37S, Tender Call 221-2005 - Design and Construction of Absorptive-Type Noise Barrier Wall System on the West Side of William R. Allen Road, from Eglinton Avenue West to Fairleigh Crescent/Aldburn Road (Ward 21 - St. Paul's)**

The Bid Committee considered a report (October 13, 2005) from the Executive Director of Technical Services and the Acting Director of Purchasing and Materials Management, advising on the results of the Tender issued for the Design and Construction of an Absorptive-type Noise Barrier Wall System, on the West Side of William R. Allen Road, from Eglinton Avenue West to Fairleigh Crescent/Aldburn Road in accordance with specifications as required by the Technical Services, and requesting the authority to award a contract to the recommended bidder.

Recommendation:

It is recommended that Contract 05FS-37S, Tender Call 221-2005, for the design and construction of the absorptive type noise barrier wall system on the west side of William R. Allen Road, from Eglinton Avenue West to Fairleigh Crescent/Aldburn Road, be awarded to Powell (Richmond Hill) Contracting Ltd., in the total amount of \$743,650.00 including all taxes and charges, being the lowest bid received.

On motion by Abdi Nur, the Bid Committee adopted the staff recommendation in the Recommendation Section of the report.

**41.3 Contract ET78851-2005, Tender Call 185-2005 - 60 Tiffield Road Renovations for Integrated Technologies System Services Relocation**

The Bid Committee considered a report (October 13, 2005) from the Acting General Manager of Toronto Water and the Acting Director of Purchasing and Materials Management, advising on the results of the Tender Call issued for 60 Tiffield Road renovations, for ITSS relocation, in accordance with specifications as required by the

Toronto Water Division, and requesting authority to award a contract to the recommended bidder.

Recommendation:

It is recommended that Contract ET78851-2005, Tender Call 185-2005, for 60 Tiffield Road renovations, for ITSS relocation, be awarded to Brown Daniels Associates Inc., in the amount of \$2,845,474.55 including all taxes and charges, being the lowest bid received.

On motion by Don Altman, the Bid Committee adopted the staff recommendation in the Recommendation Section of the report.
