Confirmation of Minutes

On motion by Laurie McQueen, the minutes of the meeting of the Bid Committee held on October 26, 2005, were confirmed.

43.1 Contract 05WD-21RD, Tender Call 217-2005 - Reconstruction of Horner Avenue from Evans Avenue to Judson Road (Ward 6 - Etobicoke Lakeshore)

The Bid Committee considered a report (October 3, 2005) from the Executive Director of Technical Services and the Manager of Purchasing and Materials Management, Goods and Services, advising on the results of the Tender issued for the Reconstruction of Horner Avenue, from Evans Avenue to Judson Road, in accordance with specifications as required by Technical Services, and requesting the authority to award a contract to the recommended bidder.

Recommendation:

It is recommended that the Contract 05WD-21RD, Tender Call 217-2005, for the Reconstruction of Horner Avenue, from Evans Avenue to Judson Road, be awarded to Pave-Al Limited & Orlando Corporation, in the amount of \$1,488,823.68, including all taxes and charges, being the lowest bid received.

On motion by Wayne Scott, the Bid Committee adopted the staff recommendation in the Recommendation Section of the report.

43.2 Request for Quotation (RFQ) 0505-05-0200 - Supply and Delivery of Various Medical Nursing Supplies to All Homes for the Aged Operated by the City of Toronto

The Bid Committee considered a report (October 15, 2005) from the Acting Director of Purchasing and Materials Management, advising on the results of the Request for Quotation (RFQ) issued for the Supply, Delivery, of Various Medical Nursing Supplies to all Homes for the Aged operated by the City of Toronto on an as and when required basis from the date of the award to July 31, 2006, with an option to renew for two(2) separate one(1) year periods from August 1, 2006 to July 31, 2007, and from August 1, 2007 to July 31, 2008, under the same terms and conditions, and requesting the authority to issue the contract to the recommended bidder.

Recommendation:

It is recommended that the quotation submitted by the lowest acceptable bidder meeting specifications, Source Medical Inc., be awarded a contract for the period from the date of the award to July 31, 2006, in the amount of \$381,947.71 including all charges and applicable taxes, being subject to an option to renew for two (2) separate one (1) year periods to be exercised by the Homes for the Aged Division, for the period from August 1, 2006 to July 31, 2007, in the amount of \$539,910.36 including all charges and applicable taxes, and from August 1, 2007 to July 31, 2008, in the amount of \$539,910.36 for a total contract amount of \$1,564,092.30 from the date of the award to July 31, 2008, provided that the supply, and delivery of Various Nursing Medical Supplies were performed at a satisfactory level and subject to budget approval, to instruct the Purchasing Agent to process the necessary contract renewals under the same terms and conditions.

On motion by Margaret Evans, the Bid Committee adopted the staff recommendation in the Recommendation Section of the report.

43.3 Contract 05WD-09RD, Tender Call 225-2005 - Pavement Reconstruction on Local Streets (Ward 12 - York South-Weston, Ward 14 - Parkdale-High Park and Ward 17 - Davenport)

The Bid Committee considered a report (October 26, 2005) from the Executive Director of Technical Services and the Manager of Purchasing and Materials Management, Goods and Services, advising on the results of the Tender issued for Pavement Reconstruction on Local Streets, in accordance with specifications as required by Technical Services, and requesting the authority to award a contract to the recommended bidder.

Recommendation:

It is recommended that Contract 05WD-09RD, Tender Call 225-2005, for Pavement Reconstruction on Local Streets, be awarded to Il Duca Contracting Inc., in the amount of \$1,127,532.83, including all taxes and charges, being the lowest bid received.
