Confirmation of Minutes

3.1 Bicycle Motor-Vehicle Collision Study

David Tomlinson, Planning Technician, Pedestrian and Cycling Infrastructure, Transportation Services, Works and Emergency Services, made a PowerPoint presentation regarding the Bicycle Motor-Vehicle Collision Study.

A copy of the PowerPoint presentation was distributed to members of the Toronto Cycling Committee.

3.2 2005 Cycle Right Campaign

Constable Steve Burns, Traffic Services, Toronto Police Service, made a presentation regarding the 2005 Cycle Right Campaign.

Constable Steve Burns provided a communication (March 14, 2005) detailing the parking offences tickets that have been issued in 2002, 2003 and 2004, as part of the Cycle Right Campaign. The communication also provided information regarding the number of Bike Rodeos held in 2002, 2003 and 2004 and the number of participants at the Bike Rodeos for each year.

Constable Burns advised that the 2005 Cycle Right Campaign will be held from June 13, 2005 to June 25, 2005.

 - (c) have alternating messages for cycling (Year 1 Cycling safety, Year 2 "Get out and ride!", Year 3 Cycling safety, etc.); and
 - (d) Toronto Cycling Committee members be requested to invite local Councillors to Bike Week events that they are attending.

On Motion by Ms. Nowak, the Toronto Cycling Committee recommended that:

- (2) the Works Committee request the Acting Commissioner of Works and Emergency Services to formulate a comprehensive policy on addressing cycling issues when road/bridge reconstruction is undertaken to ensure that there is appropriate accommodation for cyclists and pedestrians in construction zones, including speed reductions, signage and maintenance of cycling routes wherever possible during construction.

 - (a) the Toronto Bike Plan be accommodated with access for cyclists at all crossings being maintained;
 - (b) access for cyclists at rail stations (e.g. Union, Dundas, Airport) and new bicycle facilities be provided (bike parking, lockers, racks);
 - (c) the new trains allow for bicycles at all times of the day; and
 - (d) a new bicycle trail be created, which will run parallel to the rail line.
