2.1 Technology End of Lease Strategy Initiative (TELS) Progress Report on Purchasing Requirements for Second Quarter 2005

The e-City Committee considered a report (April 11, 2005) from the Commissioner of Corporate Services reporting on the equipment requirements for the Technology End of Lease Strategy Initiative for the second quarter, 2005.

On motion by Councillor Del Grande, the e-City Committee indicated that it would welcome the attendance at meetings and provision of information by the Information Technology Association for Canada for Ontario (ITAC) and requested the Executive Director of Information and Technology to report back to the e-City Committee as soon as possible on:

- (1) the opportunity to test or try out any products that the Information Technology Industry feels the City should be made aware of; and
- (2) how an ongoing relationship with the Association could be developed.

2.5 Online Services – Parking Ticket Payment System

The Director, Revenue Services, and Manager, Water and Parking Tags gave a PowerPoint presentation, titled "City of Toronto e-Service: Parking Tickets".

2.6 Works Committee Report 3, Clause 2a – Review of Automated Vehicle Location (AVL) and Management Control System Pilot Project in Solid Waste Management Services

The e-City Committee considered a communication (May 5, 2005) from the City Clerk advising that City Council on May 4, 2005, referred this Clause, to the Works Committee and the e-City Committee and requested the City Manager to report to the Works Committee on the implementation of a co-ordinated effort across the Corporation, including the City's agencies, boards and commissions, on the Automated Vehicle Location and Management Control System Pilot Project, such report to be submitted to Council for consideration at its meeting on June 14, 2005.

On motion by Councillor Soknacki, the e-City Committee recommended to City Council that:

- (1) the Executive Director of Information and Technology, in consultation with the City's Agencies, Boards, Commissions and Divisions, be requested to report to the e-City Committee as soon as possible with a framework and protocol for automated vehicle location systems; and
- (2) prior to Council's adoption of the automated vehicle location systems framework and protocol the City's Agencies, Boards, Commissions and Divisions, be requested to advise the Executive Director of Information and Technology if any such programs are under evaluation.

On motion by Councillor Soknacki, the e-City Committee requested that a copy of the recommendations of the e-City Committee be forwarded to the City Manager and Works Committee for information to assist in their response to Council's referral of the pilot project.
