Councillor Filion in the Chair.

Confirmation of Minutes

On motion by Councillor Fletcher, the Minutes of the meeting of the Board of Health on November 22, 2004, were confirmed.

1.1 Election of Chair and Vice-Chair

The Secretary asked for nominations for Chair. Councillor Fletcher nominated Councillor Filion, who accepted. There being no further nominations, the Secretary declared nominations closed.

Councillor Filion was unanimously elected Chair of the Board of Health for a one-year term.

Councillor Filion assumed the Chair.

Councillor Filion asked for nominations for Vice-Chair. Councillor Davis nominated Councillor Fletcher, who accepted. There being no further nominations, Councillor Filion declared nominations closed.

Councillor Fletcher was unanimously elected Vice-Chair of the Board of Health for a one-year term.

1.9 Toronto Public Health 2005 Operating Budget – Update on Executive Management Team (EMT) Recommendations and Ministry of Children and Youth Services (MCYS) Funding

The Board of Health considered the following:

"Potential Nutrition Program for at-risk youth in the City of Toronto"

WHEREAS teens, especially girls, are at increased nutritional risk, due to higher energy and nutrient needs for growth and development, regardless of family income; however, this is further compromised when these teens are at risk, also live in low income circumstances, are new to Canada, etc.

WHEREAS it would be advantageous to target at-risk teens in the neighbourhoods named by the Mayor's Safety Committee; including Malvern, Jamestown, Jane-Finch and Kingston-Galloway. Many of the teens in these areas face issues of hunger, living independently, teen pregnancy, single parent families, and limited resources to meet nutritional needs. Pregnant teens, in particular, are at risk of having low birth weight babies.

THEREFORE BE IT RESOLVED THAT:

- (1) the Medical Officer of Health report to the February Board of Health meeting on establishing at-risk teens nutrition programs in those communities identified in the Mayor's Community Safety Strategy; and
- (2) this report include the additional resources required, utilizing a proposed partnership funding model between Toronto Public Health and the Toronto School Board Foundations in conjunction with provincial funding. (Carried)

1.10 Further Issues Relating to the Implementation of the Pesticide By-law

The Board of Health considered the following:

(a) report (January 10, 2005) from the Medical Officer of Health, reporting further on implementation of the Pesticide By-law including setting action thresholds and implementing inspection guidelines.

Recommendations:

- (1) the Board of Health adopt this report and forward it to City Council;
- (2) the Board of Health and Council endorse that:
 - (a) no properties within the municipal boundary of the City of Toronto be exempted from the Pesticide By-law;
 - (b) the preferred means of complying with the Pesticide By-law is through applying the methods of Plant Health Care (PHC);
 - (c) if the use of non-exempted pesticides is justified, its use should conform to the principles of Integrated Pest Management (IPM);
- (3) with respect to "Action Thresholds", the Board of Health and Council:
 - (a) reaffirm the previous recommendation of the Chief Administrative Officer (CAO) that there be no action thresholds established for fungicides or herbicides on residential lawns, cemeteries and general parkland;
 - (b) request that the Medical Officer of Health adopt the Ontario Ministry of Agriculture and Food (OMAF) action thresholds for chinch bugs and grubs as guidelines in the enforcement of the bylaw on residential, commercial and institutional turf:
 - (c) request that the Medical Officer of Health monitor the emergence of new action thresholds on an ongoing basis;
 - (d) endorse that golf courses, bowling greens, and transportation and utility rights of way be subject to proactive inspections on a regular

basis, in addition to complaint response inspections by Toronto Public Health:

- (e) direct the Medical Officer of Health to request golf courses, bowling greens, and transportation and utility rights of way to submit an annual report on pesticide use and strategies to reduce pesticide use;
- (4) with respect to properties managed by Parks and Recreation (in addition to golf courses and bowling greens), the Board of Health and Council:
 - (a) direct the General Manager of Parks and Recreation to employ Plant Health Care methods in the management of City-owned turf (including general parkland, sports fields and destination parks), horticultural areas, hard surfaces and natural areas to reduce the likelihood of pest infestations and the need for pesticides to control them;
 - (b) direct that the Parks and Recreation properties listed in recommendation 5(i) be subject to proactive inspections, in addition to complaint response inspections, by Toronto Public Health;
 - (c) direct the General Manager of Parks and Recreation to provide the MOH with annual reports of pesticide use and strategies to reduce pesticide use;
- (5) the Board of Health direct the Medical Officer of Health to include, in his report on the evaluation of the pesticide by-law, options for requiring users of non-exempt pesticides to post signs detailing the use of such pesticides; and options for a notification system requiring owners to notify the City of their intention to apply non-exempt pesticides;
- (6) the Board of Health forward this report to the Ontario Ministry of the Environment, and Health Canada's Pest Management Regulatory Agency for their information; and
- (7) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

- A. Councillor Miheve moved that the Board of Health recommend to City Council that the staff recommendations in the Recommendations Section of the report (January 10, 2005) from the Medical Officer of Health be adopted, subject to:
 - (1) Recommendation (3)(a) being amended by deleting the word "cemeteries" after the word "lawns" so that it reads as follows:
 - "(3)(a) reaffirm the previous recommendation of the Chief Administrative Officer (CAO) that there be no action thresholds established for fungicides or herbicides on residential lawns, and general parkland;"
 - (2) Recommendation (3)(d) being amended by adding the word "cemeteries" after the word "greens" so that it reads as follows:
 - "(3)(d) endorse that golf courses, bowling greens, cemeteries, and transportation and utility rights of way be subject to proactive inspections on a regular basis, in addition to complaint response inspections by Toronto Public Health;"
 - (3) Recommendation (3)(e) being amended by adding the word "cemeteries" after the word "greens" so that it reads as follows:
 - "(3)(e) direct the Medical Officer of Health to request golf courses, bowling greens, cemeteries, and transportation and utility rights of way to submit an annual report on pesticide use and strategies to reduce pesticide use;"; and
 - (4) the Medical Officer of Health be requested to:
 - (a) closely monitor complaints and issues regarding compliance to the by-law by cemeteries, golf courses,

bowling greens, transportation and utility rights of way and report to the Board of Health by December 2005; and

(b) direct Public Health Inspectors to seek ongoing training in plant health care and integrated pest management from organizations and individuals expert in organic lawncare so that public education and bylaw enforcement reflect the latest pesticide free lawn and garden care approaches. (Carried)

B. Councillor Davis moved that:

- (1) Recommendation 2(b) in the report be amended by replacing the word "preferred" with the word "primary", so that it reads as follows:
 - "2(b) the primary means of complying with the Pesticide By-law is through applying the methods of Plant Health Care (PHC);"
- (2) the Pesticide By-law -Inspection Protocol for All Properties (Attachment 1) be amended to explicitly direct inspectors to "Note whether the site personnel have employed horticultural approaches or uses pest control products exempt under the bylaw to address the evidence of pests or conditions for the pests prior to applying a non-exempt pesticide"; and
- (3) annually review and report to the Board of Health on bylaw compliance and the use of non-exempt pesticides under the infestation clause on golf courses, bowling greens, cemeteries, transportation and utility rights of way, and Toronto parks; (Carried)
- C. Councillor Filion moved that the Board of Health recommend to City Council that authority be granted to introduce the necessary Bill in Council to amend Section 612-1 B(2) of Toronto Municipal Code Chapter 612, Pesticides, Use of, by amending subsection B(2)(d) by deleting "(d) BT (Bacillus thuringiensis), nematodes and other biological control organisms" and substituting "(d) biological pesticides, including BT (Bacillus thuringiensis) and nematodes". (Carried)

1.11 Reports requested respecting Potential Amendments to Pesticide By-law

The Board of Health considered a confidential report (December 20, 2004) from the City Solicitor, responding to a request on options for requiring those using pesticides restricted by the City's Pesticide By-law to posts signs and notify the City of impending pesticide use.

On motion by Councillor Davis, the Board of Health recommend that City Council receive the confidential report (December 20, 2004) from the City Solicitor, responding to a request on options for requiring those using pesticides restricted by the City's Pesticide By-law to posts signs and notify the City of impending pesticide use, that, in accordance with the *Municipal Act*, discussions pertaining to this matter be held in-camera, because the advice is subject to solicitor-client privilege.

1.12 Preventing Vicious Dog Attacks in Toronto

The Board of Health considered the following:

(a) report (January 5, 2005) from the Medical Officer of Health, providing policy recommendations and strategies to prevent vicious dog attacks in the City of Toronto.

Recommendations:

- (1) the Medical Officer of Health report to the Board of Health, in consultation with the City Solicitor, on amendments to the Municipal Code Chapter 349 to strengthen prevention of dog attacks and on related enhancements to prevention and enforcement programs, as soon as possible after proposed provincial legislation amending the Dog Owners' Liability Act is passed;
- (2) the Medical Officer of Health report to the Board of Health Budget Subcommittee within six months with a detailed strategy for increasing revenue generation from Animal Services;
- (3) the Attorney General be requested to include in the proposed amendments to the Dog Owners' Liability Act a requirement to microchip all restricted pit bulls;

- (4) the Attorney General be requested to ensure that any regulations regarding the final disposition of pit bulls be applied equally to municipalities, humane societies and contracted services;
- (5) the Attorney General be requested to fund 100% of municipal implementation costs related to proposed amendments to the Dog Owners' Liability Act for a three year transitional period;
- (6) this report be forwarded to the Attorney General with a request to consider adopting those strategies with province wide implications; and
- (7) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto;
- (b) communication (January 14, 2005) from Mike Conner, Corporate Services Director, Toronto Humane Society;
- (c) submission "Saving Lives: The Humane Society of Canada's Action Plan to Prevent Dog Bites" forwarded by Vanessa McMain, Wildlife Programs Coordinator, The Humane Society of Canada;
- (d) communication (January 16, 2005) from Steve Barker, Ontario Director, Dog Legislation Council of Canada;
- (e) communication (January 16, 2005) from Casey A. Conklin, Co-Chair, Withrow Park Dog Owners' Association; and
- (f) communication (January 17, 2005) from Liz White, Director, Animal Alliance of Canada and Environment Voters and Barry MacKay, Canadian Representative, The Animal Protection Institute.

On motion by Councillor Fletcher, the Board of Health adopted the staff recommendations in the Recommendations Section of the report (January 5, 2005) from the Medical Officer of Health with the following amendments:

- "(1) the Medical Officer of Health report to the Board of Health, in consultation with the City Solicitor, on amendments to the Municipal Code Chapter 349 to strengthen prevention of dog attacks on related enhancements to prevention and enforcement programs, as soon as possible after proposed provincial legislation amending the Dog Owners' Liability Act is passed;
 - (a) that the Board of Health approve, in principle, that the City's Animal By-law be amended to include a provision that designates dangerous or potentially dangerous dogs and that the by-law amendment include restrictions on dangerous or potentially dangerous dogs;
 - (b) that the Medical Officer of Health, in consultation with the City Solicitor, report to the Board of Health on the details required to designate dangerous or potentially dangerous dogs including:
 - (i) amendments to the Municipal Code Chapter 349 required to designate dogs as potentially dangerous or dangerous;
 - (ii) the establishment of <u>criteria</u> for designating dogs as potentially dangerous or dangerous; and the establishment of <u>restrictions</u> for dogs designated as potentially dangerous or dangerous including the following options: muzzling, confinement in a pen, increased licencing fees, microchipping, spaying/sterilizing and owner liability insurance;
 - (c) that the City Solicitor be requested to draft an amendment to the Animal By-law that reflects the policy developed by the Medical Officer of Health in Recommendation 1(b) above;
- (2) Recommendation (2) amended to read as follows:
 - "(2) the Medical Officer of Health report to the Board of Health Budget Subcommittee within six months with a detailed strategy for increasing revenue generation from Animal Services;

- (a) the Board of Health establish a short-term committee to oversee the revenue generation strategy, to be composed of members of the Budget Advisory Committee of the Board of Health, the Chair and/or Vice-Chair of the Board of Health, the Chair of the Animal Services Advisory Committee of the Board of Health and staff of the Toronto Animal Services and Finance;
- (b) development of a cost-recovery strategy for funding enforcement of dangerous/potentially dangerous dog by-laws beyond the transition phase, in part, from the revenue obtained for licencing all dogs in Toronto:
- (c) the status of collection of outstanding fines related to animal by-laws; the development of revenue-neutral strategy for increasing collection of fines issued by the City of Toronto; and the feasibility of redirecting fine revenue for enforcement of animal related by-laws into Toronto Animal Services programs; and
- (d) a review of the City of Calgary's Animal and Bylaw Services and their effective revenue generation program in order to develop similar strategies that may aide in offsetting costs for Toronto Animal Services and create education programs;
- (3) Recommendation (3) amended to read as follows:
 - "(3) the Attorney General be requested to include in the proposed amendments to the Dog Owners' Liability Act a requirement to microchip all restricted dogs";
- (4) addition of new Recommendation (8) as follows:
 - (8) the Attorney General be requested to increase not only the maximum fines but also the minimum fines;
- (5) addition of new Recommendation (9) as follows:
 - (9) the Medical Officer of Health report on a model and costs to sterilize all dogs prior to adoption from the City's Animal Centres:
- (6) addition of new Recommendation (1) as follows:

(1) the Medical Officer of Health report on ways to enhance educational programs for adults and children.

1.13 Bedbug Problems in Communities across Toronto

WHEREAS this infestation is affecting quality of life, people's use of shelters, and is leading to an increased use of the health care system;

WHEREAS there is clear public concern about the issue and a desire to learn health respond;

THEREFORE BE IT RESOLVED THAT staff prepare a report for the April Board of Health meeting on this issue."

On motion by Cathy Crowe, the Board of Health adopted the foregoing Resolution.
