#### **Confirmation of Minutes**

On motion by Fiona Nelson, the Minutes of the meeting of the Board of Health on November 28, 2005 were confirmed.

## **Chair/MOH Announcements:**

Councillor Filion, Chair, Board of Health, announced that two Toronto Public Health staff and their programs received the "Stand Up for Kids Awards", an award which honours those with the courage to stand up and take action to prevent or stop child abuse and neglect.

The awards were presented by Toronto's Four Children's Aid Societies: Catholic Children's Aid, Children's Aid, Jewish Family and Child Service, and the Native Child and Family Services. The two Toronto Public Health staff and their programs recipients were:

- Health Promotion Consultant Dia Mamatis, who accepted the award for the campaign "Spanking Hurts More Than You Think", a campaign that encourages parents to use positive discipline; and
- Community Health Officer Alice Gorman, who was presented an award for the program "Young Parents with No Fixed Address", a program that provides service to homeless, street-involved youth who are pregnant or parenting.

Councillor Filion, Chair, Board of Health and Dr. David McKeown, Medical Officer of Health, congratulated Dia Mamatis and Alice Gorman, on behalf of the Board of Health and presented them with a Recognition Award.

## **10.1** Pandemic Influenza Plan for the City of Toronto

The Board of Health considered a report (November 24, 2005) from the Medical Officer of Health, presenting to the Board of Health and Toronto City Council, the first version of the Pandemic Influenza Plan for the City of Toronto.

## Recommendations:

It is recommended that:

- (1) the Board of Health endorse the City of Toronto Pandemic Influenza Plan;
- (2) the Medical Officer of Health continue to actively monitor the influenza situation worldwide and report to the Board of Health on any urgent issues as they arise;
- (3) the Medical Officer of Health report to the Board of Health on the status of the City of Toronto Pandemic Influenza Plan on an annual basis, prior to each influenza season;
- (4) City of Toronto Council urge the federal and provincial Ministers of Health to:
  - (a) ensure an adequate supply of anti-viral medications and vaccine for designated priority groups and effective distribution mechanisms to local public health units;
  - (b) give further consideration to the wearing of masks in community situations where potential exposure to infectious individuals is likely and unavoidable.
- (5) City of Toronto Council urge the provincial Minister of Health and Long-Term Care to:

- (a) develop effective strategies to maximize the surge capacity for all components of the health care system (including hospitals and the Provincial Public Health Laboratory) to handle pandemic influenza;
- (b) ensure that the needs of vulnerable populations, including the homeless and underhoused population, persons with addictions and mental health issues and the frail elderly, be addressed as part of provincial pandemic influenza planning;
- (c) proactively address barriers for key service providers to prepare and respond to an influenza pandemic (e.g. advance funding for funeral/crematoria service providers to stockpile resources, insurance and compensation for self-employed health care providers);
- (d) develop clear criteria for the implementation of public health measures such as closure of schools, day nurseries and cancellation of social gatherings, in collaboration with local public health units to ensure consistency;
- (6) City of Toronto Council urge the provincial Ministers of Labour and Health and Long-Term Care to:
  - (a) collaborate to ensure that provincial infection control advice and directives regarding pandemic influenza are consistent and take into account both health and labour perspectives;
  - (b) develop emergency sick leave policies to help ensure that ill people do not have to work during an influenza pandemic.
- (7) City of Toronto Council direct the City Manager to:
  - (a) proactively address the human resources and labour relations issues, in collaboration with the bargaining agents, that would arise in responding to an influenza pandemic;
  - (b) ensure that all city divisions, agencies, boards and commissions have a service continuity plan for pandemic influenza by July, 2006;
  - (c) implement an information and education plan for the Toronto Public Service regarding pandemic influenza in 2006, in collaboration with the Medical Officer of Health.
- (8) City of Toronto Council urge the Local Health Integration Networks (LHINs) in the City of Toronto to work with Toronto Public Health on pandemic influenza planning as an urgent priority;
- (9) share this report with other Boards of Health in Ontario, the Association of Local Public Health Agencies, the Ontario Public Health Association, the Public Health

Agency of Canada, the Ontario Minister of Health and Long Term Care, the Ontario Minister of Labour and the Canadian Urban Health Network for their information; and

(10) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

The Board of Health also considered a communication (November 25, 2005) from Tam Goossen.

- A. Councillor Filion moved that the Board of Health recommend to the Policy and Finance Committee that the Policy and Finance Committee:
  - (1) adopt the City of Toronto Pandemic Influenza Plan, attached to the report (November 24, 2005) from the Medical Officer of Health; and
  - (2) adopt the staff recommendations in the Recommendations Section of the report (November 24, 2005) from the Medical Officer of Health.
- B. Councillor Filion moved that the Board of Health:
  - (i) endorse the City of Toronto Pandemic Influenza Plan, attached to the report (November 24, 2005) from the Medical Officer of Health;
  - (ii) endorse the staff recommendations in the Recommendations Section of the report (November 24, 2005) from the Medical Officer of Health;
  - (iii) direct that the Chair of the Board of Health or designate, be a member of the Toronto Pandemic Influenza Advisory Group; and
  - (iv) request that the Board of Health receive quarterly progress reports on the status of the preparedness for a flu pandemic, and any necessary recommendations for action.

Councillor Filion resumed the Chair.

- C. Cathy Crowe moved that the Board of Health:
  - (i) request that Board of Health Members be briefed and invited to all media briefings regarding Pandemic Flu;
  - (ii) request that Pandemic Flu remain as an item on the Board of Health agenda to allow the Medical Officer of Health to provide monthly verbal updates;
  - (iii) request the Medical Officer of Health to:
    - (a) provide an early briefing on pandemic influenza for Toronto community agencies, including funding agencies, such as the United Way;
    - (b) increase communication and outreach on pandemic influenza and emergency preparedness to the general community; and
    - (c) schedule an additional briefing on the City of Toronto Pandemic Influenza Plan for Board of Health Members.
- D. Valerie Sterling moved that the Board of Health request the Medical Officer of Health to ensure that the needs of the vulnerable populations, including the frail, elderly and disabled, are taken into account and provided for in the City of Toronto Pandemic Influenza Plan.
- E. Nathan Gilbert moved that the Board of Health request the Medical Officer of Health to include as part of his report back to the Board of Health on this issue, information on meetings that have been organized and are being organized, so that the Board of Health can be kept up-to-date on the community outreach.
- F. Councillor Davis moved that the Board of Health request the Medical Officer of Health to schedule a briefing for Members of Council prior to the consideration of this matter by the Policy and Finance Committee at its meeting on January 23, 2006.

## 10.2 Primary Results of SARS-Related Health Research

# **10.6** Provincial Funding for the Development of Tuberculosis Air Quality Guidelines and Site Assessment at Toronto Shelters

The Board of Health considered a report (November 14, 2005) from the Medical Officer of Health, seeking approval to receive one-time funding confirmed from the Ministry of Health and Long-Term Care to develop tuberculosis air quality guidelines for Toronto shelters, to assess a sample of Toronto shelters in relation to the guidelines and the potential implementation costs, and to develop an implementation guide for shelter operators.

Recommendations:

It is recommended that:

 the Medical Officer of Health be authorized to receive up to \$228.3 thousand of one-time 100% provincial funding to develop tuberculosis (TB) quality guidelines for Toronto shelters and assess specific sites;

- (2) an amount of \$12.6 thousand gross expenditure and \$12.6 thousand revenue be added to the 2005 TPH Operating Budget to support the development of TB air quality guidelines;
- (3) an amount of \$215.7 thousand gross expenditure and \$215.7 thousand revenue be added to the 2006 TPH Operating Budget to support the development of TB air quality guidelines;
- (4) this report be forwarded to City Council for approval; and
- (5) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Cathy Crowe, the Board of Health:

- recommended that City Council adopt the staff recommendations in the Recommendations Section of the report (November 14, 2005) from the Medical Officer of Health; and
- (2) requested that the report (November 14, 2005) from the Medical Officer of Health, be forwarded to the Homeless Advisory Committee, for information

## **10.7** Dog and Cat Licensing Strategy

The Board of Health considered a report (November 14, 2005) from the Medical Officer of Health, outlining a revenue generation strategy for enhancing the level of animal services in Toronto by increasing the proportion of dogs and cats which are licensed as required by the City's Municipal Code.

Recommendations:

It is recommended that:

- (1) the Medical Officer of Health be authorized to initiate the licensing strategy outlined in this report to increase the proportion of licensed dogs and cats in the City of Toronto;
- (2) the revenue raised through the implementation of the licensing strategy be used first to fund the expenditures required to implement the strategy and repay the capital project debt, and any further revenues beyond this be used to improve the

delivery of animal services to the public, subject to approval by the Board of Health and City Council through the annual budget process;

- (3) the Board of Health reconfirm its recommendation to the Budget Advisory Committee and Policy and Finance Committee, that the 2006 TPH Capital Budget be increased by \$671.2 thousand for the development of an on-line license application and renewal system and that this cost be repaid over a five year period from increased revenues as a result of the licensing strategy;
- (4) the Board of Health recommend to Budget Advisory Committee that the 2006 TPH Operating Budget be increased by \$550.0 thousand in expenditures and \$550.0 thousand in revenue with an additional annualization cost in 2007 for salaries and benefits of \$530.0 thousand gross and \$0.0 net to support the licensing strategy;
- (5) the Medical Officer of Health report to the Board of Health and the Budget Advisory Committee, annually on animal service levels and performance, including progress of the implementation of the licensing strategy prior to the submission of the TPH Operating Budget;
- (6) any year end deficit resulting from the licensing strategy initiative be reported to the Board of Health and Budget Advisory Committee and funded from within the Toronto Public Health approved budget for 2006 and beyond;
- (7) this report be referred to the Budget Advisory Committee through Policy and Finance Committee, for consideration in the 2006 budget process; and
- (8) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

The Board of Health also considered a communication (November 24, 2005) from Tim Trow, President, Toronto Humane Society

The following persons appeared before the Board of Health:

- Linday Pitney, who also filed a written submission;
- Heidi Yerashotis, Homeless Cat Rescue; and
- Darin Jackson, Canadian Union of Public Employees, Local 416.
- A. Councillor Fletcher moved that the Board of Health approve in principle the staff recommendations contained in the Recommendations Section of the report (November 14, 2005) from the Medical Officer of Health, with Recommendation (3) being amended to read as follows, and forwarded to the Policy and Finance Committee and the Budget Advisory Committee, for its consideration:
  - "(3) the Board of Health reconfirm its recommendation to the Policy and Finance Committee and the Budget Advisory

Committee, that the 2006 Toronto Public Health Capital Budget be increased by \$1.071 million for the development of an on-line license application and on-line registration and renewal system and that this cost be repaid over a ten year period from increased revenues as a result of the licensing strategy;".

B. Nathan Gilbert moved that the Board of Health adopt a further recommendation, as follows:

"That an additional category be included in the schedule of fees in order to be able to accept donations.".

Councillor Fletcher moved that the Board of Health refer this matter back to the Chair and the Vice-Chair of the Board of Health, to review the implementation strategy in consultation with Medical Officer of Health, the City Manager and the Auditor General, and report back as soon as possible to the Board of Health.
- D. Councillor Davis moved that the Board of Health request the Medical Officer of Health to:
  - (a) write again, on behalf of the Board of Health, to the Attorney General and the Premier, requesting funding for the cost of implementing the Dog Owner's Liability Act in the City of Toronto;
  - (b) include the following, when reporting back on this matter:
    - how additional resources raised through the enhanced licensing of cats and dogs could be allocated towards increased neutering and spaying services in the City of Toronto; and
    - (ii) further options for the licensing rates for senior residents on fixed incomes.

The Board of Health:

- (2) recommended to Council that the City of Toronto not enter into an agreement with the Town of Markham or the City of Pickering for the provision of Animal Services.

## **10.9** Advocating for Health through Increases to Social Assistance

- (6) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.
