On motion by Councillor Moscoe, Ward 15 – Eglinton-Lawrence, the minutes of the meeting of the North York Community Council held on July 5, 2005 were confirmed.

# 7.1 Draft By-laws – To Rename Part of Bales Avenue south of Avondale Avenue as Harrison Garden Boulevard and To Rename Part of Terlean Road as Avondale Avenue (Ward 23 – Willowdale)

The North York Community Council considered Draft By-laws from the City Solicitor to rename Part of Bales Avenue south of Avondale Avenue as Harrison Garden Boulevard and to rename Part of Terlean Road as Avondale Avenue (Ward 23 – Willowdale).

The North York Community Council also, had before it, for information, Consolidated Clause 30 of North York Community Council Report 3, titled "Renaming of Portion of Bales Avenue to "Harrison Garden Boulevard" and Renaming of Terlean Road to "Avondale Avenue" (Ward 23 – Willowdale)", which was adopted, without amendment, by City Council on April 12, 13 and 14, 2005.

The North York Community Council held a public meeting in accordance with the *Municipal Act*, 2001, and notice of the proposed enactment of the draft by-laws were posted on the Public Notices Page of the City's website in accordance with the requirements of the City of Toronto Municipal Code Chapter 162. No one appeared to address the North York Community Council on September 19, 2005

On motion by Councillor Filion, Ward 23 – Willowdale, the North York Community Council recommended to City Council, that the by-laws in the form of the draft by-laws be enacted, and that the necessary Bills be introduced in Council to give effect thereto.

# 7.2 Draft By-law to Permanently Close a Portion of the public highway Phippen Avenue (Commonly known as Parklea Drive), abutting 206 Hanna Road (Ward 26 – Don Valley West)

The North York Community Council considered a Draft By-law from the City Solicitor to Permanently Close a Portion of the public highway Phippen Avenue (Commonly known as Parklea Drive), abutting 206 Hanna Road (Ward 26 – Don Valley West)

The North York Community Council also, had before it, for information, Consolidated Clause 28 of North York Community Council Report 4, titled "Sale of Surplus Portion of the Phippen Avenue Road Allowance (Commonly known as Parklea Drive), abutting 206 Hanna Road (Ward 26 – Don Valley West), which was adopted, without amendment, by City Council on May 17, 18 and 19, 2005.

The North York Community Council held a public meeting in accordance with the *Municipal Act*, 2001, and notice of the proposed enactment of the draft by-laws were posted

on the Public Notices Page of the City's website in accordance with the requirements of the City of Toronto Municipal Code Chapter 162. No one appeared to address the North York Community Council on September 19, 2005

On motion by Councillor Pitfield, Ward 26 – Don Valley West, the North York Community Council recommended that a by-law in the form of the draft by-law be enacted, and that the necessary Bill be introduced in Council to give effect thereto.

# 7.3 Request for Fence Exemption – 157 Sherwood Avenue (Ward 25 – Don Valley West)

The North York Community Council considered a report (August 30, 2005) from the North District Manager, Municipal Licensing & Standards Division, reporting on a request by the owner of 157 Sherwood Avenue for an exemption from the City of Toronto Municipal Code Chapter 447 Fences.

#### Recommendations:

It is recommended that one of the following two options be accepted:

- (1) The application not be approved, or,
- (2) If approved, conditions be imposed requiring the applicant to bring the fence into compliance with Chapter 447 Fences or its successor by-law when the fence is replaced.

On motion by Councillor Jenkins, Ward 25 – Don Valley West, the North York Community Council recommended that City Council adopt Recommendation (2) contained in the Recommendations Section of the report (August 30, 2005) from the North District Manager, Municipal Licensing and Standards Division, and the request for an exemption from the City of Toronto Municipal Code, Chapter 447 Fences, for 157 Sherwood Avenue, be approved, subject to the applicant bringing the fence into compliance with Chapter 447 Fences or its successor by-law when the fence is replaced.

#### 7.4 Request for Fence Exemption – 35 Glen Forest Road (Ward 25 – Don Valley West)

The North York Community Council considered a report (August 30, 2005) from the North District Manager, Municipal Licensing & Standards Division, reporting on a request by the

owner of 35 Glen Forest Road for an exemption from the City of Toronto Municipal Code Chapter 447 Fences.

#### Recommendations:

It is recommended that one of the following two options be accepted:

- (1) The application not be approved, or,
- (2) If approved, conditions be imposed requiring the applicant to bring the fence into compliance with Chapter 447 Fences or its successor by-law when the fence is replaced.

The North York Community Council also considered a communication (September 15, 2005) from David Wolf.

On motion by Councillor Jenkins, Ward 25 - Don Valley West, the North York Community Council recommended that City Council adopt staff Recommendation (2) in the Recommendations Section of the report (August 30, 2005) from the North District Manager, Municipal Licensing and Standards Division, and the request for an exemption from the City of Toronto Municipal Code, Chapter 447 Fences, for 35 Glenforest Road, be approved, subject to the applicant bringing the fence into compliance with Chapter 447 Fences or its successor by-law when the fence is replaced.

#### (Report 7, Clause 4)

7.5 Request for Approval of Variances from the former City of York Sign By-law No. 3369-79, as amended, for the erection of a back to back third party advertising roof sign at 1840 Eglinton Avenue West (Ward 15 – Eglinton-Lawrence)

The North York Community Council considered a report (August 30, 2005) from the Director of Building and Deputy Chief Building Official, reviewing and making recommendations on a request by Sid Catalano of Pattison Outdoor, on behalf of Li III Limited, property owner of 1840-1842 Eglinton Avenue West, for a variance from the former City of York Sign By-law No. 3369-79, as amended, to permit the erection of a back to back off premise roof sign.

## Recommendation:

It is recommended that the request for variance be refused for the reasons outlined in this report.

The North York Community Council also considered a communication (September 15, 2005) from Albert Kwan.

David McKay, MHBC Planning, appeared before the North York Community Council, on behalf of the applicant.

On motion by Councillor Moscoe, Ward 15 – Eglinton-Lawrence, the North York Community Council recommended that City Council:

- (1) not adopt the report (August 30, 2005) from the Director of Building and Deputy Chief Building Official; and
- approve the request for a variance from the former City of York Sign By-law No. 3369-79, as amended, for the erection of a back to back third party advertising roof sign at 1840 Eglinton Avenue West, subject to:
  - (a) the removal of the sign at 2388 Dufferin Street, with the permission of the owner of 2388 Dufferin Street to do so; and
  - (b) no further roof sign being erected at 2388 Dufferin Street.

7.6 Request for Approval of Variances from the former City of North York Sign By-law No. 30788, as amended, for the erection of 5 (five) projecting signs at 2877 Bayview Avenue (Ward 24 – Willowdale)

The North York Community Council considered a report (August 30, 2005) from the Director of Building and Deputy Chief Building Official, reviewing and making recommendations on a request by Isabella Matte of International Neon, on behalf of Loblaws Properties Ltd., for a variance from the former City of North York Sign By-law No. 30788, as amended, to permit the erection of 5 (five) projecting signs at the above location.

#### Recommendations:

- (1) the request for the variance be approved; and
- (2) the applicant be advised, upon approval of the variance, of the requirement to obtain the necessary sign permits from the chief building official.

On motion by Councillor Shiner, Ward 24 – Willowdale, the North York Community Council postponed indefinitely, the report (August 30, 2005) from the Director of Building and Deputy Chief Building Official, North District.

7.7 Request for an Exemption from Chapter 248 of the former City of Toronto Municipal Code to permit driveway widening for a second parking space at 349 Briar Hill Avenue (Ward 16 – Eglinton-Lawrence)

The North York Community Council considered a report (June 13, 2005) from the Director, Transportation Services, North York District, reporting on a request for an exemption from Municipal Code Chapter 248, Parking Licenses, of the former City of Toronto Municipal Code, to permit driveway widening for a second parking space at 349 Briar Hill Avenue, which does not meet the requirements of the Code.

#### Recommendation:

The application for driveway widening for a second parking space at 349 Briar Hill Avenue be denied.

- A. Councillor Stintz, Ward 16 Eglinton-Lawrence, moved that the North York Community Council recommend to City Council that the request for an exemption from Municipal Code Chapter 248, Parking Licenses, of the former City of Toronto Municipal Code, be approved subject to the following conditions:
  - (a) the new parking area not exceeding 2.6 metres by 5.9 metres in dimension;
  - (b) that both parking area being paved with semi-permeable paving materials, such as ecostone pavers or approved equivalent paving treatment acceptable to the Acting General Manager of Transportation Services;
  - (c) the applicant providing the landscape features substantially in accordance with the plan as shown on Appendix 'B', to the satisfaction of the Acting General Manager of Transportation Services; and
  - (d) the applicant paying all applicable fees and complying with all other criteria set out in Municipal Code Chapter 248, Parking Licenses, of the former City of Toronto Municipal Code.
- B. Councillor Moscoe, Ward 15 Eglinton-Lawrence, moved that the North York Community Council defer the report to its next meeting on October 18, 2005, to allow the applicant an opportunity to address the North York Community Council.

Motion B., moved by Councillor Moscoe, Carried.

Having regard for the foregoing decision of the North York Community Council; Motion A., moved by Councillor Stintz, was not voted upon.

# 7.8 Request for Exemption from Chapter 248 of the former City of Toronto Municipal Code to Permit Driveway Widening for a Second Parking Space at 129 Edith Drive (Ward 16 – Eglinton-Lawrence)

The North York Community Council considered a report (August 23, 2005) from the Director, Transportation Services, North York District, reporting on a request for an exemption from Municipal Code Chapter 248, Parking Licences, of the former City of Toronto Municipal Code, to permit driveway widening for a second parking space at 129 Edith Drive, which does not meet the requirements of the Code.

### Recommendation:

It is recommended that the application for driveway widening for a second parking space at 129 Edith Drive be denied.

On motion by Councillor Stintz, Ward 16 – Eglinton-Lawrence, the North York Community Council recommended that City Council:

- (1) not adopt the report (August 23, 2005) from the Director, Transportation Services, North York District; and
- (2) approve the request for an exemption from Chapter 248 of the Former City of Toronto Municipal Code to permit driveway widening for a second parking space at 129 Edith Avenue, subject to the following conditions:
  - (a) the new parking area not exceeding 2.2 metres by 5.9 metres in dimension;
  - (b) both parking areas being paved with semi-permeable paving materials, such as ecostone pavers or approved equivalent paving treatment acceptable to the General Manager of Transportation Services;
  - (c) the applicant providing the landscape features substantially in accordance with the plan as shown on Attachment-1, to the satisfaction of the General Manager of Transportation Services; and

(d) the applicant paying all applicable fees and complying with all other criteria set out in Municipal Code Chapter 248, Parking Licences, of the former City of Toronto Municipal Code.

# 7.9 Request for an Exemption from Chapter 400 of the former City of Toronto Municipal Code to permit Front Yard Parking for two vehicles at 179 Ranleigh Avenue (Ward 25 – Don Valley West)

The North York Community Council considered a report (August 23, 2005) from the Director, Transportation Services, North York District, reporting on a request for an exemption from Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto Municipal Code, to permit front yard parking for two vehicles at 179 Ranleigh Avenue, which does not meet the requirements of the Code.

### Recommendation:

It is recommended that the application for front yard parking for two vehicles at 179 Ranleigh be denied.

Josephine Casey, applicant, appeared before the North York Community Council.

On motion by Councillor Jenkins, Ward 25 – Don Valley West, the North York Community Council recommended that City Council:

- (1) not adopt the report (August 23, 2005) from the Director, Transportation Services, North York District; and
- (2) approve the request for an exemption from Chapter 400, Traffic and Parking, of the Former City of Toronto Municipal Code to permit front yard parking for two vehicles at 179 Ranleigh Avenue, subject to the following conditions:
  - (a) the new parking area not exceeding 2.6 metres by 5.6 metres in dimension;
  - (b) both parking areas being paved with semi-permeable paving materials, such as ecostone pavers or approved equivalent paving treatment acceptable to the General Manager of Transportation Services;
  - (c) the City sidewalk not being encumbered at any time by vehicles overhanging the sidewalk and pedestrian traffic being maintained at all times:

- (d) when the existing below grade garage is eliminated and changed to habitable space;
- (e) the applicant providing the landscape features substantially in accordance with the plan as shown on Attachment-1, to the satisfaction of the General Manager of Transportation Services; and
- (f) the applicant paying all applicable fees and complying with all other criteria set out in Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto Municipal Code.

# 7.10 Request for a Variance to the Circular Driveway Entrance Policy – 110 York Mills Road (Ward 25 – Don Valley West)

The North York Community Council considered a report (August 23, 2005) from the Director, Transportation Services, North York District, reporting on a request to allow a variance to the Driveway Entrance Policy for a Circular Driveway at 110 York Mills Road.

#### Recommendation:

It is recommended that the application for this variance to the driveway entrance policy be denied.

The North York Community Council also considered a communication (September 16, 2005) from Councillor Jenkins, forwarding a communication (September 16, 2005) from Cindy Weiner, President, St. Andrew's Ratepayers Association.

Daniel MacDonald and Stephen Leonard, applicants, appeared before the North York Community Council.

On motion by Councillor Jenkins, Ward 25 – Don Valley West, the North York Community Council recommended that City Council:

- (1) not adopt the report (August 23, 2005) from the Director, Transportation Services, North York District; and
- (2) approve the request for a variance to the Circular Driveway Entrance Policy at 110 York Mills Road.

# 7.11 Request for Driveway Entrance Widening – 54 Otter Crescent (Ward 16 – Eglinton-Lawrence)

The North York Community Council considered a report (August 25, 2005) from the Director, Transportation Services, North York District, reporting on a request to widen the driveway entrance at 54 Otter Crescent from 3.0 metres to 5.3 metres.

#### Recommendation:

It is recommended that the request for a variance from the residential driveway entrance policy be denied.

The North York also considered a communication (September 15, 2005) from Marie Desilets, applicant.

On motion by Councillor Stintz, Ward 16 – Eglinton-Lawrence, the North York Community Council recommended that City Council:

- (1) not adopt the report (August 25, 2005) from the Director, Transportation Services, North York District; and
- (2) grant conditional approval to widen the driveway entrance at 54 Otter Crescent from 3.0 metres to 5.3 metres, only until such time as the street is re-paved with curbs.

#### 7.12 Encroachment Agreement – 399 Cortleigh Boulevard (Ward 16 – Eglinton-Lawrence)

The North York Community Council considered a report (August 15, 2005) from the Director, Transportation Services, North York District, reporting on a request for encroachment into the future right-of-way of Bathurst Street.

#### Recommendations:

- (1) the requirement to convey 3.44 metres on the Bathurst Street road allowance be waived.
- (2) City officials be authorized to take the actions necessary to take effect thereto.

# 7.13 Traffic Calming Measures (speed humps) – Hillhurst Boulevard, Bathurst Street to the west limit of cul-de-sac (Ward 15 – Eglinton-Lawrence)

The North York Community Council considered a report (August 23, 2005) from the Director, Transportation Services, North York Services, reporting on the need for traffic calming measures and results of the traffic calming poll on Hillhurst Boulevard, Bathurst Street to the west limit of cul-de-sac.

#### Recommendation:

It is recommended that traffic calming measures (speed humps) not be installed on Hillhurst Boulevard, Bathurst Street to the west limit of cul-de-sac.

#### 7.16 Parking Prohibitions – Wilmont Drive (Ward 8 – York West)

The North York Community Council considered a report (February 7, 2005) from the Director, Transportation Services, North York District, seeking approval to amend the parking regulations on Wilmont Drive.

# Recommendation:

WHEREAS because of jurisdictional considerations, the split administration of housing and city properties has posed an impediment to policing and community safety;

THEREFORE BE IT RESOLVED THAT the City Manager or a designated Deputy City Manager be requested to convene a meeting of all relevant divisions, agencies and corporations to identify current responsibilities and how these can best be undertaken at the earliest possible time but no later than the end of October;

AND FURTHER BE IT RESOLVED THAT the City Manager, be requested to report to the North York Community Council no later than January on how best to maintain and enhance the areas of the community used by residents and other members of the public;

AND FURTHER BE IT RESOLVED THAT prior to reporting to the North York Community Council there be a public meeting held with residents of Lawrence Heights to review the recommendations being brought forward and to include comments in the report to the Community Council".

# 7.55 Report Request – Terms of Reference – Consolidation and Development of a "Discount District" Plan in the Orfus Road Neighbourhood (Ward 15 – Eglinton-Lawrence)

- Blown waste and trashy rear lots
- Impediments to the natural flow of pedestrians and vehicles
- Separations between properties
- Improvements to enhance and limit the display of goods
- Signage and advertising
- Interaction with the abutting residential neighbourhood; and

WHEREAS this could be an opportunity to organize businesses into a cohesive, contributing, entity like a B.I.A and at the same time establish an effective dialogue with the adjacent residential neighbourhood; and

WHEREAS the North York Community Council is authorized to take certain actions without Council's approval and establishing terms of reference for a study of this nature would fall within this authority.

THEREFORE BE IT RESOLVED THAT the Planning Division within the North district be requested to bring forward a the terms of reference for the consolidation and development of a "Discount District" plan in the Orfus Road neighbourhood; and

BE IT FURTHER RESOLVED THAT the terms of reference include a means of dealing with any legal, bylaw planning and organizational considerations as well as a process for consultation with business, other agencies and the adjacent residential neighbourhood; and

BE IT FURTHER RESOLVED THAT this be developed in close consultation with the North District division of the Economic Development Division; and

BE IT FURTHER RESOLVED THAT these be tabled at the January meeting of the North York Community Council".

# 7.56 Ontario Municipal Board Hearing – Committee of Adjustment Application – A045/03M – 35 Green Valley Road (Ward 25 – Don Valley West)

The North York Community Council considered the following Resolution submitted by Councillor Jenkins, Ward 25 – Don Valley West, for consideration by the North York Community Council:

"WHEREAS the Committee of Adjustment – Midtown Panel (COA) on April 24, 2003 refused a request for variances to permit the construction of a new two storey dwelling at 35 Green Valley Road; and

WHEREAS this decision was appealed by the owner of the property to the Ontario Municipal Board (OMB) which in December 2003 overturned the Committee of Adjustment decision and allowed the variances to height, length of dwelling and balcony area; and

WHEREAS area residents sought and were granted leave to appeal the OMB decision to the Divisional Court; and

WHEREAS at its meeting of July 20, 21 and 22, 2004 (Report 5 Clause 13) City Council instructed the City Solicitor to seek leave of the Divisional Court to intervene in the appeal of the OMB decision and if granted to make submissions respecting the requirement that an applicant for a minor variance demonstrate special circumstance, hardship or need; and

WHEREAS the City was granted intervenor status; and

WHEREAS in a decision dated July 8, 2005, the Divisional Court allowed the appeals, set aside the decision of the OMB and remitted the appeal back to the OMB for a new hearing by a different panel; and

WHEREAS the Court found amongst other things, that the errors of the Board were both serious and numerous and set out a number of findings of law as to the proper consideration of variance applications, including that a variance may not be minor if it is too large or too important and there is a residual discretion to refuse a variance application even when the four tests are met; and

WHEREAS the property is amongst other things, located within a ravine protection area and the variances sought are of such an extent that they should not be granted pursuant to Section 45(1) of the *Planning Act* as interpreted by the Court; and

WHEREAS the City has a significant interest in ensuring that the decision of the Divisional Court is appropriately implemented and interpreted before the Ontario Municipal Board; and

WHEREAS a new hearing before the Ontario Municipal Board has been scheduled for October 7, 17, 19 and 20, 2005;

THEREFORE BE IT RESOLVED THAT the City Solicitor be authorized to attend at the Ontario Municipal Board hearing to uphold the Committee of Adjustment refusal decision, and to retain such outside consultants as she may determine are appropriate; and

BE IT FURTHER RESOLVED THAT in the event the OMB allows the appeals, that any such decision should require amongst other appropriate conditions, that a riparian restoration plan be prepared and implemented by the owner, at its expense and to the satisfaction of the City's Urban Forestry Services, including the requirement for an appropriate letter of credit to secure this condition."

On motion by Councillor Jenkins, Ward 25 – Don Valley West, the North York Community Council recommended that City Council adopt the Resolution.
