On motion by Councillor Moscoe, Ward 15 – Eglinton-Lawrence, the minutes of the meeting of the North York Community Council held on October 18, 2005, were confirmed.

9.1 Request for Approval of Variance from the former City of Toronto Sign By-law No. 297, as amended, for the erection of a double faced, illuminated, off-premise billboard roof sign at 2464 – 2468 Yonge Street (Ward 16 – Eglinton-Lawrence)

The North York Community Council considered a report (September 28, 2005) from the Director & Deputy Chief Building Official, North York District, reviewing and making recommendations on a request by Steve Wolowich of Viacom Outdoors, on behalf of Harry and Marina Cholakis, for a variance from the former City of Toronto Sign By-law No. 297, as amended, to permit the erection of a 10 feet by 20 feet double faced, illuminated, off-premise billboard roof sign.

#### Recommendation:

It is recommended that the request for variance be refused for the reasons outlined in this report.

Steve Wolowich, Viacom Outdoor, appeared before the North York Community Council, on behalf of the applicants.

On motion by Councillor Stintz, Ward 16 – Eglinton-Lawrence, the North York Community Council recommended that City Council adopt the staff recommendations in the Recommendations Section of the report (September 28, 2005) from the Director & Deputy Chief Building Official, North York District, and the request for variance from the former City of Toronto Sign By-law No. 297, be refused.

## (Report 9, Clause 1)

#### 9.2 Encroachment Agreement – 267 Burbank Drive (Ward 24 – Willowdale)

The North York Community Council considered a report (October 31, 2005) from the Manager, Municipal Licensing and Standards, North York District, reporting on an encroachment agreement consisting of retaining walls, walkway, light standard, existing and proposed wooden fences, lattice structure, planter and trees. These encroachments are located within the municipal road allowance, in front and west side of the residential property known as 267 Burbank Drive.

#### Recommendations:

It is recommended that the encroachment application be approved, subject to the following conditions:

- (1) that the owner(s) enter into an Encroachment Agreement with the City to the satisfaction of the City Solicitor and Executive Director of Municipal Licensing and Standards;
- (2) that the appropriate City officials be authorized to take the necessary action to give effect thereto;
- (3) that no claims will be made against the City by the owner(s) for damages occurring to the area of encroachment or its elements during snow removal;
- (4) that the life of the agreement be limited to 5 years from the date of registration or to the date of removal of the encroachment at which time, the City may consider the Agreement for further extension if requested by the applicant;
- (5) the indemnification of the City by the owner(s) of the encroachments for all liability relating in any way to the encroachment and providing of an insurance policy for such liability for the lifetime of the Agreement in a form as approved by the City Solicitor in an amount no less than \$2,000,000.00 or such greater amount as the City Solicitor may require;

- (6) in the event of sale or transfer of the property abutting the encroachment, Legal Services be authorized to extend the Encroachment Agreement to the new owner, subject to the approval of the Executive Director of Municipal Licensing and Standards;
- (7) the owner(s) pay the following fees:
  - (i) Application Fee of \$435.76
  - (ii) Legal Administration Cost and Registration, plus dispersments, including G.S.T.;
  - (iii) Annual fee (rate adjusted annually) of \$3.30 per square metre for 27.0 square metres, totalling \$95.23, including G.S.T.

A staff presentation was made by Bryan Byng, Manager, Municipal Licensing & Standards, North York District.

On motion by Councillor Minnan-Wong, Ward 34 – Don Valley East, the North York Community Council deferred the report to its next meeting on January 17, 2006.

#### (Report 9, Other Items Clause 27(a))

9.3 Request for an Exemption from Chapter 248 of the former City of Toronto Municipal Code to permit driveway widening for a second parking space at 349 Briar Hill Avenue (Ward 16 – Eglinton-Lawrence)

The North York Community Council considered a report (June 13, 2005) from the Director, Transportation Services, North York District, reporting on a request for an exemption from Municipal Code Chapter 248, Parking Licenses, of the former City of Toronto Municipal Code, to permit driveway widening for a second parking space at 349 Briar Hill Avenue, which does not meet the requirements of the Code.

#### Recommendation:

The application for driveway widening for a second parking space at 349 Briar Hill Avenue be denied.

- A. Councillor Stintz, Ward 16 Eglinton-Lawrence, moved that the North York Community Council recommend to Council that:
  - (1) the request for an exemption from Chapter 248, Parking Licences, of the former City of Toronto Municipal Code to permit the driveway widening for a second parking space at 349 Briar Hill Avenue, be approved, subject to the following conditions:
    - (a) the new parking area not exceeding 2.6 metres by 5.9 metres in dimension;
    - (b) both parking areas being paved with semi-permeable paving materials, such as ecostone pavers or approved equivalent paving treatment acceptable to the Acting General Manager of Transportation Services;
    - (c) the applicant providing the landscape features substantially in accordance with the plan as shown on Appendix 'B', to the satisfaction of the General Manager of Transportation Services;
    - (d) the applicant paying all applicable fees and complying with all other criteria set out in Municipal Code Chapter 248, Parking Licences, of the former City of Toronto Municipal Code;
    - (e) the applicant consulting with the Director, Transportation Services, North York District, to minimize the need for further curb cuts; and
    - (f) the applicant being required to continue to purchase a street permit for a parking space for as long as the additional curb cut remains, in view of the loss of one permit parking space; and
  - (2) the report (June 13, 2005) from the Director, Transportation Services, North York District, be received.
- B. Councillor Moscoe, Ward 15 Eglinton-Lawrence, moved that the City Solicitor be requested to report directly to City Council for its meeting on December 5, 6 and 7, 2005, on a way to make future purchasers of the property at 349 Briar Hill Avenue aware of the parking conditions on this site.

Motion A., moved by Councillor Stintz, Carried.

Motion B., moved by Councillor Moscoe, Carried.

# 9.4 Introduction of Permit Parking on the east side of Greer Road, between Old Orchard Grove and Roe Avenue (Ward 16 – Eglinton-Lawrence)

The North York Community Council considered a report (October 24, 2005) from the Director, Transportation Services, North York District, reporting on the introduction of permit parking on the east side of Greer Road, between Old Orchard Grove and Roe Avenue, to operate during the hours of 12:01 a.m. to 7:00 a.m., 7 days a week. The permit to be applicable only to this section of Greer Road.

#### Recommendations:

It is recommended that:

- (1) permit parking be introduced on the east side of Greer Road, between Old Orchard Grove and Roe Avenue, on a street name basis, to operate during the hours of 12:01 a.m. to 7:00 a.m., 7 days a week;
- (2) part A of Schedule XXVI (Permit Parking), of Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto Municipal Code, be introduced to incorporate the east side of Greer Road, between Old Orchard Grove and Roe Avenue;
- (3) parking be prohibited from 2:00 a.m. to 6:00 a.m., on the west side of Greer Road, from a point 30.5 metres north of Old Orchard Grove to the southerly limit of Roe Avenue; and
- (4) the appropriate City Officials be authorized and directed to take the necessary action to give effect thereto, including the introduction of all necessary bills.

On motion by Councillor Stintz, Ward 16 – Eglinton-Lawrence, the North York Community Council recommended that City Council adopt the staff recommendations in the Recommendations Section of the report (October 24, 2005) from the Director, Transportation Services, North York District.

# 9.5 40 Km/h Speed Limit – Brooke Avenue, Avenue Road to Elm Road (Ward 16 – Eglinton-Lawrence)

The North York Community Council considered a report (October 25, 2005) from the Director, Transportation Services, North York District, reporting on a request to reduce the speed limit on Brooke Avenue, Avenue Road to Elm Road to 40 km/h.

#### Recommendation:

It is recommended that this report be received for information.

On motion by Councillor Stintz, Ward 16 – Eglinton-Lawrence, the North York Community Council recommended that City Council:

- (1) approve the request to reduce the speed limit on Brooke Avenue, Avenue Road to Elm Road, to 40 km/hr; and
- (2) receive the report (October 25, 2005) from the Director, Transportation Services, North York District.

# 9.6 Through Traffic Regulations – Cactus Avenue/Palm Gate Boulevard and Steeles Avenue West (Ward 23 – Willowdale)

The North York Community Council considered a report (October 26, 2005) from the Director, Transportation Services, North York District, seeking approval to prohibit north and southbound through traffic at the intersection of Cactus Avenue/Palm Gate Boulevard at Steeles Avenue West.

#### Recommendations:

#### It is recommended that:

- (1) northbound through traffic from Cactus Avenue to Palm Gate Boulevard at Steeles Avenue West, from 4:00 p.m. to 7:00 p.m., Monday to Friday, be prohibited;
- (2) southbound through traffic from Palm Gate Boulevard to Cactus Avenue at Steeles Avenue West, from 7:00 a.m. to 9:00 a.m., Monday to Friday, be prohibited; and
- (3) the appropriate City officials be authorized to take whatever action is necessary to give affect to the foregoing, including the introduction in Council of any bills that are required.

The North York Community Council recommended that City Council adopt the staff recommendations in the Recommendations Section of the report (October 26, 2005) from the Director, Transportation Services, North York District.

# 9.7 All Way Stop Control – Lilywood Road at Times Road (Ward 15 – Eglinton-Lawrence)

The North York Community Council considered a report (October 26, 2005) from the Director, Transportation Services, North York District, reporting on the feasibility of installing an all way stop control at the intersection of Lilywood Road and Times Road.

#### Recommendation:

It is recommended that this report be received for information only.

On motion by Councillor Moscoe, Ward 15 – Eglinton-Lawrence, the North York Community Council recommended that City Council:

- (1) approve the request to install an all way stop control at the intersection of Lilywood Road and Times Road; and
- (2) receive the report (October 26, 2005) from the Director, Transportation Services, North York District.

Councillor Stintz and Councillor Shiner were opposed to the motion.

## 9.8. 40 km/h Speed Limit – Craigmore Crescent (Ward 23 – Willowdale)

The North York Community Council considered a report (October 26, 2005) from the Director, Transportation Services, North York District, seeking approval to reduce the speed limit to 40 km/h on Craigmore Crescent.

### **Recommendation:**

It is recommended that By-law No. 31878, of the former City of North York, be amended by designating a 40 km/h speed limit on Craigmore Crescent, from the easterly limit of Dudley Avenue to the northerly limit of Glendora Avenue.

The North York Community Council recommended that City Council adopt the staff recommendation in the Recommendation Section of the report (October 26, 2005) from the Director, Transportation Services, North York District.

#### (Report 9, Clause 7)

#### 9.9 Prohibited U Turn – Rockford Road (Ward 10 – York Centre)

The North York Community Council considered a report (October 27, 2005) from the Director, Transportation Services, North York District, seeking approval to prohibit U turns on Rockford Road, between the east leg of Sunnycrest Road and Robingrove Road.

#### Recommendation:

It is recommended that Schedule XV of By-law No. 31001, of the former City of North York, be amended to prohibit U turns on Rockford Road, between Sunnycrest Road (east leg) and Robingrove Road.

On motion by Councillor Feldman, Ward 10 – York-Centre, the North York Community Council recommended that City Council adopt the staff recommendation in the Recommendation Section of the report (October 27, 2005) from the Director, Transportation Services, North York District.

#### (Report 9, Clause 8)

# 9.10 On-Street Parking Machines – West side of Yonge Street, between Drewry Avenue and Patricia Avenue (Ward 23 – Willowdale)

The North York Community Council considered a report (October 27, 2005) from the Director, Transportation Services, North York District, seeking approval to install on-street pay and display parking machines on the west side of Yonge Street between Drewry Avenue and Patricia Avenue.

#### Recommendations:

#### It is recommended that:

(1) Pay and Display parking machines be installed on the west side of Yonge Street, from a point 30 metres north of the northerly limit of Drewry Avenue to the southerly limit of Patricia Avenue;

- (2) Pay and Display parking machines be installed on the west side of Yonge Street, from a point 30 metres north of the northerly limit of Drewry Avenue to the southerly limit of Patricia Avenue;
- (3) the pay and display parking areas identified in items 1 and 2 above, will be in revenue operations from 10:00 a.m. to 3:00 p.m. and 7:00 p.m. to 9:00 p.m., Monday to Friday and 8:00 a.m. to 6:00 p.m., Saturday, at a rate of \$1.50 for each half hour, to a maximum of two hours;
- (4) the pay and display parking areas identified in items 1 and 2 above, will be in revenue operations from 1:00 p.m. to 9:00 p.m., Sunday, at a rate of \$1.50 per each half hour, to a maximum of three hours; and
- (5) the appropriate City officials be authorized to take whatever action is required to give effect to the foregoing, including the introduction in Council of any bills that are required.

The North York Community Council recommended that City Council adopt the staff recommendations in the Recommendations Section of the report (October 27, 2005) from the Director, Transportation Services, North York District.

### (Report 9, Clause 9)

#### 9.11 Turn Restrictions – Campbell Crescent (Ward 25 – Don Valley West)

The North York Community Council considered a report (October 30, 2005) from the Director, Transportation Services, North York District, seeking approval to prohibit westbound left turns onto Campbell Crescent from the development driveway at 45 York Mills Road.

#### Recommendation:

It is recommended that Schedule XV of By-law No. 31001, of the former City of North York, be amended to prohibit westbound left turns at anytime from the northerly driveway access to 45 York Mills Road, on the east side of Campbell Crescent.

On motion by Councillor Jenkins, Ward 25 – Don Valley West, the North York Community Council recommended that City Council adopt the staff recommendation in the Recommendation Section of the report (October 30, 2005) from the Director, Transportation Services, North York District.

#### (Report 9, Clause 10)

# 9.12 Prohibited 'U' Turns – Sheppard Avenue East, west of Bayview Avenue (Ward 23 – Willowdale)

The North York Community Council considered a report (October 30, 2005) from the Director, Transportation Services, North York District, seeking approval to prohibit westbound 'U' Turns on Sheppard Avenue East, west of Bayview Avenue.

#### **Recommendations:**

It is recommended that:

- (1) westbound 'U' turns be prohibited at anytime on Sheppard Avenue East, at point 50 metres west of Bayview Avenue to a point 30 metres westerly thereof; and
- (2) the appropriate City officials be authorized to take whatever action is necessary to give effect to the foregoing, including the introduction in Council of any Bills that are required.
- A. Councillor Shiner, Ward 24 Willowdale, moved that the North York Community Council:
  - (1) recommend that City Council adopt the staff recommendations in the Recommendations Section of the report (October 30, 2005) from the Director, Transportation Services, North York District; and
  - (2) request the Director, Transportation Services, North York District to report further by the Spring of 2006 on intersection improvements to add an additional westbound left turn lane and all the requirements to make that happen.
- B. Councillor Filion, Ward 23 Willowdale, moved that the Director, Transportation Services, North York District, also be requested to address the problems at the intersection and look at any difficulties with all turn movements.

Motion A., moved by Councillor Shiner, Carried.

Motion B., moved by Councillor Filion, Carried.

# 9.13 Turn Prohibitions – Avenue Road and Brookdale Avenue (Ward 16 – Eglinton-Lawrence)

The North York Community Council considered a report (October 30, 2005) from the Director, Transportation Services, North York District, seeking approval to prohibit turns at the driveways to the property at 1677 Avenue Road.

#### **Recommendations:**

#### It is recommended that:

- (1) eastbound left and westbound right turns be prohibited at all times to the westerly Brookdale Avenue access driveway;
- (2) westbound left and right turns be prohibited at all times from the Avenue Road access driveway; and
- (3) appropriate City officials be authorized to take whatever action is necessary to give effect to the foregoing, including the introduction in Council of any Bills that are required.

On motion by Councillor Stintz, Ward 16 – Eglinton-Lawrence, the North York Community Council recommended that City Council adopt the staff recommendations in the Recommendations Section of the report (October 30, 2005) from the Director, Transportation Services, North York District.

# 9.14 Assumption of Services – Subdivision owned by NY Towers Inc. – Plan 66M-2364, Subdivision File UDSB-1248 – Rean Drive (Ward 24 – Willowdale)

The North York Community Council considered a report (October 5, 2005) from the Director, Development Engineering, advising Council that the municipal services installed under the terms of the Subdivision Agreement for Plan 66M-2364, dated June 6, 2001, between NY Towers Inc. and the City of Toronto are in the required condition to be assumed by the City.

#### Recommendations:

#### It is recommended that:

(1) an assumption by-law be passed to assume the municipal services in Subdivision Plan 66M-2364; and

(2) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

The North York Community Council recommended that City Council adopt the staff recommendations in the Recommendations Section of the report (October 5, 2005) from the Director, Development Engineering.

9.15 Assumption of Services – Subdivision owned by Tigix Investments – Plan 66M-2335, Subdivision File UDSB-1226 – Ballyconnor Court (Ward 24 – Willowdale)

The North York Community Council considered a report (October 5, 2005) from the Director, Development Engineering, advising Council that the municipal services installed under the terms of the Subdivision Agreement for Plan 66M-2335, dated March 8, 1999, between Tigix Investments Ltd. and the City of Toronto are in the required condition to be assumed by the City.

#### Recommendations:

It is recommended that:

- (1) an assumption by-law be passed to assume the public highways and municipal services in Subdivision Plan 66M-2335; and
- (2) the City Solicitor be authorized and directed to make any payment of costs necessary to register the assumption by-law in the Land Registry Office.

On motion by Councillor Shiner, Ward 24 – Willowdale, the North York Community Council recommended that City Council adopt the staff recommendations in the Recommendations Section of the report (October 5, 2005) from the Director, Development Engineering.

#### (Report 9, Clause 14)

9.16 Assumption of Services – Downsview Lands Secondary Plan – Block H owned by Costco Canada Inc. – Plan 64R-16745 – Billy Bishop Way (Ward 9 – York Centre)

The North York Community Council considered a report (October 5, 2005) from the Director, Development Engineering, advising Council that the municipal services installed under the terms of the Section 37 Agreement for Downsview Lands Secondary Plan – Block

H, dated August 28, 2000 and the City of Toronto are in the required condition to be assumed by the City.

#### Recommendations:

- (1) an assumption by-law be passed to assume the public highways and municipal services in Billy Bishop Way road allowance within Registered Plan 64R-16745; and
- (2) the City Solicitor be authorized and directed to make any payment of costs necessary to register the assumption by-law in the Land Registry Office.

On motion by Councillor Moscoe, Ward 15 – Eglinton-Lawrence, the North York Community Council recommended that City Council:

(1) adopt the following Recommendation:

"that the owners of the property be required to close the access points to the Dean Myers lots and agree to maintain the landscaping on the south side of Billy Bishop Way and replace the dead trees, prior to the assumption of the public highways and municipal services in Billy Bishop Way road allowance within Registered Plan 64R-16745;" and

(2) receive the report (October 5, 2005) from the Director, Development Engineering.

#### 9.17 Naming of Proposed Public Street – 2701 Keele Street (Ward 9 – York Centre)

The North York Community Council considered a report (October 27, 2005) from the City Surveyor, Technical Services, recommending that the proposed public street located at 2701 Keele Street be named "George Appleton Way".

#### Recommendations:

It is recommended that, subject to City Council granting an exception to its policy of avoiding similar sounding names and avoiding the naming of streets after living persons:

(1) the proposed public street located at 2701 Keele Street, extending easterly from Keele Street, be dedicated by by-law for public highway purposes and named "George Appleton Way";

- (2) the future extension of this street northerly to Wilson Avenue, be dedicated by bylaw for public highway purposes and named "George Appleton Way"; and
- (3) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

The North York Community Council recommended that City Council grant an exception to its policy of avoiding similar sounding names and avoiding the naming of streets after living persons, and adopt the staff recommendations in the Recommendations Section of the following report (October 27, 2005) from the City Surveyor, Technical Services, as follows:

- (1) the proposed public street located at 2701 Keele Street, extending easterly from Keele Street, be dedicated by by-law for public highway purposes and named "George Appleton Way";
- (2) the future extension of this street northerly to Wilson Avenue, be dedicated by by-law for public highway purposes and named "George Appleton Way"; and
- (3) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

- (o) 5 Northtown Way;
- (p) 10 Northtown Way;
- (q) 15 Northtown Way;
- (r) 3560 Victoria Park Avenue;
- (s) 2760 Bathurst Street;
- (t) 199 Upper Canada Drive;
- (u) 1700 Eglinton Avenue; and
- (2) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Councillor Moscoe, Ward 15 – Eglinton-Lawrence, the North York Community Council recommended that:

- (1) City Council adopt the staff recommendations in the Recommendations Section of the report (October 28, 2005) from the District Chief, Fire Prevention North Command; and

# 9.25 Request for Approval of a Variance from the former City of North York Sign By-law No. 30788, as amended, for the erection of an LCD Video Screen Menu Board Ground Sign at 5955 Leslie Street (Ward 24 – Willowdale)

The North York Community Council considered a report (November 1, 2005) from the Director & Deputy Chief Building Official, North York District, reviewing and making recommendations on a request by Mark Bradley of TDL Group Corp., for a variance from the former City of North York Sign By-law No. 30788, as amended, to permit the erection of an LCD video screen menu board ground sign at the above location.

#### Recommendation:

It is recommended that the request for the variance be refused for the reasons outlined in this report.

# 9.26 Spenvalley Drive and Yatescastle Drive – Blessed Margherita of Citta Di Castello Catholic School (Ward 9 – York Centre)

The North York Community Council considered a report (October 31, 2005) from the Director, Transportation Services, North York District, seeking approval to amend the limits of the school bus loading zone and parking/stopping regulations on Yatescastle Drive and Spenvalley Drive.

#### Recommendations:

#### It is recommended that:

- (1) Schedule XI of By-law No. 31001, of the former City of North York, be amended by deleting the No Standing, 8:00 a.m. to 4:00 p.m., Monday to Friday, prohibition on the east side of Yatescastle Drive, from a point 69 metres north of the northerly limit of Spenyalley Drive to a point 51 metres northerly thereof;
- (2) Schedule X of By-law No. 31001, of the former City of North York, be amended by deleting the 15 minute Permitted Parking, 8:00 a.m. to 4:00 p.m., Monday to Friday, restriction on the east side of Yatescastle Drive, from a point 120 metres north of the northerly limit of Spenvalley Drive to a point 72 metres northerly thereof;
- (3) Schedule X of By-law No. 31001, of the former City of North York, be amended by installing 15 minute Permitted Parking, 8:00 a.m. to 4:00 p.m., Monday to Friday, restriction on the east side of Yatescastle Drive, from a point 69 metres north of the northerly limit of Spenvalley Drive to a point 123 metres northerly thereof;
- (4) By-law No. 32759, of the former City of North York, be amended by deleting the School Bus Loading Zone on the north side of Spenvalley Drive, from 17 metres east of the easterly limit of Yatescastle Drive to a point 32 metres easterly thereof;
- (5) Schedule VIII of By-law No. 31001, of the former City of North York, be amended by deleting the No Parking Anytime, prohibition on the north side of Spenvalley Drive, from the easterly limit of Yatescastle Drive to the westerly limit of the west portion of Watney Crescent;
- (6) Schedule IX of By-law No. 31001, of the former City of North York, be amended by deleting the No Stopping, 8:00 a.m. to 6:00 p.m., Monday to Friday, prohibition on the north side of Spenvalley Drive, from the easterly limit of Yatescastle Drive to a point 97.65 metres east of the easterly limit of Yatescastle Drive;
- (7) Schedule X of By-law No. 31001, of the former City of North York, be amended by installing 15 minute Permitted Parking, on the north side of Spenvalley Drive, from the easterly limit of Yatescastle Drive to a point 120 metres easterly thereof; and

(8) Schedule VIII of By-law No. 31001, of the former City of North York, be amended by installing a No Parking Anytime prohibition on the north side of Spenvalley Drive, from a point 120 metres east of the easterly limit of Yatescastle Drive to the westerly limit of Watney Crescent (west leg).

The North York Community Council recommended that City Council adopt the staff recommendations in the Recommendations Section of the report (October 31, 2005) from the Director, Transportation Services, North York District.

# 9.27 All Way Stop Control – John Lindsay Court and Sawmill Road (Ward 9 – York Centre)

The North York Community Council considered a report (November 4, 2005) from the Director, Transportation Services, North York District, reporting on the feasibility of installing an all way stop control at the intersection of John Lindsay Court and Sawmill Road (south leg).

#### Recommendation:

It is recommended that this report be received for information.

On motion by Councillor Augimeri, Ward 9 – York-Centre, the North York Community Council recommended that City Council:

- (1) approve the request to install an all way stop control at the intersection of John Lindsay Court and Sawmill Road (south leg); and
- (2) receive the report (November 4, 2005) from the Director, Transportation Services, North York District.

Councillor Stintz was opposed to the motion.

## 9.28 40 km/h Speed Limit – John Lindsay Court (Ward 9 – York Centre)

The North York Community Council considered a report (November 4, 2005) from the Director, Transportation Services, North York District, reporting on a request from Councillor Maria Augimeri to introduce a 40 km/h speed zone on John Lindsay Court.

#### Recommendation:

It is recommended that this report be received for information only.

On motion by Councillor Augimeri, Ward 9 – York-Centre, the North York Community Council recommended that City Council:

- (1) approve the request to introduce a 40 km/h speed zone on John Lindsay Court; and
- (2) receive the report (November 4, 2005) from the Director, Transportation Services, North York District.

# 9.29 Traffic Control Signal Installation – Yonge Street at the GO/York Region Transit Terminal (Ward 23 – Willowdale) (Ward 24 – Willowdale)

On motion by Councillor Shiner, Ward 24 - Willowdale, and in accordance with §27-127, Late Items, of Chapter 27 of the City of Toronto Municipal Code, the North York Community Council, by majority vote, granted leave to introduce a report (November 10, 2005) from the Director, Transportation Services, North District, regarding the Traffic Control Signal Installation – Yonge Street at the GO/York Region Transit Terminal.

The North York Community Council considered a report (November 10, 2005) from the Director, Transportation Services, North York District, reviewing a request to install traffic control signals on Yonge Street at the GO/York Region Transit Terminal and associated turn prohibitions.

#### Recommendations:

It is recommended that:

- (1) traffic control signals be installed on Yonge Street at the GO/York Region Transit Terminal driveway, located approximately 90 metres north of Bishop Avenue/Hendon Avenue;
- (2) coincidental with the installation of the traffic control signals noted in Recommendation (1);
  - (i) westbound left turns and through movements be prohibited at anytime, from the GO/York Region Transit Terminal driveway to Yonge Street;
  - (ii) northbound left turns be prohibited at anytime from Yonge Street to the Toronto Transit Commission (TTC) Park 'N' Ride driveway;
  - (iii) eastbound left turns and through traffic movements be prohibited at anytime, from the Toronto Transit Commission (TTC) Park 'N' Ride driveway to Yonge Street;
  - (iv) pedestrian crossings of Yonge Street be prohibited at anytime on the north and south approaches to the proposed traffic control signal;
- (3) the Director of Transportation Services report back to Community Council three months after the implementation of the traffic control signals, on the feasibility of permitting TTC vehicles to be exempt from the left turn designation at the traffic control signals; and
- (4) the appropriate City officials be authorized to take whatever action is necessary to give effect to the foregoing, including the introduction in Council of any Bills that are required.

The North York Community Council also considered the following Resolution submitted by Councillor Shiner, Ward 24 – Willowdale:

"WHEREAS surface transit service to the Finch subway station is increasing; and

WHEREAS surface transit services to the Finch station operate out of two terminals, one for regional transit and one for local transit; and

WHEREAS both surface transit terminals access the same subway facility; and

WHEREAS the intersections of Yonge Street/Hendon Avenue/Bishop Avenue and Yonge Street/Finch Avenue are congested as a result of vehicular traffic and the turning requirements for transit vehicles to access their respective terminals; and

WHEREAS this congestion affects surface transit service reliability as well as access to adjacent land uses; and

WHEREAS special traffic control measures are now required to ensure that adequate access be available to the transit terminals; and

WHEREAS York Region has requested the installation of special traffic control signals on Yonge Street to facilitate access and egress of transit vehicles from the regional terminal; and

WHEREAS sufficient lands appear to be available in the vicinity of the intersection of Yonge Street with Hendon Avenue/Bishop Avenue to facilitate the development of a single surface transit terminal; and

WHEREAS the City of Toronto supports improvements to transit services;

THEREFORE BE IT RESOLVED THAT the signals requested by York Region be installed on a temporary basis, to allow officials from the City of Toronto, the Toronto Transit Commission and York Region, in consultation with all transit carriers accessing the Finch subway station, to review the feasibility of providing a single shared use facility for surface transit services in this area. This review should assess improved surface access, reduced traffic congestion and improved pedestrian facilities resulting from a single facility for all surface transit services serving the Finch subway station; and

BE IT FURTHER RESOLVED THAT a report be submitted to the July 2006 meeting of North York Community Council, outlining the results of this assessment, at which time the continued operation of the new traffic control signals will be determined";

On motion by Councillor Shiner, Ward 24-Willowdale, the North York Community Council recommended that City Council:

- (1) adopt the foregoing Resolution submitted by Councillor Shiner, Ward 24 Willowdale; and
- (2) receive the report (November 10, 2005) from the Director, Transportation Services, North York District.

# 9.30 Payment-in-Lieu of Parking – Quiznos Canada Inc. – 4922 Yonge Street (Ward 23 – Willowdale)

On motion by Councillor Filion, Ward 23 – Willowdale, and in accordance with §27-127, Late Items, of Chapter 27 of the City of Toronto Municipal Code, the North York Community Council, by majority vote, granted leave to introduce a motion regarding Payment-in-Lieu of Parking – Quiznos Canada Inc. – 4922 Yonge Street, submitted by Councillor Filion.

The North York Community Council considered the following Resolution submitted by Councillor Filion, Ward 23 – Willowdale:

"WHEREAS the proposed Quiznos Canada Inc. is proposing a restaurant to be located at 4922 Yonge Street; and

WHEREAS Quiznos Canada Inc. applied for a change in use for the building from retail to restaurant use; and

WHEREAS the proposed change would increase the on-site requirements from 5 parking spaces to 14 parking spaces; and

WHEREAS North American Retail Architects Inc. (on behalf of Quiznos Canada Inc.) has requested that payment-in-lieu of parking, as per Council Policy be applied; and

WHEREAS the property location is well served by on-street metered parking and adjacent 112-space and 401-space municipally operated lots;

THEREFORE BE IT RESOLVED THAT the requested payment-in-lieu of parking for the proposed Quiznos Restaurant be accepted;

AND BE IT FURTHER RESOLVED THAT payment-in-lieu of parking, as per Council's policy, be applied to the parking deficiency of 9 spaces at the rate of \$2,500 per parking space."

On motion by Councillor Filion, the North York Community Council recommended that City Council adopt the Resolution submitted by Councillor Filion, Ward 23 – Willowdale.

- (1) the condition and the capacity of the existing sewer infrastructure in the Wnyford / Concorde / Palisades area, and
- (2) what improvements can be made and what the cost of any improvements would be.

# 9.32 Report Request - Naming of Soccer Centre Facility - Keele Reservoir - 4995 Keele Street (Ward 8 - York West)

On motion by Councillor Li Preti, Ward 8 – York West, and in accordance with §27-127, Late Items, of Chapter 27 of the City of Toronto Municipal Code, the North York Community Council, by majority vote, granted leave to introduce a Resolution regarding a Report Request – Naming of Soccer Centre Facility – Keele Reservoir – 4995 Keele Street (Ward 8 – York West) submitted by Councillor Li Preti.

The North York Community Council considered the following Resolution submitted by Councillor Li Preti, Ward 8 – York West:

"WHEREAS the City's Parks, Forestry and Recreation Division has identified the need for a major outdoor lit soccer facility, based on the growing demand for this sport; and

WHEREAS a site at the Keele Reservoir has been identified as being suitable for this type of facility; and

WHEREAS the City has constructed a major soccer field including a full size irrigated field with lights; and

WHEREAS an RFP was issued for a firm to construct the appurtenant facilities such as a field house that includes change rooms, washrooms and a community room; and

WHEREAS a petition has been received by the City to name the soccer centre at the Keele Reservoir in honour of Sandy Ricciuto; and

WHEREAS Sandy Ricciuto is a well known and respected member of his community; and

WHEREAS Sandy Ricciuto has demonstrated his generosity by donating his time and leadership and by financially contributing to projects such as the Family Centre Project that involves the creation of a daycare and meeting rooms for seniors and youth in the community; and

WHEREAS Sandy Ricciuto's leadership is responsible for annual fundraisers where all proceeds go to the Children's Aid Society; and

WHEREAS Sandy Ricciuto is also responsible for donating funds to developing nations, specifically, Chad, Africa;

NOW THEREFORE BE IT RESOLVED THAT the General Manager of Parks, Forestry and Recreation Division be requested to review this request in accordance with the Naming and Renaming of Parks and Recreation Facilities Policy; and

BE IT FURTHER RESOLVED THAT the General Manager of Parks, Forestry and Recreation Division be requested to report back to North York Community Council at its' meeting on January 17, 2006.

On motion by Councillor Li Preti, the North York Community Council adopted the foregoing Resolution.

## 9.33 Small Video Display Screens on Restaurant Drive Thru's

That Video Screen Venues be positioned so they cannot be seen by motorists in traffic lanes; and

That the Chair of the Planning and Transportation Committee be authorized to consult with Municipal Licensing and Standards and to give statutory notice of the by-law adjustments at an appropriate date."
