**7-1. Final Report – City Initiated Official Plan Amendment
2 McDonalds Place, 1 and 3 Concorde Gate and
10 and 12 Concorde Place
(Ward 26 – Don Valley West)**

The Planning and Transportation Committee considered the following report and communications:

Recommendation:

It is recommended that in the event that City Council decides to amend the New Official Plan to re-designate the lands known municipally as 2 McDonalds Place, and 1-3 Concorde Gate 10 and 12 Concorde Place from *Mixed Use Areas* to *Employment Areas*, City Council may:

- (1) amend the Official Plan for the City of Toronto substantially in accordance with the draft Official Plan Amendment attached as Attachment No. 1; and
 - (2) authorize the City Solicitor to make such stylistic and technical changes to the draft Official Plan Amendment as may be required.
- (2) (August 24, 2005) from Jennifer Whittard; and
- (3) (September 8, 2005) from Anne Morash, The Cadillac Fairview Corporation Limited.

- (3) notice for the Public Meeting under the Planning Act be given according to the regulations under the Planning Act.

On motion by Councillor Moscoe, the Planning and Transportation Committee:

- (1) recommended that City Council adopt the staff recommendations contained in the Recommendations Section of the report (September 1, 2005) from the Chief Planner and Executive Director, City Planning; and
- (2) requested the Chief Planner and Executive Director, City Planning, in consultation with the Toronto and Region Conservation Authority, to submit a report to the Planning and Transportation Committee on the initial review of the flood protection landform area in light of the recent occurrence of flooding in New Orleans; such report to also address the liability to the City in the event there is flooding over the flood protection landform.

7-3. New Provincial Regulation for the Clean Up of Contaminated Sites

The Planning and Transportation Committee considered a report (August 24, 2005) from the Chief Planner and Executive Director, City Planning and the Chief Building Official and Executive Director, Building Division, advising that the province's new Regulation 153/04, effective October 1, 2005 - Records of Site Condition (RSC) will now provide new clear rules for the clean up of contaminated sites when a change in use occurs. This report provides a summary of the new regulation released under the Environmental Protection Act and identifies its implications on City procedures including the impact on building permit service delivery.

Recommendations:

It is recommended that:

- (1) the City's Harmonised Site Remediation Peer Review Process no longer apply to development applications under the Planning Act, except where land is being conveyed to the City as part of the approval of the applications;
- (2) with the exception of projects that involve land conveyances to the City, the current harmonized peer review process that is required as a part of a development application approval be discontinued as of October 1, 2005 and the appropriate City officials, where requested by the property owner, be authorized to make amendments to the peer review requirements of existing development related agreements entered into by the City to reflect this process change;
- (3) effective January 1, 2006, Council approve 6 full time equivalent plan review positions in the Building Division, offset by a 1 percent increase in the building permit application fee to carry out new responsibilities as a result of the Brownfields Statute Law Amendment Act and the potential impact of the new Act on meeting the service delivery standards of the Building Code Statute Law Amendment Act, which take effect on January 1, 2006;
- (4) this report be forwarded to the Works Committee for information; and
- (5) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

**7-4. West Toronto Diamond Rail-to-Rail Grade Separation
Extension of Grade Separation to North of St. Clair Avenue West**

The Planning and Transportation Committee considered a report (June 13, 2005) from the Chief Planner and Executive Director, City Planning, responding to City Council's Direction of May 18, 2005 regarding the Environmental Assessment (EA) recently completed by GO Transit in relation to the West Toronto Diamond Rail-to-Tail Grade Separation.

Recommendations:

It is recommended that:

- (1) City Council not pursue any additional investigations related to extending the trench for the CN/CP West Toronto Diamond Rail-to-Rail Grade Separation to cross under St. Clair Avenue West, due to the prohibitive high costs that would be borne by the City of Toronto; and
- (2) City Council direct staff to work with the St. Clair West Community Design Consultation Group to improve physical conditions in and around the CN/CP structure east of Keele Street as part of the detailed design work for the St. Clair Avenue West Transit Improvements project.

The Planning and Transportation Committee also considered a communication (undated) from Claude Bergeron.

On motion by Councillor Thompson, on behalf of Councillor Palacio, the Planning and Transportation Committee recommended that:

- (1) the City of Toronto formally request the Provincial Minister of Public Infrastructure Renewal and Federal Minister of State for Infrastructure and Communities to help fund important City building in future projects; and
- (2) City Council direct staff to work with the St. Clair Community Design Consultation Group and Transit Community Liaison Committee (TCLC) to improve physical conditions in and around the CN/CP structure east of Keele Street as part of the detailed design work for the St. Clair West Transit Improvements Project and have this location identified as an additional “key location” for public art and beautification.

**7-6. Proposed Graffiti Abatement Strategy – “Clean Team” Operations
Anti-Graffiti Coatings**

The Planning and Transportation Committee considered a report (August 18, 2005) from the Executive Director, Municipal Licensing and Standards, advising the Planning and Transportation Committee on anti-graffiti protective coatings.

Recommendation:

It is recommended that this report be received.

On motion by Councillor Moscoe, the Planning and Transportation Committee recommended that:

- (1) each City Division identify a list of publicly owned surfaces within their jurisdictions that are prone to graffiti including street poles and traffic control boxes;
- (2) each Division affected, identify a limited amount within their existing budget to experiment with re-coating some problem locations and report on this matter through their respective council committees;
- (3) the Executive Director of Municipal Licensing and Standards be requested to prepare a publication based on the information in this report to distribute to private property owners with graffiti prone properties;
- (4) the full cost of the publication be underwritten by advertising sold to the manufacturers of these coatings;

- (5) this matter be forwarded to the Clean and Beautiful City Roundtable and all City Agencies, Boards and Commissions for their information;
- (6) the “Clean Team” graffiti removal operating season be extended by four months, from the current time period of May to September to an extended period of March to November; and
- (7) the acquisition of two pressure washers and related equipment and supplies be approved, and the cost of \$7,000.00 be absorbed within the non-salary Municipal Licensing and Standards’ budget.

7-7. Toronto Bike Plan – Year 3 Progress Report (2004)

The Planning and Transportation Committee considered a communication (June 22, 2005) from the Toronto Cycling Committee advising that the Toronto Cycling Committee on June 20, 2005, had before it a report (June 13, 2005) from the Acting General Manager, Transportation Services Division, providing the third annual progress report on the implementation of the Toronto Bike Plan and to outline a strategy for reviewing and accelerating the Toronto Bike Plan schedule of implementation. The Toronto Cycling Committee also had before it a communication (June 20, 2005) from Martin Koob, Member, Toronto Cycling Committee.

Recommendations:

The Toronto Cycling Committee on June 20, 2005, recommended that:

- (1) the report (June 13, 2005) from the Acting General Manager, Transportation Services Division, be forwarded to the Board of Health for information;
- (2) the Board of Health request the Medical Officer of Health to:
 - (a) assist the Toronto Cycling Committee in promoting cycling as one of the means to reduce smog and improve air quality; and

- (b) arrange a presentation to the Toronto Cycling Committee by Toronto Public Health staff regarding:
 - (i) air quality;
 - (ii) fitness;
 - (iii) injury prevention; and
 - (iv) disease prevention

as it relates to promoting cycling as one of the tools to help improve the quality of life for the citizens of Toronto;

- (3) the Works Committee, the Economic Development and Parks Committee and the Planning and Transportation Committee, be advised that the Toronto Cycling Committee endorses the proposed work plan to develop the Strategy for Accelerating the Toronto Bike Plan as outlined in the report (June 13, 2005) from the Acting General Manager, Transportation Services Division;
- (4) City Council be requested to address the shortfalls in capital funding, the insufficient human resources and the difficulties in the bicycle lane approval process that have stalled the implementation of the Toronto Bike Plan; and
- (5) the Acting General Manager, Transportation Services Division, the Chief Planner and Executive Director, City Planning Division, and the General Manager, Parks, Forestry and Recreation Division, be requested to incorporate the strategy proposed in the report (June 13, 2005) from the Acting General Manager, Transportation Services Division, into their 2006 budget process, in order to assist in the acceleration of the implementation of the Toronto Bike Plan.

On motion by Councillor Ootes, the Planning and Transportation Committee:

- (1) received the communication (June 22, 2005) from the Toronto Cycling Committee; and

7-11. Fireworks Displays and Public Safety

The Planning and Transportation Committee considered the following communications:

- (1) (June 20, 2005) from the City Clerk advising that City Council on June 14, 15 and 16, 2005, referred the following Motion to the Planning and Transportation Committee:

J(1) Fireworks Displays and Public Safety
Moved by Councillor Carroll, seconded by Councillor Hall

“WHEREAS the 2005 Victoria Day weekend was marred with numerous instances of dangerous and/or careless use of fireworks; and

WHEREAS, in spite of Toronto Fire’s concerted efforts, we still had an alarming number of fires that appear to be attributable to fireworks; and

WHEREAS so far this year, there have been 34 fires with an apparent ignition source being fireworks, with 31 occurring over the last few days causing, in total, \$306,541.00 in property damage; and

WHEREAS the media aired alarming video footage, both amateur and professional, of kids using fireworks as weapons; and

WHEREAS the television news media aired a story featuring a number of local convenience stores that were selling fireworks to minors; and

WHEREAS there is growing public concern about the use of fireworks in their neighbourhoods, often with little regard for public safety; and

WHEREAS the proximity of areas of Toronto to boundaries with other GTA Municipalities may hinder local efforts to license, prohibit or regulate the sale, purchase and use of fireworks;

NOW THEREFORE BE IT RESOLVED THAT the City Solicitor be requested to report to the Planning and Transportation Committee on:

- (1) the City's legislative authority to regulate the use of fireworks in the City of Toronto;
- (2) the current Provincial Set Fines for the sale of fireworks to minors;
- (3) whether private fireworks displays can be prohibited or regulated through a permit system;
- (4) the feasibility of a total ban on private fireworks displays in the City of Toronto;
- (5) the status of harmonization of by-laws regulating fireworks sale and displays in the former municipalities in the City of Toronto; and
- (6) existing laws regulating the sale and use of fireworks in New York State, Quebec and other jurisdictions as deemed appropriate by the City Solicitor;

AND BE IT FURTHER RESOLVED THAT a copy of this Motion and the above-mentioned report, when ready, be forwarded to Mr. Michael Bryant, Attorney General of Ontario, with a request that the provincial government pursue the feasibility of a province-wide ban on private fireworks displays.”

during which fireworks are
traditionally used; and

following this consultation and review staff undertake to draft a by-law which addresses the foregoing matters in order to harmonize the existing by-laws regulating fireworks sales and displays; (**Motions by Councillor Stintz**) and

- (II) amending the second operative paragraph by deleting the words “with a request that the provincial government pursue the feasibility of a province-wide ban on private fireworks displays.”; so that the operative paragraphs now reads as follows:

“NOW THEREFORE BE IT RESOLVED THAT the City Solicitor be requested to report to the Planning and Transportation Committee on:

- (1) the City’s legislative authority to regulate the use of fireworks in the City of Toronto;
- (2) the current Provincial Set Fines for the sale of fireworks to minors;
- (3) the status of harmonization of by-laws regulating fireworks sale and displays in the former municipalities in the City of Toronto;
- (4) existing laws regulating the sale and use of fireworks in New York State, Quebec and other jurisdictions as deemed appropriate by the City Solicitor;
- (5) undertake meaningful consultation with the pyrotechnic industry and other interested parties regarding the safe use

and effective regulation of fireworks sales and displays, including but not limited to the use of a licensing system;

AND BE IT FURTHER RESOLVED THAT a copy of this Motion and the above-mentioned report, when ready, be forwarded to Mr. Michael Bryant, Attorney General of Ontario;” and **(Motions by Councillor Stintz on behalf of Councillor Carroll)**

- (B) requested the Fire Chief and General Manager to submit a report to the Community Services Committee on the extent to which private use of fireworks has created a problem in terms of fires and injuries. **(Motion by Councillor Ootes)**

7-12. Appointment of Member to the Sub-Committee of the Planning and Transportation Committee to Review the City’s Planning Process
