### **Scarborough Centre Secondary Plan Review**

#### **Scarborough Centre Secondary Plan (Official Plan Amendment No. 1146)**

#### **North of Ellesmere Road, South of Highway 401, West of Bellamy Road and East (including properties on or near the west side) of Brimley Road**

#### **File No. 05 144149 EPS 00 TM**

#### **Wards 37 & 38 - Scarborough Centre**

The Planning and Transportation Committee held a statutory Public Meeting on November 7, 2005, and notice was given in accordance with the *Planning Act*.

The Planning and Transportation Committee considered a report (October 24, 2005) from the Chief Planner and Executive Director, City Planning, which represents the conclusion of the Scarborough Centre Secondary Plan Review and recommends amendments to the Official

Plan and the Zoning By-law for the Scarborough Centre (lands north of Ellesmere Road, south of Highway 401, west of Bellamy Road and east (including properties on or near the west side) of Brimley Road.

Recommendations:

It is recommended that City Council:

- (1) amend the Official Plan (City Centre Secondary Plan) for the former City of Scarborough Official Plan substantially in accordance with the draft Official Plan Amendment No. 1146 attached as Attachment 4;
- (2) amend the Employment Districts Zoning By-law No. 24982 (Progress), as amended, for the former City of Scarborough substantially in accordance with the draft Zoning By-law Amendment attached as Attachment 5;
- (3) enact an Alternative Parkland Dedication By-law for the Scarborough Centre which implements an alternative parkland rate of 0.4 hectares per 300 dwelling units for residential development but not less than 5 percent of the land area, substantially in accordance with the draft By-law attached as Attachment 6;
- (4) direct the City Solicitor to request the Ontario Municipal Board to modify the Official Plan of the City of Toronto to incorporate the proposed Scarborough Centre Secondary Plan (attached as Attachment 4) with appropriate amendments;
- (5) direct the City Solicitor to request the Ontario Municipal Board to modify the pending Official Plan Amendment for the lands at 1750 Brimley Road to be consistent with the proposed Scarborough Centre Secondary Plan (Attachment 4); and
- (6) authorize the City Solicitor to make such stylistic and technical changes to the draft Official Plan Amendment, the draft Zoning By-law Amendment and the draft Alternative Parkland Dedication By-law, as may be required.

### 10.3 Improving the Planning Process

The Planning and Transportation Committee had before it a report (November 3, 2005) from the Chief Planner and Executive Director, City Planning Division, recommending operational changes to planning processes in order to achieve improved public participation, collaboration, communication, accessibility, transparency and greater accountability.

#### Recommendations:

- (1) It is recommended that City Council adopt current and proposed business practice changes to the City Planning Division, which can be absorbed by the Division's budget for 2006, as follows:
  - (a) the planning process be changed for complex planning applications (rezoning, official plan amendments, sub-division, and related site plan control applications) so that community consultation meetings are held earlier in the process, before the preparation of staff reports;
  - (b) City Planning review and improve application information and the process for public access to information, including the use of email to notify interested groups;
  - (c) City Planning use clear language to describe relevant planning issues, policies, guidelines and the response to public concerns in all reports;
  - (d) City Planning, in consultation with the City Clerk, the City Solicitor and other appropriate civic officials, work with the Committee of Adjustment to improve communication material, the content of public notices and decisions, on-site signage, notification procedures, and to develop comprehensive protocols for the various responsibilities of the Committee;
  - (e) City Planning ensure that City guidelines (as contained in a draft document entitled "Community Engagement Handbook") for community engagement, including equity and human rights, are adhered to when conducting community consultation meetings, and that the relevant guidelines be made available to the public and are announced before the meeting;
  - (f) City Planning continue existing public outreach programs, such as attending community association meetings and provide staff training on consultation skills and outreach services, including effective facilitation methodology,

within existing budget limits;

- (g) City Planning improve public education within existing budget limits; and
  - (h) City Planning develop criteria for determining when professional facilitators for community meetings should be used;
- (2) it is recommended that the following proposed business practice changes to the City Planning Division, recommended by the Planning and Transportation Sub-Committee, as amended by the Planning and Transportation Committee, not be adopted because of funding requirements, which are not part of the Division's proposed budget for 2006 or for technical reasons, as follows:
- (a) expansion of notification for planning applications to residential tenants and condominium unit owners;
  - (b) development of web page enhancements;
  - (c) increased public involvement and outreach by City Planning over and above existing levels would require additional staff resources;
  - (d) the hiring of professional facilitators; and
  - (e) the scheduling of additional community consultation meetings above existing levels;
- (3) it is recommended that staff continue the pre-application consultation process, as set out in the Building Toronto Together development guide and that Appendix 2 in the Sub-committee's report be amended to indicate pre-application consultation as the first step for all complex applications;
- (4) it is recommended that City Council consider enforcement mechanisms for the works and amenities approved and secured under site plan control applications at the time it considers the report from the Chief Planner on the passing of the new harmonized site plan control by-law; and
- (5) it is recommended that the Chief Planner report back to the Planning and Transportation Committee meeting no later than September 2006 on the progress of implementing the changes outlined in this report and the identification of additional implementation costs.

**10.4 Designation of Community Improvement Project Areas  
to Implement the BIA Commercial Façade Improvement Program**

- (1) the City Solicitor, in consultation with the Chief Planner and Executive Director, City Planning Division, be authorized to prepare the necessary by-laws to ensure that areas that coincide with the existing 54 Business Improvement Areas are designated as Community Improvement Project Areas as contemplated in this report;
- (2) the Chief Planner and Executive Director, City Planning Division, in consultation with the Executive Director of Economic Development, be authorized to prepare Community Improvement Plans as well as amendments to existing Community Improvements Plans as may be appropriate, to implement a Commercial Façade Improvement Program within areas that coincide with all 54 of the existing Business Improvement Areas (BIAs) further to Council's direction found in Report 8, Clause 8 of the Economic Development and Parks Committee;
- (3) in accordance with the requirements of the *Planning Act*, staff be authorized to hold a public meeting before the Planning and Transportation Committee at its first meeting of 2006; and
- (4) this report be forwarded to the Economic Development and Parks Committee for information.

#### **10.10 Proposed Amendments to the City of Toronto Municipal Code, Chapter 545, Licensing, Regarding the Regulation of Entertainment Facilities**

  2. Shiatsu Therapy Association of Ontario;
  3. Healing Touch Association of Canada, Inc.;
  4. Canadian Federation of Aromatherapists;
  5. Association of Massage Therapist and Wholistic Practitioners (AMTWP);
  6. The Ontario Herbalist Association;

7. Ontario Polarity Therapy Association;
  8. Trager Canada;
  9. Reflexology Registration Council of Canada (RRCO);
  10. Canadian Reiki Association;
  11. International Association of Rubenfeld Synergists;
  12. Examining Board of Natural Medicine Practitioners; and
  13. Shiatsu Diffusion Society;
- (2) the following four holistic associations and its board of directors, which did not qualify to be recognized as Professional Holistic Associations, will not be able to reapply to be included in Toronto Municipal Code Chapter 545, Licensing, Appendix L, as a Professional Holistic Association, for a period of at least one year from the date of adoption by Council:
1. Canadian Examining Board of Health Care Practitioners;
  2. Iridologists Association of Canada;
  3. The Feldenkrais Centre; and
  4. World Peace and Natural Health Association;
- (3) the provisions relating to holistic practitioners being required to be members in good standing of a Professional Holistic Association come into effect for all individuals applying for a new licence on the date of adoption by Council;
- (4) all holistic centre owners and holistic practitioners who are licensed, or who have submitted an application for a licence, prior to the date of adoption by Council, not be required to demonstrate that they are members in good standing of a Professional Holistic Association until the date of their next renewal, but not earlier than three months after the requirements come into effect;
- (5) Section 545-161 of Toronto Municipal Code Chapter 545, Licensing, be replaced with the amendment in Appendix A of this report;
- (6) the definition in Appendix B of this report be added to Toronto Municipal Code Chapter 545, Licensing, Article XI;
- (7) Section 545-161.1 in Appendix C of this report be added to Toronto Municipal Code Chapter 545, Licensing, Article XI;
- (8) Subsection 545-162B of Toronto Municipal Code Chapter 545, Licensing, pertaining to the grandfathering of individuals licensed prior to 1998, be repealed;
- (9) any other consequential bylaw amendments to Chapter 545 or any other by-law be correspondingly effected;

- (10) the City Solicitor be directed to prepare the necessary bill to give effect to the recommendations in this report, effective immediately; and
