Status of Women Working Group

The meeting convened at 7:00 p.m. with Councillor Mihevc in the Chair.

There were no declarations of interest under the Municipal Conflict of Interest Act.

Welcome and Introductions from Mayor David Miller and Councillor Joe Mihevc

The Members of the Roundtable, staff members and interested persons in attendance were welcomed by the Chair.

Mayor David Miller gave a presentation on the City's policy to promote equality throughout the City, the accomplishments to date, and an overview of the importance of the Roundtable in helping the City achieve its full potential in serving the needs of all sectors of Toronto's diverse population.

The Chair gave a brief historical overview of the City's former goals and achievements relating to access, equity and human rights within the City of Toronto, commencing with the initial 1997 City of Toronto Task Force on Community Access and Equity.

All Committee Members and staff were subsequently invited to introduce themselves and briefly state their interest that brought them to the Roundtable.

1. Mandate and Procedures for the Roundtable on Access, Equity and Human Rights

The Roundtable considered the following communications:

- (a) (October 4, 2004) from the City Clerk forwarding Clause 34 of Report 7 of the Policy and Finance Committee, headed "Simplified Procedures for Advisory Bodies", adopted by City Council on September 28, 29, 30 and October 1, 2004; and
- (b) (February 21, 2005) from Diversity Management and Community Engagement, providing a summary report of the City of Toronto policies, reports and studies regarding Access, Equity and Human Rights.

2. Overview of the City's Progress on Access, Equity and Human Rights Related Initiatives

Councillor Mihevc gave a presentation outlining the City's progress on access, equity and human rights, which included a vision statement on the City's access, equity and diversity; a policy framework and a plan of action for the elimination of racial discrimination and discrimination; a mechanism for community input through Advisory Committees and Working Groups including public consultations, appointments to

Agencies, Boards and Commissions, and improved accessibility; and also a mechanism for evaluation and accountability through studies, departmental action plans and annual reports, as well as an audit by the City Auditor General.

Sylvia Searles, Special Assistant in the Mayor's Office gave a presentation on the Terms of Reference and Workplan, including why the Mayor and Council established roundtables; the procedures to guide the business of the roundtable; the process of providing advice; the role of program staff, the role of City Clerk's staff; the framework for an equity lens; objective and components of an equity lens; and a working group structure.
