Minute 3.1

The Chair welcomed everyone and thanked them for coming to the meeting. At the invitation of the Chair the people in the room introduced themselves.

The event was very well attended by seniors who came to City Hall to learn about a range of services for seniors provided by community groups as well as the three orders of government. There was a launch of the event that included Mayor David Miller, the Hon. John Gerretsen (then) Minister Responsible for Seniors (Province) and the Hon. Tony Ianno, Minister of State for Families and Caregivers (Federal).

The Chair advised the Roundtable on Seniors that the communication from Mayor Miller to provincial Ministers on retirement homes would be circulated shortly and any updates would be brought forward to the Roundtable on Seniors at future meetings.
