On motion by Angela Kennedy, Trustee, T.C.D.S.B., the Toronto Pedestrian Committee requested that a Steering Committee / Working Group be set up in order that the Toronto Pedestrian Committee can assist to outline the various phases of the plan and requested that a draft Terms of Reference with respect to the mandate/objectives and membership of the working group be proposed and report back to Committee for its consideration.

9.4 Cycling on Sidewalks Report

The Toronto Pedestrian Committee received a presentation from Brigitte Nowak, Member, Toronto Cycling Committee regarding the Cycling on Sidewalks report (Bicycle Safety Education Plan) to the Toronto Pedestrian Committee.

On a Motion by Angela Kennedy, Trustee, T.C.D.S.B., The Toronto Pedestrian Committee, supports the Toronto Cycling Committee recommendations to Planning and Transportation Committee as outlined in its transmittal letter (December 15, 2005) requesting the Planning and Transportation Committee to:

- allocate an additional \$100,000.00 to the Transportation Planning, City Planning budget to carry out the Sidewalk Riding Counter Measure: A Bicycle Safety Education Plan, program in 2006, and
- (3) request the assistance of Toronto Police Service Traffic Services Division, in developing and implementing the Sidewalk Riding Counter Measure: A Bicycle Safety Education Plan program.

9.9 P. S. Kensington Working Group

The Toronto Pedestrian Committee consideration communication from Michael Rosenberg, Treasurer, P.S. Kensington Working Group (December 15, 2005) requesting that the Pedestrian Committee recommend that the City of Toronto budget include an allocation for the City to provide logistical support such as

barricades, signage, pylons, paid duty police, etc. for pedestrian events to support seven pedestrian events days in Kensington Market in the summer of 2006.

On motion by Crawford Murphy, the Toronto Pedestrian Committee recommended to Works Committee that City Council commit an allocation to provide logistical support such as barricades, signage, pylons, paid duty police, etc. for holding Pedestrian events, for seven days in Kensington Market in the summer of 2006 and to secure funding through the 2006 Operating Budget for Transportation Services.
