Confirmation of Minutes

On motion by Councillor Giambrone, the Minutes of the meeting of the Works Committee held on June 29, 2005, were confirmed.

7.1 Presentation on the Status of Rain Damage Resulting from the August 19, 2005, Storm

The Works Committee received a Power Point presentation by Michael D'Andrea, Director of Water Infrastructure Management, Toronto Water, and Roberto Stopnicki, Director of Transportation Services, North York District on the effects and status of rain damage resulting from the August 19, 2005, storm.

The Works Committee also considered communications from the following:

- (September 1, 2005) from Councillor Mike Del Grande, Ward 39, Scarborough-Agincourt, respecting the large numbers of basement floodings in Scarborough and North York as a result of the severe rainstorm on August 19, 2005; indicating that Council on July 20, 2004, in adoption of Works Committee Report 6, Clause 11, entitled "Basement Flooding in the Area of the Lower Beaches and Ashbridges Bay Due to the August 14, 2003 Electrical Power Outage", allowed affected property owners to claim up to \$3,050.00 under the Basement Flooding Protection Subsidy Program; that the circumstances between the August 14, 2003, Electrical Power Outage and the August 19, 2005, rainstorm are sufficiently similar to warrant affording the same consideration to the residents of Scarborough and North York as was extended to the residents of the former City of Toronto under the same terms and conditions, including the aggressive communication strategy; and
- (September 13, 2005) from Councillor John Filion, Ward 23, Willowdale, respecting flooding damage to basements across the City resulting from the August 19, 2005, rain storm; requesting that the Works Committee recommend to Council that the "no fault" grant be reinstated for those who have experienced sewer back-up into their homes; and further requesting that the Committee amend the criteria for eligibility for the grant program approved by Council following the May 2001 flooding for the installation of a backwater valve in homes which were flooded during the storm.

 - (a) City Council reinstate the Basement Flooding Protection Subsidy Program, referred to in Report 6, Clause 11 of the Works Committee, entitled "Basement Flooding in the Area of the Lower Beaches and Ashbridges Bay Due to August 14, 2003 Electrical Power Outage", adopted by City Council on July 20, 21 and 22, 2004, and that the criteria outlined in this Clause on sewer back-up be utilized for all properties that were flooded as a result of the August 19, 2005 rainstorm; and further that the work plan for this Program include:
 - sending letters and an information brochure to the affected residents outlining the benefits of the program;
 - advertising in the local community newspapers;
 - a fact and information sheet the Councillors may include in their regular correspondence with their constituents;
 - each document contain a reference as to how to obtain the information in various languages;
 - the information be posted on the City's web site and provided to Toronto Water, other appropriate Works and Emergency Services staff, and Access Toronto; and
 - applications be on a first come, first served basis with a December 1, 2005 cut-off;

(b) City Council reinstate the "no fault" grant to those who have experienced sewer back-up in their homes, as a result of the August 19, 2005, rain storm; and

(Motion by Councillor Carroll, on behalf of Councillor Filion)

(c) the appropriate staff be directed to undertake an engineering review of the affected flood damaged areas, that the review

include proposals to speed up the Wet Weather Flow Master Plan, specifically dealing with, but not limited to, the Downspout Disconnection Program, and that the appropriate staff report thereon to the Works Committee.

(2) requested Deputy City Manager, Fareed Amin, to provide the Policy and Finance Committee for its meeting on September 20, 2005, with an issues management overview of the initial flood response and continued response;

7.3 New Street Name Signs (All Wards)

The Works Committee considered a report (August 30, 2005) from the General Manager, Transportation Services responding to the request of the Works Committee on June 29, 2005, to report further on necessary modifications to the new street name signs to allow the introduction of the names of communities to be included on the signs.

- (1) the new street name sign design outlined in attached "Appendix A", including shape, size, font, letter height and reflectivity be confirmed as the design for all street name signs within the City of Toronto; and
- (2) where the name of a community is included in the street name sign, its placement within the street name sign be in accordance with the design outlined in attached "Appendix B".

7.4 Supply and Delivery of Rock Salt During the 2003-2004 and 2004-2005 Winter Season – Tender Call 64-2003

The Works Committee considered a report (June 22, 2005) from the Acting General Manager, Transportation Services and the Treasurer requesting authority to increase the overall value of Contract 47008166 for the supply and delivery of rock salt for expenditures incurred during the 2003-2004 and 2004-2005 winter seasons.

- (1) Contract 47008166, Tender 64-2003, with Canadian Salt Company Ltd. for the supply and delivery of rock salt in Toronto and East York, North York and Scarborough Districts, from August 2003 to April 2005, be amended to permit an increase in payment under the Contract from \$12,358,691.20 to \$13,500.000.00 including all charges and applicable taxes, under the same terms and conditions;
- (2) additional funds up to \$1,141,308.80 to cover the supply and delivery of salt in the three Districts be provided from the Winter Control Stabilization Reserve to Cost Centres TP0108 and TP0120, TP0189 and TP0216, in the event the increase cost cannot be accommodated within the Transportation Services Division's 2005 Operating Budget; and
- (3) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto including the introduction in Council of any Bills that may be required.

- (1) the existing publication or newsvending by-laws/code chapters, including their respective schedules, of the former municipalities be consolidated and new provisions be added to Municipal Code Chapter 743, Streets and Sidewalks, Use of, for the uniform regulation of dispensing boxes, units and kiosks;
- (2) authority be granted to submit any Bills required to enact the new code provisions pertaining to publication dispensing boxes, units and kiosks, generally in accordance with Appendix A of this report, subject to any necessary refinements as may be identified by the General Manager, Transportation Services and the City Solicitor;
- (3) the existing provisions in the sections of the by-laws/code chapters of the former municipalities as set out below, and any other provisions that may be identified that relate to or have been superseded or replaced by new code provisions, be repealed or amended as necessary:
 - By-law No. 1-87, Newspaper Boxes (East York);
 - By-law No. 3727-80 amending By-law No. 3343-79 (Section 3A), respecting Streets (York);
 - By-law No. 11683, Newspaper Boxes (Scarborough);
 - By-law No. 31680, Newspaper Vending Boxes (North York);
 - Municipal Code Chapter 171, Newspapers (Etobicoke); and
 - Municipal Code Chapter 313, Street and Sidewalks, § 313-44 (Toronto);
- (4) the City Solicitor, in consultation with the General Manager, Transportation Services, be authorized and directed to make application to the Ministry of the Attorney General for set fines with respect to the above-noted proposed code provisions, in the amount of \$500.00 per offence;
- (5) the funding and resources arrangements pertaining to administering, co-ordinating and organizing publication vending box issues to be considered as part of the 2006 budget process; and
- (6) the appropriate City officials be authorized and directed to take the necessary action to give effect to the foregoing, including the introduction in Council of any Bills that may be required.

7.9 Feasibility of Installing Traffic Control Signals at Brimley Road and Fraserton Gate/Shediac Road (Ward 38, Scarborough Centre)

- (c) for the post-construction services, an amount not to exceed \$78,685.00, including disbursements and GST, and including a contingency allowance of \$9,246.00, including GST for additional services, if necessary and authorized by the Executive Director, Technical Services;
- (4) this report be forwarded to Policy and Finance Committee for consideration; and
- (5) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

7.41 Streetcar Right-of-Way on Fleet Street Modification to Environmental Assessment

The Works Committee considered a communication (September 2, 2005) from the General Secretary, Toronto Transit Commission, advising that the Commission, at its meeting on

August 31, 2005, considered a report, entitled "Streetcar Right-of-Way on Fleet Street - Modification to Environmental Assessment", and adopted the following Recommendations 1 and 3:

- "1. Request that the City of Toronto:
 - (a) endorse the modification to the environmental assessment for the Waterfront West Light Rail Transit Line, as described in the attached report, to allow the implementation of a reserved right-of-way for streetcars on Fleet Street when the tracks on that roadway are reconstructed in 2006; and
 - (b) request that the Ministry of the Environment permit the modification to the original environmental assessment, as described in the attached report"; and
- "3. Forward this report to the City of Toronto Works Committee and Deputy Mayor Pantalone";

and noting that Recommendation 2 was amended to read as follows:

- "2. Advise the Ontario Ministry of the Environment and Toronto Council that a streetcar right-of-way on Fleet Street:
 - (a) is preferred over the original approved alignment for a streetcar right-of-way in the middle of Lake Shore Boulevard;
 - (b) will replace the only section of the 509 HARBOURFRONT streetcar line that is still operating in mixed-traffic and will protect service on that route, and on the corresponding section of 511 BATHURST streetcar route, from traffic delays resulting from major events at Exhibition Place and from the future developments planned in this area;
 - (c) is estimated to cost roughly \$3 million over and above the cost of simply reconstructing the existing 800 metres of streetcar tracks on Fleet Street; and
 - (d) is already included in the secondary plan for the Central Waterfront area and, therefore, has already been endorsed in principle by City Council;".

On motion by Councillor Giambrone, the Works Committee:

(i) recommended that City Council:

(A) adopt Recommendations 1(a) and (b) of the Toronto Transit Commission, contained in the communication (September 2, 2005) from the General Secretary; and (B) adopt the following motion: "WHEREAS the TTC is proposing to build a dedicated streetcar line on Fleet Street between Strachan Avenue and Bathurst Street: and WHEREAS the Fort York Neighbourhood north of Fleet Street is being developed as a new residential neighbourhood; and WHEREAS the function of Fleet Street will change to more of a local road; and WHEREAS traffic volume eastbound on Fleet Street between Bastion Street and Grand Magazine Street has been projected to be approximately 21-25 cars per hour at peak hours and is not expected to increase in the future, indicating that this section of eastbound Fleet Street could be eliminated; WHEREAS it is desirable to maximize the amount of public space adjacent to Fleet Street which will be available for landscaping and aesthetic improvements; WHEREAS, if a portion of Fleet Street was eliminated, lands could be added to Gore Park that would benefit the park and trees could be saved: NOW THEREFORE BE IT RESOLVED THAT the report, titled "Streetcar Right-of-Way on Fleet Street - Modification

titled "Streetcar Right-of-Way on Fleet Street – Modification to Environmental Assessment," be amended to incorporate the permanent closing, as public highway, of the eastbound section of Fleet Street, from Fort York Boulevard to the Lake Shore Boulevard West/Fleet Street "cross-over" and these lands be incorporated into the adjacent park lands, subject to compliance with the *Municipal Act, 2001*, and:

(1) the jurisdiction of the public highway lands be transferred to the Parks, Forestry and Recreation Division;

- (2) notice be given to the public of a proposed by-law to permanently close the public highway lands, in accordance with the requirements of Chapter 162 of the City of Toronto Municipal Code, and the Toronto and East York Community Council hear any member of the public who wishes to speak to this matter during consideration of the draft By-law;
- (3) following the closure of the public highway lands, appropriate easements be granted in favour of any public utility company over the public highway lands for access, operation, use, inspection, repair, maintenance, reconstruction or alteration of any existing services and for the construction of additional or new services; and
- (4) the appropriate City officials be authorized and directed to take the necessary action to give effect to the foregoing, including the introduction in Council of any bill necessary to give effect thereto;

AND FURTHER BE IT RESOLVED THAT the westbound lane from Bastion Street to Iannuzzi Street, which is currently proposed as being 5.0 metres in width be revised to 4.0 metres in width."; and

(ii) requested the General Manager, Transportation Services to report directly to City Council for its meeting on September 28, 2005, on whether there are any implications to the roadway alterations.
