8.1 Environment Days Date Selection Discussion Results and Increasing the Number and Hours of Operation of Environment Day Events

8.2 Biodegradable Plastic Bags for Organic Material

The Works Committee considered a report (September 29, 2005) from the Acting General Manager, Solid Waste Management Services responding to the request of the Works Committee on April 27, 2005, to report on the issue of biodegradable bags including the potential use of biodegradable plastic bags for organic material collection.

Recommendation:

It is recommended that this report be received for information.

Michael Rosenberg appeared before the Works Committee.

On behalf of Councillor Balkissoon, Councillor De Baeremaeker moved that the City of Toronto proceed with a pilot program to test the use of biodegradable bags for leaf and yard waste at approximately 1,000 homes in the Spring of 2006, subject to:

- (1) the Acting General Manager, Solid Waste Management Services inviting the manufacturers of biodegradable bags to participate in this pilot by making a contribution to offset the estimated City costs by:
 - (a) supplying up to two types of biodegradable plastic bags to a maximum of 50,000 bags;
 - (b) conducting resident surveys (approximate value \$10,000.00); and

- (c) hiring a consultant to monitor and analyze the performance of the bags (approximately \$10,000.00);
- (2) the hiring of all consultants and final selection of bags being under the direct and independent control of the Acting General Manager, Solid Waste Management Services, in consultation with biodegradable bag manufacturers; and
- (3) the remaining projected City costs of the pilot, approximately \$37,000.00, being added to the new initiatives portion of the 2006 Solid Waste Management Services Operating Budget submission for consideration by the Budget Advisory Committee and City Council during the Budget Process,

which did not carry.

8.4 Results of the 2005 Litter Audit

The Works Committee considered the following reports:

8.5 Bicycle Lane Guidelines and Royal York Road Pavement Marking Options (All Wards)

The Works Committee considered the following:

(i) Report (September 26, 2005) from the General Manager, Transportation Services responding to various requests by City Council, North York Community Council and the Works Committee on design options for bicycle lanes and signed bicycle routes.

Recommendations:

It is recommended that:

- (1) City Council endorse a minimum bicycle lane width of 1.5 metres on roads with curbs, and 1.2 metres on roads without curbs;
- (2) Royal York Road between Mimico Creek and Usher Avenue be marked with shared use lane markings, as illustrated in Figure 1, as a pilot project; and
- (3) the appropriate City officials be authorized to take the necessary action to give effect thereto.
- (ii) Communication (August 9, 2005) from the Toronto Cycling Committee advising that the Committee on July 18, 2005, in accordance with the Council direction in Works Committee Report 5, Clause 1 (May 17, 18, and 19, 2005) recommended that:
 - (1) Royal York Road, between Mimico Creek and Usher Avenue, be marked using shared-lane markings, as a pilot project;

- (2) the use of an edge-lane marking on Royal York Road, between Mimico Creek and Usher Avenue, or as a method to mark a bicycle lane, not be used; and
- (3) the Toronto Cycling Committee reiterate to the Works Committee that the minimum width of a bicycle lane should be 1.5 metres and that bicycle lanes are the preferred option regarding bike route pavement markings.
- (iii) Confidential report (September 27, 2005) from the City Solicitor responding to the request of the Works Committee on April 27, 2005, to report on the legal and risk factors associated with marking the edge line on Royal York Road between Mimico Creek and Usher Avenue.

Recommendations:

8.6 Cycling Conditions and Construction Project

The Works Committee considered a communication (September 27, 2005) from the Toronto Cycling Committee advising that the Committee on September 19, 2005, considered minutes of the Bikeway Network Sub-Committee meeting held on July 27, 2005, and a communication from Andrew Wood, and recommended that the Works Committee:

- (1) request City staff to:
 - (a) improve cycling conditions on the portions of Beverley Street and Dundas Street West affected by the Art Gallery of Ontario reconstruction; and
 - (b) report on the changes necessary to City policy and by-laws which would ensure that:
 - (i) private developers undertaking construction projects near existing bikeway network facilities ensure that those facilities are maintained

and remain open throughout the construction process; and

- (ii) when the nature of construction makes it impossible to maintain and/or keep open bikeway network facilities, a development surcharge be levied based on the length of bikeway network impacted and that any revenue raised be used to either construct a temporary (but equally safe detour) or be used for construction of additional cycling facilities elsewhere in the City; and
- (2) adopt the following Resolution from Andrew Wood, Member, Toronto Cycling Committee:

"WHEREAS Bike Route No. 35 is one of the City's main north-south cycle routes and is heavily used by cyclists; and

WHEREAS conditions along the route have been severely compromised by construction at the AGO, construction and road maintenance within the University of Toronto campus and by the lack of enforcement of no-stopping by-laws along the portion of the route within the University of Toronto campus; and

WHEREAS the Corporation of the City of Toronto was recently found partially liable for failure to maintain a signed cycling route on Queen Street West;

THEREFORE BE IT RESOLVED THAT the Works Committee request City staff to undertake a complete safety audit of Bike Route No. 35 between Bloor Street and the route's terminus at Queen Street West; and

BE IT FURTHER RESOLVED THAT if the route is found to be less than safe, City staff be requested to propose a list of possible remediation measures, including, but not limited to, road resurfacing, detours and education of drivers."

On motion by Councillor Giambrone, the Works Committee referred the communication from the Toronto Cycling Committee to the General Manager, Transportation Services for a report to the Works Committee.

8.7 The Use and Regulation of Segways

The Works Committee considered a report (September 8, 2005) from the City Solicitor responding to the request of the Works Committee on April 27, 2005, to report on the use and regulation of Segways in Ontario and other jurisdictions; concluding that:

- (i) the Segway is encompassed within the definition of motor vehicle as found in Ontario's Highway Traffic Act and, according to the Ontario Ministry of Transportation and pursuant to the Act, may not legally operate on a highway in Ontario; and that a highway would include the sidewalk or footpath where the sidewalk or footpath falls within the road allowance; and
- (ii) the Segway would fall within the definition of "vehicle" as found in Municipal Code Chapter 608, Parks, and pursuant to this Chapter currently may be operated on parks' roadways and parking areas that are not public highways, but not in any other area of the park unless authorized by permit.

WHEREAS Councillor Saundercook did a ten-day pilot project to test the integration of the Segway on the sidewalks with pedestrians;

WHEREAS the City of Toronto faces pollution problems due in part to the high number of vehicles on the City's roads and that the Segway could encourage less dependence on cars;

WHEREAS Councillor Saundercook as a member of the Pedestrian Committee presented his findings and recommendations on the pilot project, and lost in a six to four vote;

NOW THEREFORE BE IT RESOLVED THAT the Works Committee recommend to City Council that Segways be permitted on the sidewalks of Toronto for a one year test period;

AND BE IT FURTHER RESOLVED THAT it be understood that pedestrians do have and always will have the right of way.",

which did not carry.

Councillor De Baeremaeker moved that the Acting General Manager, Transportation Services be requested to evaluate the Segway Product including "on street" trials and further requested that he report to the Works Committee on the role Segways could play in reducing traffic congestion, gasoline consumption and air pollution, which was declared redundant.

8.9 Draft Terms of Reference for the Peer Review of the Biosolids and Residuals Master Plan Decision Making Model

The Works Committee considered a report (September 28, 2005) from the Acting General Manager, Toronto Water and the Medical Officer of Health responding to the request of the Works Committee on March 8, 2005, that a peer review be undertaken of the Biosolids and Residuals Master Plan methodology and weighting scale used to determine the recommended residuals and biosolids management options and strategies for the City's water and wastewater treatment plants.

Recommendations:

It is recommended that:

- (1) authority be granted to the General Manager of Toronto Water, working together with the Medical Officer of Health, to issue a Request for Proposal (RFP) in accordance with the confidential draft Terms of Reference, for the hiring of a facilitator, and to engage the services of a panel of experts to undertake a peer review of the decision making model used in the Biosolids and Residuals Master Plan; and
- (2) this report be forwarded to the Board of Health for information.

The Works Committee also considered a communication (October 7, 2005) from Councillor Paula Fletcher, Ward 30, Toronto-Danforth, expressing concern that the Biosolids and Residuals Master Plan focuses solely on agricultural uses to the exclusion of other non-agricultural options; and requesting that the Terms of Reference for the Peer Review be expanded to include an analysis of why this omission occurred and a solution for remedying the problem.

8.10 Amendments to the Toronto Municipal Code Chapter 681 – Sewers, Article 1, Sewage and Land Drainage (Sewer Use By-law No. 457-2000) – Designation of Best Management Practices Documents and Revised Pollution Prevention Plan for Certain Industries (All Wards)

The Works Committee held a public meeting on October 11, 2005, in accordance with the Municipal Act, 2001, and notice of the proposed enactment of the draft by-law was posted on the City's web site for a minimum of twenty-one days.

The Works Committee considered a report (September 26, 2005) from the Acting General Manager, Toronto Water respecting a number of amendments to the Toronto Municipal Code Chapter 681 – Sewers, Article I, Sewage and Land Drainage (Sewer Use By-law No. 457-2000), and the need to adopt a Best Management Practices (BMP) process with respect to pollution prevention planning for certain industries. Recommendations:

It is recommended that:

(1) Municipal Code Chapter 681- SEWERS, ARTICLE I- Sewage and Land Drainage (the "By-law"), be amended as specifically set out in Appendix "A" to this report;

- (2) the General Manager of Toronto Water be authorized to implement the Best Management Practices (BMP) Program as described in this report and grant exemptions from the discharge and concentration limits in the By-law in accordance with the BMP program using the guidelines set out in this report, and to implement the BMP program, that Council authorize and approve the Best Management Practices (BMP) documents, attached as Appendix "B", for facilities in the automotive service sector: Automotive Repair Operations, Vehicle Wash Operations, and Petroleum Facilities:
- (3) the Pollution Prevention Plan and Plan Summary form, attached as Appendix "C", be designated for use by the Automotive Service Sector;
- (4) the Pollution Prevention Plan and Plan Summary form, attached as Appendix "D", be designated for use by the Dry Cleaning sector; and
- (5) the appropriate City officials be authorized to introduce the necessary bills to Council to implement the recommendations.

On motion by Councillor De Baeremaeker, the Works Committee recommended that City Council adopt the staff recommendations in the Recommendations Section of the report (September 26, 2005) from the Acting General Manager, Toronto Water.

8.13 Parking for Motorized Scooters and Motorcycles – Motion J(2)

The Works Committee considered the following communication and report:

(i) (October 3, 2005) from the City Clerk advising that City Council on September 28, 29 and 30, 2005, referred the following Motion J(2) by Councillor Ootes, seconded by Councillor De Baeremaeker, to the Works Committee:

"WHEREAS the City of Toronto should do all it can to encourage its residents to use environmentally-friendly modes of transportation, and not penalize them; and

WHEREAS Canada is committed to the Kyoto protocol; and

WHEREAS Torontonians are being urged to do their part in the federal government's One-Tonne Challenge (Canada to reduce our annual greenhouse gas emissions by one tonne); and

WHEREAS the definition of 'motorcycle' under the *Ontario Highway Traffic Act*, means 'a self-propelled vehicle having a seat or saddle for the use of the driver and designed to travel on not more than three wheels in contact with the ground, and includes a motor scooter, but does not include a motor assisted bicycle'; and

WHEREAS motorcycles, as defined in the *Ontario Highway Traffic Act*, use up to 90 percent less gasoline than a regular car or truck; and

WHEREAS motorcycles are significantly smaller than other vehicles, use far less road space, thus helping to reduce gridlock, and occupy less parking space when parked at an angle to the curb; and

WHEREAS many City of Toronto Councillors are on record as being opposed to any type of state-of-the-art incineration methods to deal with our garbage, such as those used in European countries; and

WHEREAS many of these same Councillors opposed the City sending our garbage to Kirkland Lake; and

WHEREAS the Mayor of Toronto has repeatedly stressed the need for Toronto City Council to operate in an open and transparent manner, to benefit the citizens of our City; and

WHEREAS the Mayor of Toronto has spoken about his belief that 'every elected official in every government must have a personal and professional commitment to honesty, transparency, and responsibility'; and

WHEREAS the Mayor of Toronto has spoken about the need to undertake a governance review to make Councillors and Committees more accountable, and work to improve and increase the information we provide to the public about business at City Hall; and

WHEREAS the Chair of the City's Works Committee was recently quoted as saying that a 'confidential contingency plan' exists, should Michigan close its border to our garbage; and

WHEREAS the City's impending garbage disposal crisis is of great importance to Toronto's residents; and

WHEREAS Toronto citizens have a right to know what contingency plans have been made, should Michigan ever refuse to accept our garbage;

NOW THEREFORE BE IT RESOLVED THAT the Chair of the Works Committee bring forward a report to the October 26, 2005 meeting of City Council, that outlines the details of this 'confidential contingency plan' and make it a matter of public record;

AND BE IT FURTHER RESOLVED THAT the Works Committee ensure that the public is given an opportunity to make deputations regarding this garbage disposal contingency plan, at the earliest opportunity."

- (2) a staff briefing note on the feasibility of conducting a mandatory downspout disconnection program and the benefits that a downspout disconnection program would bring to the City, such report to include one scenario where the City could adopt an 11-year cycle that would disconnect the downspouts in four wards per year for eleven years;
- (3) a staff briefing note on the feasibility of providing a second green bin free to homes that have either basement apartments and/or large families and/or are keen recyclers; and
- (4) a staff briefing note on the feasibility of permitting Councillors to have additional free compost days for local residents.

WHEREAS the Pedestrian Charter underscores the importance of pedestrian access in the environmental, safety, and economic well-being of our City; and

WHEREAS the Martin-Goodman Trail, on Toronto's waterfront, currently provides the only pedestrian access for several hundred employees who work along Toronto's waterfront; and

WHEREAS there is currently no snow clearing on the Martin Goodman Trail despite the large number of pedestrians and cyclists who need this route to get to work; and

WHEREAS the City is in receipt of a petition signed by dozens of these employees, requesting such access (attached);

NOW THEREFORE BE IT RESOLVED THAT the General Manager, Transportation Services report to the next Works Committee on the feasibility and cost (if any) of adding the stretch of the Martin Goodman Trail between the Roncesvalles Pedestrian Bridge and Dowling Avenue Pedestrian Bridge to the sidewalk snow removal program for 2006;

AND BE IT FURTHER RESOLVED THAT the report also consider the cost (if any) of adding the City's entire off-street cycling network to the sidewalk snow removal program;

AND BE IT FURTHER RESOLVED THAT this report be forwarded to the City of Toronto Pedestrian Committee, Cycling Committee and local City Councillors for information."

On motion by Councillor De Baeremaeker, the Works Committee referred the following items to the appropriate staff with a request that they submit briefing notes to the Works Committee for consideration during the 2006 budget process:

- (a) item (1) in the communication from Councillor De Baeremaeker to the General Manager, Parks, Forestry and Recreation;
- (b) item (2) in the communication from Councillor De Baeremaeker to the Acting General Manager, Toronto Water;

- (c) item (3) in the communication from Councillor De Baeremaeker to the Acting General Manager, Solid Waste Management Services; and
- (d) the motion in the communication from Councillor Palacio to the General Manager, Transportation Services.
