1. Request for Proposals 9117-05-7457 - Engineering Services for New HVAC Systems in Old City Hall

Report (January 16, 2006) from the Acting Director of Purchasing and Materials Management, advising on the results of the Request for Proposals (RFP) 9117-05-7457 for the provision of engineering services for the new Heating, Ventilation and Air Conditioning (HVAC) Systems in Old City Hall, and requesting authority to enter into an agreement with the recommended proponent.

Recommendation:
