Report (May 24, 2006) from the Executive Director of Technical Services and the Manager of Goods and Services, Purchasing and Materials Management, advising on the results of the Tender issued for reconstruction of pavement, curb and sidewalk on Eastern Avenue from Woodfield Road to Coxwell Avenue and asphalt resurfacing from Lewis Avenue to Carlaw Avenue, in accordance with specifications as required by Technical Services, and requesting authority to award a contract to the recommended bidder.

Recommendation:
