Action taken by the Committee:

 - (ii) request the General Manager, Transportation Services, in consultation with the Toronto Police Service, to report to the Works Committee on an education and enforcement programme aimed at drivers to reduce the incidence of drivers illegally driving and/or parking in bicycle lanes; and
- (2) referred the communication (March 30, 2006) from Bradford Hovinen back to the Education and Safety Sub-committee and requested that they create a budgetary

request for mandatory cycling education safety for students in Grades 6 to 8, in Toronto.

Action Taken by the Committee:

The Toronto Cycling Committee:

- (1) requested that the City Clerk invite the Toronto Public Space Committee and the Toronto Youth Cabinet to send a representative to the May 15, 2006 meeting of the Toronto Cycling Committee to give a presentation about their respective Committees if their organizations are interested in membership on the Toronto Cycling Committee;
- (2) requested the City Clerk to include the Toronto Cycling Committee's Terms of Reference with the invitation;
- (2) received Recommendations (1) and (3) contained in the Promotions Subcommittee minutes dated March 22, 2006; and

(3) received the remainder of the Promotions Sub-committee minutes dated March 22, 2006.

Promotions Subcommittee minutes dated March 22, 2006 and providing the following recommendations for consideration:

- (1) Recommends that the members of the Toronto Cycling Committee attend all four City of Toronto Bike Week Media Events at the following locations the Etobicoke CC, the North York CC, the Scarborough CC and the East York CC; and members are encouraged to attend all the community organized events during Bike Week.

8(c). Bikeway Network Sub-committee

Action Taken by the Committee:

The Toronto Cycling Committee:

(1) adopted the following resolution:

Whereas the Toronto Waterfront Revitalization Corporation is conducting a design competition for the Central Waterfront that includes the completion of the Martin Goodman Trail through the central waterfront area and the re-design of Queens Quay; and Whereas creating continuous cycling routes through the waterfront are an important element of implementing the Toronto Bike Plan;

Now therefore be it resolved that the City of Toronto support the initiative to complete the missing section of the Martin Goodman Trail; and

Be it further resolved that the City of Toronto support the inclusion of on-street bike lanes on Queens Quay from Spadina Road to Yonge Street to ensure continuous on-street bike lanes along the length of Queens Quay, and that the City undertake any work and approvals necessary for the bike lanes to be included as part of the design of Queens Quay;

- (2) recommended that a copy of the resolution be sent to the General Manager, Transportation Services; and
- (3) received the Bikeway Network Sub-committee minutes dated March 29, 2006.

8(d). Cycling and Transit Working Group

Action Taken by the Committee:

The Toronto Cycling Committee:

- (1) adopted the following recommendations:
 - (i) that the City of Toronto's Bicycle Locker Pilot Project include lockers on Toronto Transit Commission property to provide secure bicycle parking close to public transit thereby encouraging the use of bicycles in combination with public transit; and
 - (ii) that the following be recommended with regard to the Don Mills Road Transit Improvement Study:
 - (a) that transit vehicles servicing the Don Mills route be equipped to accommodate bicycles with equipment such as bike racks on buses and/or streetcars; and
 - (b) that the Bikeway Network subcommittee review this project with respect to bike lanes on the Don Mills route;
- (2) adopted and endorsed the following:

that the following "General Recommendations regarding Public Transit Projects" be adopted by the Toronto Cycling Committee for the purpose of commenting on proposed public transit developments or improvements:

- (i) for transit station projects:
 - (a) clear signage is provided to indicate the location of cycling facilities;
 - (b) a Bike Station is provided (bicycle rental, repair, supervised parking, showers, etc.);
 - (c) a BikeShare Hub is provided within the station or in close proximity;
 - (d) options for short-term and long-term bicycle parking are provided for customers and employees;
 - (e) Secure bicycle parking is provided at all entrances to the station;
 - (f) Sidewalk cut-outs are provided for pull-ins at bicycle parking locations;
 - (g) adequate space is provided for motorists to pull over and let out passengers without obstructing a bicycle lane or route;
 - (h) ramps or "bicycle channels" are provided on stairs surrounding or within the station to improve access to the station and platforms; and
 - (i) new bicycle lanes and routes are provided in the surrounding area to provide cyclists with safer access to the station
- (ii) for transit vehicles:
 - (j) transit vehicles accommodate bicycles on board at all times;
- (iii) for transit corridor projects:
 - (k) access for cyclists is accommodated at all crossings;
 - (l) any new bridges/underpasses include bicycle lanes; and
 - (m) a bicycle trail is created, which runs parallel to the transit corridor;
- (3) deferred the following recommendation to the next meeting of the Toronto Cycling Committee to be held on May 15, 2006, and requested that the Cycling and Transit Project Organizer, Transportation Planning provide the Powerpoint slides from the

presentation given to the Union Station Public Advisory Group on March 20th, 2006 regarding possible bicycle facilities at Union Station:

That a "Type 3" bicycle station that includes showers, change rooms, bicycle oriented retail and services and transit information centred around a staffed, "valet" parking structure be implemented at Union Station; and

(4) received the remainder of the Cycling and Transit Working Group minutes dated April 11, 2006.

Cycling and Transit Working Group minutes dated April 11, 2006 and providing the following recommendations:
