Subject: August 19, 2005 Storm Damage Update

(All Wards)

Purpose:

To report on damage to Parks, Forestry and Recreation infrastructure as a result of the August 19, 2005 storm and reallocate \$1,200,000.00 in funds within the approved 2006 Parks, Forestry and Recreation Capital Budget to undertake essential repairs in 2006.

Financial Implications and Impact Statement:

Current estimates place the cost of repairing the bridges, parking lots and trails damaged in the August 19, 2005 storm at \$4,735,967.00. This does not include repairs already undertaken or replacement or repair to other park features such as benches or drinking fountains that may have been washed away; or to other features or amenities that may have been damaged and not yet identified or inventoried. Of this \$4,735,967.00, \$1,000,000.00 relates to funds required for the removal of damaged and fallen trees from ravines and watercourses, which must be funded through future Operating Budget allocations. The balance relates to Capital items.

No funding was approved in either the 2006 Operating or 2006 Capital Budget to undertake storm damage repairs. No funding has been included for 2005 storm damage in the proposed 2007 – 2010 Capital Plan for Parks, Forestry and Recreation. To maintain the corporate debt target, reallocation and deferral of other planned projects within the Capital Plan would be required to accommodate this work. It is anticipated that storm damage impacts will be submitted for consideration during Budget Advisory Committee's review of the 2007 - 2011 Capital Plan and the 2007 Operating Budget.

The Parks Branch has identified two parks, Edwards Gardens and Highland Creek/Colonel Danforth Park, which have sustained extensive damage to bridges and stream embankments. A further 102 bridges and 168 different locations in parking lots and paths have been damaged and require repair. In light of the essential nature of these repairs, Parks, Forestry and Recreation are seeking authority to reallocate \$1,200,000.00 in funds within the approved 2006 Capital Budget

to undertake this work. Replacement of these funds will be requested in the 2007 Capital Budget submission. A chart setting out the total costs of the storm, expenditures to date and outstanding costs is contained in Attachment 1.

The Deputy City Manager and Chief Financial Officer has reviewed this report and concurs with the financial impact statement.

Recommendations:

It is recommended that:

- (1) funds in the amount of \$1,200,000.00 be reallocated within the approved 2006 Parks, Forestry and Recreation Capital Budget as set out in Attachment 2 to undertake essential repairs to damaged infrastructure in 2006;
- (2) the financial impacts of the storm related damage funding requests for 2007 be included in the 2007 2011 Capital Plan submission and the 2007 Operating Budget submission from Parks, Forestry and Recreation for consideration by BAC;
- (3) this report be forwarded to Policy and Finance Committee for consideration; and
- (4) the appropriate City Officials be authorized and directed to take the necessary action to give effect thereto.

Background:

On Friday August 19, 2005, a severe storm passed through the Greater Toronto Area. In a relatively short time span of two to three hours, rainfalls in excess of 100 millimetres were recorded at various Environment Canada and City of Toronto rain gauge stations throughout the City. The high rate of precipitation resulted in many flash floods of rivers, creeks and ravines, in which water quickly overflowed the stream banks. The high stream flows and large volumes of runoff, caused erosion of many watercourse banks, destroyed vegetation and damaged many structures in City parks and ravines.

Numerous bridges, paths and parking lots sustained damage. Debris hitting the bridges and erosion caused by rushing water affected the structural integrity of many of the bridges, with some bridges being washed away completely. Damage to parks was not just limited to bridges, parking lots and paths; hundreds of trees were downed or remain standing in unsafe conditions; playground locations had the base sand washed away, making the playground unsafe; drinking fountains and benches were washed away; and many riverbanks and sodded areas were ripped up or remain littered with the debris washed downstream.

Subsequently, the majority of the parks and facilities have been inspected, with all bridges, parking lots and paths undergoing detailed assessment and safety audits by consultants retained by the Parks, Forestry and Recreation Division at a cost of \$130,000.00. The audits, in the fall of 2005 and the spring of 2006, were carried out using the assessment protocol used in the

Divisional State of Good Repair Program which forms the basis for the development of the 5 - Year Capital Budget Program. The primary focus of the safety audits is to determine whether the features are structurally unsafe and should be closed until such time as repairs are implemented or whether they can be used safely in their current condition or after minor repairs are completed.

Damage to Morningside Park Service Yard in the Scarborough District was extensive and is estimated at \$3,000,000.00. Twelve service vehicles and grass cutting equipment were damaged. The flood, combined with the sewage that spilled into Highland Creek, damaged the office and storage area, ruining equipment, computers, furniture, and supplies, including ten skids of fertilizer.

This report identifies the type and cost of repairs carried out to date, provides estimates of the work that remains outstanding and prioritizes that work.

Comments:

Immediately after the storm, Parks, Forestry and Recreation began to inventory and assess the costs of repairing or replacing assets damaged or lost in the storm. The Division also began making repairs in 2005 where practical, using existing operating funds or funds available within existing Divisional blanket work order contracts. Using the templates developed by Finance, the Division, through the hiring of engineers to undertake detailed audits, started rolling up the costs of work done immediately after the storm, developing estimates of work to be done during the rest of 2005 and projecting costs extending into 2006. The total current assessment of costs necessary to repair the damage is \$8,760,101.00. This includes \$3,000,000.00 in Scarborough at the Morningside Yard, \$1,024,134.00 spent in 2005, \$3,735,967.00 in outstanding repairs, plus \$1,000,000.00 for forestry work.

The current outstanding repair costs of \$3,735,967.00 will be submitted as part of the 2007 Capital Budget. The costs of \$1,000,000.00 for forestry work to remove damaged trees will be submitted as part of the 2007 Operating Budget.

The reporting on the assessment of damage to parks infrastructure was delayed due to the necessity of completing detailed audits, re-checks in the spring of 2006 of an extensive amount of parkland to determine whether the winter conditions further impacted the damage, and waiting for responses regarding insurance claims.

The damage to the Morningside Yard was estimated at \$3,000,000.00. The majority of the damage was to the building and contents. Twelve service vehicles, including grass cutting equipment were damaged. Both the building and equipment are covered under the city insurance and is currently going through the claims process.

Immediately after the storm, Parks, Forestry and Recreation staff began implementing repairs necessary to eliminate situations where the health and safety of the public were at risk. Paths or trails that had eroded or washed out were filled and levelled to ensure that a firm surface was reestablished. Debris was swept from paved paths that had not been damaged and both Parks and Forestry staff cleared fallen limbs and brush that blocked pathways. Where funds were available

in blanket work order contracts, paving was undertaken to restore a consistent trail surface. During the remaining four months of 2005 after the storm, staff spent \$1,024,134.00 to make full repairs where possible or temporary repairs where necessary.

There is currently \$3,735,967.00 in repair work remaining to 102 bridges, 168 different sections of paths, trails and parking lots, plus \$1,000,000.00 in Forestry work necessary to remove damaged and fallen trees from ravines and watercourses. Parks, Forestry and Recreation is working closely with Toronto Water to prioritize repairs and obtain the necessary approvals from the Toronto and Region Conservation Authority, Ministry of Natural Resources and the Department of Oceans and Fisheries.

Of the remaining \$4,735,967.00, Parks, Forestry and Recreation has prioritized work and identified \$1,200,000.00 in projects that need to be undertaken in 2006. The Kissing Bridge at Edwards Gardens, the abutments that support it and part of the connecting paths were washed out completely and need full replacement. The Kissing Bridge is one of the most popular bridges for wedding photography in the city and is fully booked annually. Restoring this site and photography location is the highest priority for the Division. The estimated total cost to replace the bridge, install abutments and repair the connecting paths is \$100,000.00.

One of the key pedestrian bridges at Highland Creek/Colonel Danforth Park was already undergoing improvements in 2005 as part of the approved Capital Program with funding of \$400,000.00. The storm did additional damage estimated at \$350,000.00. Completing the work started in 2005 is the second highest priority and will require an additional \$350,000.00 on top of the \$400,000.00 approved in 2005.

\$591,920.00 is necessary for minor repairs to 168 different locations on paths, trails and parking lots. The majority of this work includes placing fill material such as gravel or soil, compacting it and paving it to re-establish uninterrupted paved pathways or filling holes in parking lots.

Two other parks, Wilket Creek Park and G. Ross Lord Park also suffered damage to main roads and specific bridges and will require \$158,080.00 in repairs.

In light of the essential nature of these repairs, Parks, Forestry and Recreation are seeking authority to reallocate \$1,200,000.00 in funds within the approved 2006 Parks, Forestry and Recreation Capital Budget to undertake this work. Replacement of these funds will be requested in the 2007 Capital Budget. A chart with the total costs of the storm, expenditures to date and outstanding costs is contained in Attachment 1.

It is essential to understand that the costs set out in this report only address those repairs which have been identified by staff and assessed by the consultants. It is expected that additional damage will be found as the parks dry out and staff and the public gain access to the farther reaches or inaccessible parkland and ravines. In late 2005, Forestry staff had identified over 250 damaged trees that needed to be removed and it is anticipated that this number will grow as they inspect deeper into the ravines. Parks, Forestry and Recreation has identified \$3,735,967.00 in repairs for 2007 and will continue inventory damage and estimate costs of repair or replacement. Requests for funding to undertake this work will be submitted as part of the 2007 Capital Budget State of Good Repair Program Report.

Conclusions:

The August 19, 2005 storm caused \$8.76 Million in damages to bridges, parking lots and paths; vehicles and structures in Morningside Yard; and created blockages in the parks and streams as a result of fallen trees and debris washed downstream. Immediately after the storm, staff from Parks and Urban Forestry began working to eliminate hazards to pedestrians and making repairs to paths and bridges to make them safe for use by the public. Over \$1.0 Million has been spent to date from within existing approved budgets to carry out this work, \$3.0 Million has been covered by insurance, leaving \$4.74 Million in outstanding repairs.

Essential funding of \$1,200,000.00 is required in 2006 to replace two key bridges, one in Edwards Gardens and one in Highland Creek and undertake repairs to numerous bridges, paths and parking lots. Funding will be reallocated within the 2006 approved Capital Budget to fund the repairs. Additional funds will be requested in the 2007 – 2011 Capital Plan submission and the 2007 Operating Budget submission from Parks, Forestry and Recreation for consideration by BAC.
