5.1 Request for Proposals 9117-05-7457 - Engineering Services for New HVAC Systems in Old City Hall

The Bid Committee considered a report (January 16, 2006) from the Acting Director of Purchasing and Materials Management, advising on the results of the Request for Proposals (RFP) 9117-05-7457 for the provision of engineering services for the new Heating, Ventilation and Air Conditioning (HVAC) Systems in Old City Hall, and requesting authority to enter into an agreement with the recommended proponent.

Recommendation:

It is recommended that authority be granted to award a contract to The Mitchell Partnership Inc., to provide engineering services for the new HVAC Systems Project in Old City Hall, at a cost of \$1,171,650 including all applicable taxes and charges.

Recommendation:

It is recommended that authority be granted to award a contract to Morosons Construction Ltd., at a cost of \$640,758.80 including all taxes and charges, for Pool Upgrades and HVAC Replacement at Norseman Indoor Pool, 105 Norseman Street, being the lowest quotation meeting specifications.

Recommendation:

It is recommended that Contract 06SC-06RD, Tender Call 253-2005, for the McLevin Avenue, Scarborough District, Major Road Resurfacing, be awarded to Furfari Paving Co. Ltd., in the amount of \$584,840.60, including all taxes and charges, being the lowest bid received.
