**Confirmation of Minutes**

On motion by Ralph Frebald, the minutes of the meeting of the Bid Committee held on March 8, 2006, were confirmed.

**11.1 Contract 06EY-03RD, Tender Call 259-2005 - Pavement Rehabilitation at Runnymede Road and Symington Avenue (Ward 13 - Parkdale-High Park and Ward 17 - Davenport)**

The Bid Committee considered a report (March 2, 2006) from the Executive Director of Technical Services and the Manager of Goods and Services, Purchasing and Materials Management, advising on the results of the Tender issued for Pavement Rehabilitation at Runnymede Road and Symington Avenue, in accordance with specifications as required by Technical Services, and requesting the authority to award a contract to the recommended bidder.

Recommendation:

It is recommended that Contract 06EY-03RD, Tender Call 259-2005, for Pavement Rehabilitation - Runnymede Road and Symington Avenue, be awarded to Il Duca Contracting Inc., in the amount of \$821,275.29, including all taxes and charges, being the lowest bid received.

**11.2 Contract 06EY-17WS, Tender Call 6-2006 - Watermain Replacements on Holmesdale Crescent from Ennerdale Road to Holmesdale Road and on Holmesdale Road from Dufferin Street to Ennerdale Road (Ward 17 - Davenport)**

The Bid Committee considered a report (March 7, 2006) from the Executive Director of Technical Services and the Acting Director of Purchasing and Materials Management, advising on the results of the Tender Call 6-2006, issued for Watermain Replacements on Holmesdale Crescent and Holmesdale Road, in accordance with specifications as required by Technical Services, and requesting the authority to award a contract to the recommended bidder.

Recommendation:

It is recommended that authority be granted to award a contract to 614128 Ontario Ltd., O/A Trisan Construction, in the amount of \$751,756.97, including all taxes and charges, for Watermain Replacements on Holmesdale Crescent and Holmesdale Road.

On motion by Wayne Scott, the Bid Committee adopted the staff recommendation in the Recommendation Section of the report.

**11.3 Request for Quotation (RFQ) 3412-06-3023 - For the Supply, Delivery and Installation of Upgrades for the Sun Fire 12K to 15K Server**

Recommendation:

It is recommended that authority be granted to award a contract to Onx Enterprise Solutions Inc., in the amount of \$737,317.93, including all taxes and charges for the

Supply, Delivery and Installation of Upgrades for the Sun Fire 12K Server for the Information and Technology Division, being the only bid received.

It is recommended that Contract 06SC-19WS, Tender Call 15-2006, for the Dorset Park Community, Phase II - Watermain Replacement, Scarborough District, be awarded to Sam Rabito Construction Ltd., in the amount of \$2,604,777.39, including all taxes and charges, being the lowest bid received.

**11.11 Request for Quotation 1201-06-5004 - Parkside Changeable Message Sign Supply and Install new Changeable Message Sign to Replace Existing Unit**

The Bid Committee considered a report (March 10, 2006) from the Acting Director of Purchasing and Materials Management, advising on the results of the Request for Quotation 1201-06-5004 issued for the supply and install a new Changeable Message Sign to replace the existing unit over the west bound lanes of the Gardiner Expressway near Parkside Avenue, in accordance with the specifications, as required by the Transportation Services Division and requesting authority to award a contract to the recommended bidder.

Recommendation:

It is recommended that authority be granted to award a contract to Guild Electric Limited, in the amount of \$981,238.98, including all taxes and charges, for the supply and install of a new Changeable Message Sign to replace the existing unit over the west bound lanes of the Gardiner Expressway near Parkside Avenue.
