Confirmation of Minutes

On motion by Mae Maracle, the minutes of the meeting of the Bid Committee held on March 15, 2006, were confirmed.

12.1 Contract 06EY-100TU, Tender Call 267-2005 - Permanent Repairs to Utility Cuts - Etobicoke York District (Wards 1 and 2 - Etobicoke North and Wards 3 and 4 - Etobicoke Centre)

The Bid Committee considered a report (March 10, 2006) from the General Manager of Transportation Services and the Manager of Goods and Services, Purchasing and Materials Management, advising on the results of the Tender issued for Permanent Repairs to Utility Cuts in Etobicoke York District, in accordance with specifications as required by Transportation Services, and requesting authority to award a contract to the recommended bidder.

It is recommended that authority be granted to award Contract 06EY-100TU, for the Permanent Repairs to Utility Cuts in Etobicoke York District, to Lima's Garden & Construction Inc., in the amount of \$1,464,739.05 including all applicable taxes and charges.
