14.1 Contract 06NY-315WS, Tender Call 47-2006 Cleaning and Cement Mortar Lining of Existing Water Mains at Various Locations in North York District

The Bid Committee considered a report (March 21, 2006) from the General Manager of Toronto Water and the Acting Director of Purchasing and Materials Management, advising on the results of the Tender Call 47-2006, issued for Cleaning and Cement Mortar Lining of Existing Water Mains at Various Locations in North York District, in accordance with specifications as required by Toronto Water, and requesting the authority to award a contract to the recommended bidder.

provided the supply and delivery of Building Repairs for Various Children's Services locations throughout the City of Toronto were performed at a satisfactory level and subject to budget approval, the General Manager of Children's Services to instruct the Purchasing Agent to process the necessary contract renewals under the same terms and conditions; and

(3) a contract for the period from April 1, 2006 to December 31, 2006, in the total amount of \$300,000 including all applicable taxes and charges be awarded to A.M.P.M. Renovations, with an option to renew at the sole discretion of the General Manager of Children's Services for the period January 1, 2007 to December 31, 2007, in the total amount of \$300,000 and with a second option to renew at the sole discretion of the General Manager of Children's Services for the period January 1, 2008 to December 31, 2008, in the total amount of \$300,000 provided the supply and delivery of Building Repairs for Various Children's Services locations throughout the City of Toronto were performed at a satisfactory level and subject to budget approval, the General Manager of Children's Services to instruct the Purchasing Agent to process the necessary contract renewals under the same terms and conditions.

It is recommended that authority be granted to award Contract 06TE-121TR, Tender Call 66-2006 for Resurfacing of Expressways at Various Locations in the Toronto and East York District, to Gazzola Paving Limited, in the amount of \$1,589,631.06, including all taxes and charges, being the lowest bid received.
