Confirmation of Minutes

On motion by Laurie McQueen, the minutes of the meeting of the Bid Committee held on April 12, 2006, were confirmed.

16.1 Request for Quotation 3907-06-5019 - Facility Upgrades, Leaside Memorial Garden Pool (Ward 26 - Don Valley West)

Bid Committee considered a report (March 30, 2006) from the Acting Director of Purchasing and Materials Management and the General Manager of Parks, Forestry and Recreation, advising on the results of the Request for Quotation issued for Facility Upgrades at Leaside Memorial Garden Pool, in accordance with specifications, as required by the Parks, Forestry and Recreation, and requesting the authority to award a contract to the recommended bidder.

Recommendation:

It is recommended that authority be granted to award a contract to P.S. Painting Ltd., (operating as Cosar Renovation), in the amount of \$828,180.00, including all applicable taxes and charges, for Facility Upgrades at Leaside Memorial Gardens Pool.

Bid Committee considered a report (April 10, 2006) from the Executive Director of Technical Services and the Manager of Goods and Services, Purchasing and Materials Management, advising on the results of the Tender issued for Road Reconstruction, Road Resurfacing, Intersection Modification and Road Widening on Marlee Avenue, from Lawrence Avenue West to 50m North of Hopewell Avenue, in North York District, in accordance with specifications as required by Technical Services and requesting authority to award a contract to the recommended bidder.

Recommendation:

It is recommended that Contract 06NY-03RD, Tender Call 4-2006, for Road Reconstruction, Road Resurfacing, Intersection Modification and Road Widening on Marlee Avenue from Lawrence Avenue West to 50m North of Hopewell Avenue in North York District, be awarded to Gazzola Paving Limited in the amount of \$2,683,007.51 including all taxes and charges, being the lowest acceptable bid received.

the Toronto and East York District, in accordance with specifications as required by Transportation Services, and requesting authority to award a contract to the recommended bidder.

Recommendation:

It is recommended that authority be granted to award Contract 06TE-111TR to Furfari Paving Co.
