Confirmation of Minutes

On motion by Don Altman, the minutes of the meeting of the Bid Committee held on April 26, 2006, were confirmed.

18.1 Contract 06SC-320WP- Tender Call 65-2006 - CCTV Inspection and Cleaning of Municipal Sewers at Various Locations in the Scarborough District

The Bid Committee considered a report (April 18, 2006) from the General Manager of Toronto Water and the Acting Director of Purchasing and Materials Management, advising on the results of the Tender 65-2006, issued for CCTV Inspection and Cleaning of Municipal Sewers at Various Locations in the Scarborough District, in accordance with specifications as required by Toronto Water, and requesting authority to award a contract to the recommended bidder.

Recommendation:

It is recommended that authority be granted to award Contract 06SC-320WP, Tender Call 65-2006, for CCTV Inspection and Cleaning of Municipal Sewers at Various Locations in Scarborough District, to Sarp Toronto Inc., in the amount of \$588,302.05 including all taxes and charges.

18.2 Contract 06TE-310WS- Tender Call 33-2006 - Cleaning and Cement Mortar Lining of Existing Water Mains at Various Locations in Toronto and East York District

The Bid Committee considered a report (April 18, 2006) from the General Manager of Toronto Water and the Acting Director of Purchasing and Materials Management, advising on the results of the Tender 33-2006, issued for Cleaning and Cement Mortar Lining of Existing Water Mains at Various Locations in Toronto and East York District, in accordance with specifications as required by Toronto Water, and requesting authority to award a contract to the recommended bidder.

Recommendation:

It is recommended that authority be granted to award Contract 06TE-310WS, Tender Call 33-2006, for Cleaning and Cement Mortar Lining of Existing Water Mains at Various Locations in Toronto and East York, to Fer-Pal Construction Ltd., in the amount of \$2,277,013.50 including all taxes and charges.

On motion by Frank Csenkey, the Bid Committee adopted the staff recommendation in the Recommendation Section of the report.

18.3 Contract 06SC-114TR, Tender Call 58-2006 - Local Road Resurfacing (Wards 37, 39 and 42 - Scarborough District)

The Bid Committee considered a report (April 19, 2006) from the General Manager of Transportation Services and the Manager of Goods and Services, Purchasing and Materials Management, advising on the results of the Tender 58-2006, issued for Local Road Resurfacing, Scarborough District, in accordance with specifications as required by the Transportation Services Division, and requesting the authority to award a contract to the recommended bidder.

Recommendation:

It is recommended that authority be granted to award Contract 06SC-114TR, Tender Call 58-2006, for Local Road Resurfacing, Wards 37, 39 and 42, Scarborough District, to D. Crupi & Sons Limited, in the total amount of \$1,655,055.78 including all taxes and charges.

18.4 Automated Meter Reading System Request for Proposal 0729-05-7287 (All Wards)

The Bid Committee considered a report (April 26, 2006) from the General Manager of Toronto Water and the Acting Director of Purchasing and Materials Management, advising on the results of the Request for Proposal (RFP) 0729-05-7287, for the Meter Replacement and Automated Meter Reading System RFP Development and Contract Management and requesting authority to award a contract and enter into an agreement with the recommended proponent.

Recommendation:

It is recommended that authority be granted to award a contract to EMA Canada Inc., in the amount of \$4,201,536.90 including all applicable taxes and charges to provide professional services to develop an RFP for meter replacement and an automated meter reading system.

18.5 Tender Call 12-2006 - Concrete Repairs to Underground Parking Garage at 2 Civic Centre Court (Ward 3 - Etobicoke Centre)

The Bid Committee considered a report (April 25, 2006) from the Acting Director of Purchasing and Materials Management, advising on the results of the Tender issued for the Concrete Repairs to Underground Parking Garage at 2 Civic Centre Court, in accordance with specifications as required by Facilities and Real Estate and requesting the authority to award a contract to the recommended bidder.

Recommendation:

It is recommended that authority be granted to award Tender Call 12-2006, for Concrete Repairs to Underground Parking Garage at 2 Civic Centre Court, to Across Canada Construction, in the amount of \$599,246.01 including all taxes and charges.

Recommendation:

It is recommended that authority be granted to award Contract 06TE-40WP, Tender Call 85-2006 to Co-X-Co Construction Limited., in the amount of \$936,506.80, including all applicable taxes and charges, for the construction of a combined sewer on Dupont Street from Davenport Road to Avenue Road.
