Confirmation of Minutes

On motion by Don Altman, the minutes of the meeting of the Bid Committee held on June 28, 2006, were confirmed.

27.1 Request for Quotation 1210-06-0059 - Electric Motor Repair and Rewinding, Other Electrical Repairs, and Supply of Electrical Motors and Variable Frequency Drives (All Wards)

The Bid Committee considered a report (June 21, 2006) from the General Manager of Toronto Water, the General Manager of Solid Waste Management Services and the Director of Purchasing and Materials Management, advising on the results of the Request for Quotation (RFQ) 1210-06-0059 for the Supply and Delivery of Labour, Parts, Equipment and Supplies necessary for Electric Motor Repair and Rewinding, Other Electrical Repairs, and Supply of Electrical Motors and Variable Frequency Drives at various Toronto Water and Solid Waste Management Services locations throughout the City of Toronto, from the date of the contract award to December 31, 2007, with the

option in favour of the City of Toronto to renew the contract for two (2) additional, separate one (1) year periods, and requesting authority to award contracts to the recommended bidders.

Recommendations:

It is recommended that:

- (1) authority be granted to award a contract to Ainsworth Inc., in the amount of \$1,156,789.84 including all taxes, charges and a 20 percent contingency for the Supply and Delivery of Labour, Parts, Equipment and Supplies Necessary for Electric Motor Repair and Rewinding, Other Electrical Repairs, and Supply of Electrical Motors and Variable Frequency Drives at various Toronto Water and Solid Waste Management Services locations throughout the City of Toronto from the date of the contract award to December 31, 2007, with the option to renew at the sole mutually agreeable discretions of the General Managers of Toronto Water and Solid Waste Management, for the periods of January 1, 2008 to December 31, 2008, in the amount of \$714,967.07 including all applicable taxes charges, and a 20 percent contingency, and with a second option to renew at the sole mutually agreeable discretions of the General Managers of Toronto Water and Solid Waste Management for the period of January 1, 2009 to December 31, 2009, in the amount of \$742,765.74 including all applicable taxes, charges, and a 20 percent contingency; and
- (2) authority be granted to award a contract to Trademark Industrial Inc., in the amount of \$1,156,789.84 including all taxes, charges, and a 20 percent contingency for the Supply and Delivery of Labour, Parts, Equipment and Supplies Necessary for Electric Motor Repair and Rewinding, Other Electrical Repairs, and Supply of Electrical Motors and Variable Frequency Drives at various Toronto Water and Solid Waste Management Services locations throughout the City of Toronto, from the date of the contract award to December 31, 2007, with the option to renew at the sole mutually agreeable discretions of the General Managers of Toronto Water and Solid Waste Management for the periods of January 1, 2008 to December 31, 2008, in the amount of \$714,967.07 including all applicable taxes charges, and a 20 percent contingency, and with a second option to renew at the sole mutually agreeable discretions of the General Managers of Toronto Water and Solid Waste Management for the period of January 1, 2009 to December 31, 2009, in the amount of \$742,765.74 including all applicable taxes, charges, and a 20 percent contingency.

27.2 Contract 06SC-330WS, Tender Call 131-2006 - Cathodic Protection of Existing Watermains in Various Locations in Scarborough District (Wards 35 and 36 - Scarborough Southwest, Ward 37 - Scarborough Centre, Ward 40 - Scarborough - Agincourt, Wards 43 and 44 - Scarborough East)

The Bid Committee considered a report (June 26, 2006) from the General Manager of Toronto Water and the Director of Purchasing and Materials Management, advising on the results of the Tender issued for Cathodic Protection of Existing Iron Watermains in Various Locations in Scarborough District, in accordance with specifications as required by Toronto Water, and requesting authority to award a contract to the recommended bidder.

Recommendation:

It is recommended that authority be granted to award Contract 06SC-330WS, Tender Call 131-2006, for Cathodic Protection of Existing Iron Watermains in Various Locations in Scarborough District, to 614128 Ontario Ltd. - O/A Trisan Construction, in the amount of \$1,298,787.40, including all taxes and charges, being the lowest bid received meeting specifications.

27.3 Contract 06TE-36WS, Tender Call 124-2006 - Construction of Watermain on Beverley Street from Dundas Street West to College Street (Ward 20 - Trinity-Spadina)

The Bid Committee considered a report (June 22, 2006) from the Executive Director of Technical Services and the Director of Purchasing and Materials Management, advising on the results of the Tender issued for the construction of watermain on Beverley Street from Dundas Street West to College Street, in accordance with specifications as required by Technical Services, and requesting authority to award a contract to the recommended bidder.

Recommendation:

It is recommended that authority be granted to award Contract 06TE-36WS, Tender Call 124-2006, to Alsi Contracting Ltd., in the amount of \$683,114.75, including all taxes and charges, for the construction of watermain on Beverley Street from Dundas Street West to College Street, being the lowest bid meeting specifications.

On motion by Surina Kaur, the Bid Committee adopted the staff recommendation in the Recommendation Section of the report.

27.4 Contract 06EY-14RD, Tender Call 132-2006 - Eglinton Avenue Bicycle Path and Sidewalk (Ward 4 - Etobicoke Centre)

It is recommended that authority be granted to award Contract 06EY-14RD, Tender Call 132-2006 to 1458451 Ontario Limited o/a Slip-Form Construction, in the amount of \$1,154,871.70, including all taxes and charges, for the Eglinton Avenue Bicycle Path and Sidewalk.

Recommendation:

It is recommended that authority be granted to award Contract 06NY-328WS, Tender Call 138-2006, to Kenco Construction Ltd., in the amount of \$1,630,578.89 including all taxes and charges for Water Service Replacement at Various Locations in Wards 8, 9, 10, 15, 16, 23, 24, 25, 26, 33 and 34 in North York District.

Recommendation:

It is recommended that authority be granted to award Contract 06SC-329WS, Tender Call 148-2006, for Water Service Replacement at Various Locations in Wards 35, 36, 37, 38, 39, 40, 41, 42, 43 and 44 in Scarborough District, to Sebco Contracting Ltd., in the amount of \$1,501,359.80 including all taxes and charges.

Recommendation:

It is recommended that recommended that authority be granted to award Contract 06SC-103TM, Tender Call 125-2006, for Repairs to Roads and Sidewalks, Wards 35, 36, 37, 38, 39, 40, 41, 42, 43 and 44 in Scarborough District to Gazzola Paving Limited, in the amount of \$869,188.29 including all taxes and charges.
