Confirmation of Minutes

On motion by Don Altman, the minutes of the meeting of the Bid Committee held on July 12, 2006, were confirmed.

29.1 Request for Quotation (RFQ) 0606-06-0016 - Supply and Delivery of Milk and Other Related Dairy Products for Various Shelter, Support and Housing Administration Locations throughout the City of Toronto

The Bid Committee considered a report (June 30, 2006) from the Director of Purchasing and Materials Management, advising on the results of the Request for Quotation (RFQ) issued for the supply and delivery of Milk and other related dairy products for the Shelter, Support and Housing Adminstration from award date to April 30, 2007, with option to renew for three (3) separate and additional one (1) year periods, and requesting authority to award a contract to the recommended bidder.

Recommendation:

It is recommended that authority be granted to award a contract from the date of award to April 30, 2007, in the total amount of \$193,631.46 including all applicable taxes and charges to Agropur Division Natrel, having submitted the lowest bid meeting specifications, with an option to renew at the sole discretion of the General Manager of Shelter, Support and Housing Administration in the total amount of \$200,290.86 including all applicable taxes and charges for the period from May 1, 2007 to April 30, 2008, and with a second option to renew at the sole discretion of the General Manager of Shelter, Support and Housing Administration, in the total amount of \$207,175.60 including all applicable taxes and charges, and with a third option to renew at the sole discretion of the General Manager of Shelter, Support and Housing Administration, in the total amount of \$214,251.73 including all applicable taxes and charges, provided that the supply and delivery of milk and other related dairy products were performed at a satisfactory level and subject to budget approval, the General Manager of Shelter, Support and Housing Administration, to instruct the Chief Purchasing Official to process the necessary contract renewals under the same terms and conditions.

L. Clark Water Treatment Plant, and requesting authority to award a contract to the recommended bidder.

Recommendation:

It is recommended that authority be granted to award a contract for the construction of Administration Building Interior and Exterior Renovations, at the R. L. Clark Water Treatment Plant, to Morosons Construction Ltd., in the amount of \$3,804,412.08 including all applicable taxes, charges and contingency being the lowest acceptable bid meeting specifications.

Recommendation:

It is recommended that Contract 06FS-44WS, Tender Call 91-2006, for the Parkdale Pumping Station for the Replacement of the Primary 13.8 kV Switchgear be awarded to Procon Niagara, Division of 1149855 Ontario Inc., in the total amount of \$1,235,345.79 including all taxes and charges, being the lowest bid received meeting specifications.

Recommendation:

It is recommended that authority be granted to award Contract 06TE-17RD, Tender Call 144-2006, for the Reconstruction of Pavement, Sidewalk and Water Services on Hursting Avenue, from Winona Drive to Arlington Avenue and Chiltern Hill Road from Avenal Drive to Ava Road, to Metropolitan Paving & Concrete Inc., in the amount of \$601,673.33, including all taxes and charges, having submitted the lowest bid meeting specifications.
