#### **Confirmation of Minutes**

On motion by Don Altman, the minutes of the meeting of the Bid Committee held on July 26, 2006, were confirmed.

#### **31.1 Contract 06NYSC-332WP, Tender Call 152-2006 - CCTV Inspection and Cleaning of Municipal Sewers (Various Locations - North York and Scarborough Districts)**

The Bid Committee considered a report (July 17, 2006) from the General Manager of Toronto Water and the Director of Purchasing and Materials Management, advising on the results of the Tender issued for CCTV Inspection and Cleaning of Municipal Sewers at Various Locations in the North York and Scarborough Districts, in accordance with specifications as required by Toronto Water, and requesting authority to award a contract to the recommended bidder.

Recommendation:

It is recommended that Contract 06NYSC-332WP, Tender Call 152-2006, for CCTV Inspection and Cleaning of Municipal Sewers at Various Locations in North York and Scarborough Districts, be awarded to Capital Commercial Pipe Services Ltd., in the amount of \$640,240.00, including all taxes and charges, having submitted the lowest bid meeting specifications.

**31.2 Contract 06NY-334WS, Tender Call 164-2006 - Cathodic Protection of Existing Iron Watermains in Toronto – Various Locations – North York District – York Centre (Ward 10, York Centre, Wards 11 and 12, York South-Weston, Wards 15 and 16, Eglinton-Lawrence, Wards 23 and 24, Willowdale, Wards 25 and 26, Don Valley West and Wards 33 and 34, Don Valley East)**

The Bid Committee considered a report (July 11, 2006) from the General Manager of Toronto Water and the Director of Purchasing and Materials Management, advising on the results of the Tender issued for Cathodic Protection of existing Iron Watermains at Various Locations in the North York District, in accordance with specifications as required by Toronto Water, and requesting authority to award a contract to the recommended bidder.

Recommendation:

It is recommended that authority be granted to award Contract 06NY-334WS, Tender Call 164-2006, for Cathodic Protection of existing Iron Watermains at Various Locations in the North York District, to 1460973 Ontario Limited O/A C.P. Systems, in the amount of \$1,380,432.70, including all taxes and charges, being the lowest bid received meeting specifications.

**31.3 Contract 06NY-325WP, Tender Call 112-2006 - The Full Length Trenchless Rehabilitation of Existing Gravity Sewers and Watermains within Hoggs Hollow Area – North York District (Ward 25, Don Valley West)**

The Bid Committee considered a report (July 24, 2006) from the General Manager of Toronto Water and the Director of Purchasing and Materials Management, advising on the results of the Tender issued for The Full Length Trenchless Rehabilitation of Existing Gravity Sewers and Watermains within Hoggs Hollow Area - North York

District, in accordance with specifications as required by Toronto Water, and requesting authority to award a contract to the recommended bidder.

Recommendation:

It is recommended that authority be granted to award Contract 06NY-325WP, Tender Call 112-2006, for The Full Length Trenchless Rehabilitation of Existing Gravity Sewers and Watermains within Hoggs Hollow Area - North York District, to Ferpel Construction Ltd., in the amount of \$2,335,152.44, including all taxes and charges, having submitted the lowest bid meeting specifications.

**31.4 Contract 06NY-19WS, Tender Call 121-2006 - Replacement of Watermains on Elmwood Avenue from Dudley Avenue to Highgate Avenue, Woodsworth Road from Northey Drive to Davean Drive, Bryant Street from Tokay Court to Waterloo Avenue and Baytree Crescent from Bayview Avenue to End (Ward 10, York Centre, Ward 23, Willowdale and Ward 25, Don Valley West)**

The Bid Committee considered a report (July 24, 2006) from the Executive Director of Technical Services and the Director of Purchasing and Materials Management, advising on the results of the Tender issued for Replacement of Watermains on Elmwood Avenue, Woodsworth Road, Bryant Street and Baytree Crescent, in accordance with specifications as required by Technical Services, and requesting authority to award a contract to the recommended bidder.

It is recommended that authority be granted to award Contract 06NY-19WS, Tender Call 121-2006, for Replacement of Watermains on Elmwood Avenue, Woodsworth Road, Bryant Street and Baytree Crescent, to Rymall Construction Inc., in the amount of \$1,937,680.00, including all taxes and charges, having submitted the lowest bid meeting specifications.

It is recommended that Contract 06NY-331WP, Tender Call 151-2006, for CCTV Inspection and Cleaning of Municipal Sewers at Various Locations in North York District, be awarded to Capital Commercial Pipe Ltd., in the amount of \$582,894.00, including all taxes and charges, having submitted the lowest bid meeting specifications.
