38.1 Request for Quotation 4305-06-5096 - Installation of New Air Handling Units AHU-3 and AHU-4 and Return Fans RF-3, RF-3A and RF-4 at North York Civic Centre, 5100 Yonge Street, Toronto

The Bid Committee considered a report (September 7, 2006) from the Chief Corporate Officer and the Director of Purchasing and Materials Management, advising on the results of the RFQ issued for the Installation of New Air Handling Units AHU-3 and AHU-4 and Return Fans RF-3, RF-3A and RF-4, at North York Civic Centre, 5100 Yonge Street, Toronto, in accordance with the specifications as required by Facilities and Real Estate, and requesting authority to award a contract to the recommended bidder.

Recommendation:

It is recommended that authority be granted to award a contract for the Installation of New Air Handling Units AHU-3 and AHU-4 and Return Fans RF-3, RF-3A and RF-4, at North York Civic Centre, 5100 Yonge Street, Toronto, to Bomben Plumbing & Heating Ltd., in the amount of \$755,163.08, including all applicable taxes and charges, having submitted the lowest bid.

The Bid Committee considered a report (August 24, 2006) from the Executive Director of Technical Services and the Director of Purchasing and Materials Management, advising on the results of the Tender issued for the Watermain Construction on Coolhurst Drive, Dewsbury Crescent and Quebec Avenue, in accordance with specifications as required by Technical Services, and requesting authority to award a contract to the recommended bidder.

Recommendation:

It is recommended that authority be granted to award Contract 06EY-16WS, Tender Call 75-2006, for the Watermain Construction on Coolhurst Drive, Dewsbury Crescent and Quebec Avenue, to Rabcon Contractors Ltd., in the amount of \$813,513.54, including all applicable taxes and charges, having submitted the lowest bid meeting specifications.

The Bid Committee considered a report (September 11, 2006) from the Director of Purchasing and Materials Management, advising on the results of the Request for Quotation issued for the supply of all labour, equipment and materials necessary for the Replacement of A/C Unit 2 and 3, overhead door heating units and sump pump systems at St. Lawrence Market South, 91 Front Street East, in accordance with specifications as required by Facilities and Real Estate Division, and requesting authority to award a contract to the recommended bidder.

Recommendation:

It is recommended that authority be granted to award a contract for the Replacement of A/C Unit 2 and 3, overhead door heating units and sump pump systems at St. Lawrence Market South, 91 Front Street East, to Servocraft Limited, in the amount of \$1,028,200.00 including all applicable taxes and charges, having submitted the lowest bid.
