- (4) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

- (3) the Executive Director of Technical Services be requested to prepare designation by-law maps of the area, as described by Attachment 1 (Maps 1-3), and submit them to the City Solicitor;
- (4) subject to the City Clerk reporting favourably on the results of the poll referred to in Recommendation (2), and upon receipt of the maps referred to in Recommendation (3), the City Solicitor be directed to prepare a by-law designating the area, as described by Attachment 1 (Maps 1-3), as a Business Improvement Area in accordance with Section 204 of the *Municipal Act, 2001*;
- (5) staff report directly to Council on the poll results referred to in Recommendation (4), to enable the designation of the BIA in 2006; and
- (6) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

- (2) a letter from the Clerk indicating that the establishments listed in Attachment 1 are officially endorsed by Nuit Blanche Toronto and Toronto City Council has no objection to these establishments being included in Toronto Special Events'

application for a sales licence extension of hours with the AGCO for the purpose of Nuit Blanche on September 30 through to October 1; and

- (3) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

- (ii) (May 26, 2006) from the General Manager of Parks, Forestry and Recreation, forwarding the recommended allocations for all community organizations that have appealed their original allocation in the Recreation Partnership and Investment Program for 2006.

Recommendations:

- (1) Recreation Partnership and Investment Program allocations totalling \$3,508.00, to five of the seven organizations that appealed their original 2006 recommendation as listed in Attachment 1 and described in Attachment 2, be approved; and

The Economic Development and Parks Committee considered a report (May 25, 2006) from the General Manager of Parks, Forestry and Recreation seeking, authority to enter into an easement agreement with Loblaws Properties Limited for the purposes of developing a formal trailhead to the Lower Don River Parklands.

On motion by Councillor Lindsay Luby, the Economic Development and Parks Committee requested the General Manager of Parks, Forestry and Recreation to add the words “No fireworks unless authorized by permit - Parks By-law 608-5” to new signs to be installed in City parks as well as old signs as they are replaced.

Councillor Lindsay Luby resumed the Chair.

**4.18 Request for Name Change for Eastview Park**

The Economic Development and Parks Committee considered a communication (May 10, 2006) from Councillor Paula Fletcher, Ward 30 Toronto-Danforth, forwarding a request from the Eastview Neighbourhood Community Centre's Committee of Management that Eastview Park be renamed in memory of Kempton Howard.

On motion by Councillor Hall, the Economic Development and Parks Committee referred the communication to the General Manager of Parks, Forestry and Recreation for report to the Committee as soon as possible, and that the report also review the City's policy on renaming of parks and financial implications thereof.

**4.19 The Ontario Federal Council's Leadership in Science and Sustainable Development Award**

**4.20 Appointment of One Member of the Economic Development and Parks Committee to the Children's Services Advisory Committee**

The Economic Development and Parks Committee considered a communication (May 1, 2006) from the City Clerk, advising that City Council on April 25, 26 and 27, 2006, adopted, without amendment, Clause 3 of Report 3 of the Policy and Finance Committee.

On motion by Councillor Grimes, the Economic Development and Parks Committee recommended that City Council appoint Councillor Augimeri as the representative from the Economic Development and Parks Committee, to the Children's Services Advisory Committee, for a term of office ending November 30, 2006.
