3.2 Refusal Report – Official Plan Amendment and Rezoning Application; Applicant: CIC Millwork Ltd.; Architect: OP Design Inc., 829, 833, 839 Oxford Street and 156, 160 Evans Avenue (Ward 6 – Etobicoke-Lakeshore)

The Etobicoke York Community Council considered a report (March 20, 2006) from the Director, Community Planning, Etobicoke York District regarding an application for Official Plan and Zoning Code amendments to permit development of 194 townhouse units at 829, 833, 839 Oxford Street and 156, 160 Evans Avenue.

Recommendation:

Moved by Councillor Grimes, that the Etobicoke York Community Council recommend to City Council the adoption of the following motion:

WHEREAS an application has been submitted to redevelop the property municipally known as 829, 833 and 839 Oxford Street and 156 and 160 Evans Avenue in the former City of Etobicoke with a 194 unit townhouse development; and

WHEREAS the Site in question is located in an area where similar and compatible townhouse developments have proceeded in lieu of the historical employment uses and is also adjacent to existing residential development on Evans Avenue; and

WHEREAS the proposed development is generally in accordance with the criteria contained in the former City of Etobicoke Official Plan for the redesignation of employment lands; and

WHEREAS the proposed development is similar to other townhouse developments which have been approved with units fronting onto a private roadway as part of a "common element condominium"; and

WHEREAS a community consultation meeting was held on February 2, 2006 at which the attendees were virtually unanimous in their support of the proposed townhouse development;

NOW THEREFORE BE IT RESOLVED that the staff recommendation in the Recommendation Section of the report (March 20, 2006) from the Director, Community Planning, Etobicoke York District, be deleted, and that City Council:

- (1) adopt the following replacement Recommendation instead:
 - "(1) It is recommended that the applicant submit an acceptable revised plan which provides for adequate buffering between the proposed use and the industrial lands to the west, and which addresses other site plan matters such as garbage pickup, proposed park design, access and circulation, and urban design considerations such as deck heights and privacy issues relating to existing residential development."
- (2) adopt the following additional Recommendation (2):
 - "(2) that the Director, Community Planning, Etobicoke York District, be requested to complete the processing of the revised acceptable applications and bring forward a Final Report to a statutory public meeting at the June 13, 2006 Etobicoke York Community Council Meeting, which report shall include appropriate implementing Official Plan and Zoning By-laws, and any other such agreements necessary to facilitate the proposed development, which proposed development shall be exempt from the application of the Development Infrastructure and Policy Standards policies."

3.3 Final Report – Local Area Review for the lands located between Sheppard Avenue West, CPR Rail Line, Starview Lane and rear property lines of the Residential Properties along Weston Road and Official Plan and Rezoning Application, Subdivision Application; Applicant: Robert Truman 2277-2295 Sheppard Avenue West and 100 Mainshep Road (Ward 7 – York West)

The Etobicoke York Community Council considered a report (March 21, 2006) from the Director, Community Planning, Etobicoke York District, providing a local area review of planning policies and reviews and recommending approval of an application to amend the Official Plan and the Zoning By-law for a development with 546 residential units and approximately 7,305 square metres of commercial floor area a 2277-2295 Sheppard

Avenue West and 100 Mainshep Road, and amendment to the Official Plan to permit residential uses at 2973 Weston Road and 3035 Weston Road.

Recommendations:

- (2) amend the Zoning By-law No. 7625 for the former City of North York substantially in accordance with the draft Zoning By-law Amendment attached as Attachment No. 10;
- (3) direct the City Solicitor to request the Ontario Municipal Board to modify the Official Plan for the City of Toronto substantially in accordance with Attachment No. 9;
- (4) authorize the City Solicitor to make such stylistic and technical changes to the draft Official Plan Amendment and draft Zoning By-law Amendment as may be required;
- (5) be advised that the Chief Planner, who has delegated authority to approve conditions of draft plan of subdivision approval, proposes to approve the application on the conditions as generally set out in Attachment No. 11;
- (6) before introducing the necessary Bills to City Council for enactment, require the owner to enter into a Section 37 Agreement, securing the facilities, services and matters referred in the draft Official Plan and Zoning By-law Amendment; and
- (7) before introducing the necessary Bills to City Council for enactment, require the owner to provide a written undertaking in a form satisfactory to the City Solicitor, that upon the site-specific Official Plan and Zoning By-law Amendments described in this report coming into effect, the applicant's appeal of the new Toronto Official Plan as it relates to this site, be settled upon the necessary amendments to the new Toronto Official Plan being made to reflect the approved Official Plan Amendment and Zoning By-law.

On motion by Councillor Mammoliti, the Etobicoke York Community Council recommended that City Council:

- (1) adopt the staff recommendations in the Recommendations Section of the report (March 21, 1006) from the Director, Community Planning, Etobicoke York District, be adopted, subject to deleting Recommendation (6) and replacing it with the following instead:
 - "(6) before introducing the necessary Bills to City Council for enactment, require the owner to enter into a Section 37 agreement and prior to draft plan approval, the owner provide a Letter of Credit for the amount of \$500,000 to the City, to be used for improvements to the Humber Sheppard Community centre with regard to those areas of the building that are managed by the Humber Sheppard East Wing Management Board, and for the following enhancements:
 - (a) Community/Teaching Kitchen up to \$200,000;
 - (b) Outdoor Soccer Stadium up to \$150,000;
 - (c) Building of Concession Stand up to \$70,000; and

that the remaining \$80,000 be used for improvements to the gymnasium floor and other amenities at the Humber Sheppard Community Centre;"

- (2) adopt the following additional Recommendations (2) to (8):
 - "(2) that H & R Developments be requested to undertake the proposed construction as noted above;
 - (3) that if any enhancements cannot be completed, that other parks and/or recreation sites within Ward 7 York West, be considered at the discretion of the Ward Councillor and the General Manager, Parks, Forestry and Recreation;
 - (4) that in the event traffic control signals are not warranted at the Weston Road/Mainshep Road intersection following build-out of this development, then the remaining funds paid by the developer to secure the installation of traffic control signals shall be reallocated to another intersection in Ward 7 – York West, where traffic control signals are considered warranted;
 - (5) that the applicant meet with the Ward Councillor, staff of the Affordable Housing Office and City Planning staff, to determine if an agreement between the Owner and the City can be reached to offer "affordable" units to prospective purchasers (as determined by the City), prior to the offering of the units to the general public, the term "affordable" being generally based on the definition and numeric requirements as set out in the North York Official Plan, the Official Plan for Metropolitan Toronto and the 2005 Provincial Policy Statement;
 - (6) that appropriate staff report on the outcome of above discussions and any implementation measures that may be required;
 - (7) that the Draft Official Plan and Zoning By-law be amended accordingly, to reflect the above Recommendations, if necessary; and
 - (8) that the developer be required to contribute \$25,000 towards the construction of the St. Jude's Catholic School/Best Start Playground."

3.4 Final Report – Rezoning Application; Applicant: Mario Faroane; Architect: Gary Zebroski, Zebroski Assoc. Ltd. Architect 129 Fenmar Drive (Ward 7 – York West)

The Etobicoke York Community Council considered a report (December 22, 2005) from the Director, Community Planning, Etobicoke York District, recommending approval of an application to amend the former City of North York Zoning By-law No. 7625 to permit a Salvage Yard use with outside storage and operations, as an exception to the Industrial Zone Three (M3) zoning for the property at 129 Fenmar Drive.

- (5) require the foregoing requirements to be satisfied within a five year period of City Council's adoption of this report.

3.6 Final Report – Official Plan Amendment & Rezoning Application; Applicant: Jonathan Mair, Firm Capital Corporation; Architect: Ferdinand Wagner Architect 99 Chandos Avenue (Ward 17 – Davenport)

The Etobicoke York Community Council considered a report (March 21, 2006) from the Director, Community Planning, Etobicoke York District regarding an application to amend the former City of Toronto Zoning By-law No. 438-86 to convert an existing building at 99 Chandos Avenue, formerly used for industrial purposes, to a residential use containing 15 dwelling units.

Recommendations:

- (1) amend Zoning By-law No. 438-86 for the former City of Toronto substantially in accordance with the draft Zoning By-law Amendment attached as Attachment No. 5;
- (2) authorize the City Solicitor to make such stylistic and technical changes to the draft Zoning By-law Amendment as may be required;
- (3) before introducing the necessary Bills to City Council for enactment, require the owner to submit to the Executive Director of Technical Services for review and acceptance a Reference Plan of survey in metric units, should a registered agreement be required to permit boulevard parking. The Plan is to be referenced to the Ontario Co-ordinate system, delineating thereon by separate PARTS the

lands under application and any appurtenant rights-of-way and easements will be required for the preparation of legal descriptions;

- (4) before introducing the necessary Bills to City Council for enactment, require the owner to submit a building permit application and submit a legible, up-to-date and fully monumented plan of survey of the site necessary for building permit approval and inspection purposes;
- (5) before introducing the necessary Bills to City Council for enactment, require the owner to satisfy Notice of Approval Conditions issued for Site Plan Approval under Section 41 of the Planning Act;
- (6) before introducing the necessary Bills to City Council for enactment, require the owner to file on the Province's Environmental Registry under the Environment Protection Act, a Record of Site Condition evidencing that the site is suitable for residential purposes, such environmental documentation to recognize that the change in use is from industrial to residential; and
- (7) require the owner to satisfy all conditions in recommendation 3, 4, 5 and 6 within a period of two years from the date of City Council approval, failing which the owner shall be required to reapply for the necessary zoning by-law amendment.

 - (a) That Recommendation (4) be amended by adding the words "to convert the building from industrial to residential" after the word "application", to read as follows:

- "(4) before introducing the necessary Bills to City Council for enactment, require the owner to submit a building permit application to convert the building from industrial to residential and submit a legible, up-to-date and fully monumented plan of survey of the site necessary for building permit approval and inspection purposes;"
- (b) That Recommendation (7) be amended by deleting the words "two years" and replacing it with the words "nine (9) months", to read as follows:
 - "(7) require the owner to satisfy all conditions in recommendation 3, 4, 5 and 6 within a period of nine (9) months from the date of City Council approval, failing which the owner shall be required to reapply for the necessary zoning by-law amendment."
- (c) That the Draft Zoning By-law attached as Attachment 5, be amended by:
 - (i) deleting "Section 34" where it appears in the first recital in the By-law and replacing it with "Section 39" instead, to read as follows:
 - "WHEREAS authority is given to Council by Section 39 of the *Planning Act*, R.S.O. 1990, c.P. 13, as amended, to pass this By-law; and"
 - (ii) adding a new paragraph 5. to read as follows:
 - "5. This By-law shall be in effect for a period of one (1) year from the date of its passage."
- (2) adopt the following additional Recommendations (8), (9), (10), (11), (12) and (13):

- "(8) before introducing the necessary Bills to Council for enactment, require the owner to relinquish the existing boulevard parking permits granted for the previous industrial use:
- (9) require that the boulevard area in front of the building be landscaped to the satisfaction of the Director, Community Planning, Etobicoke York District, in consultation with the

Ward Councillor, as part of the Site Plan process, including reinstatement of the curb, all at no cost to the City;

- (10) require that the windows on the west elevation be replaced with a frosted louvred window detail or acceptable alternative in consultation with the Ward Councillor, through the Site Plan Approval process;
- (11) require that the owner obtain a building permit for conversion of the building from industrial to residential and complete the work pursuant to the building permit within one (1) year of the building permit being issued;
- (12) in the event the work pursuant to the building permit is not completed within the time period specified, require the Director of Buildings and Deputy Chief Building Official and the Director, Community Planning, Etobicoke York District, to report to the Etobicoke York Community Council on appropriate measures to take; and
- (13) deem that no further notice of a public meeting is required in respect of the proposed by-law pursuant to Section 34(17) of the *Planning Act*."

3.7 Final Report – Official Plan and Zoning Amendment Applicant: Sam Paglia, Westport Beach Development Corporation; Architect: Kirkor Architects – 3857-3867 Lake Shore Boulevard West and 96 Forty First Street (Ward 6 – Etobicoke-Lakeshore)

- (8) stopping be prohibited from 8:00 a.m. to 9:00 a.m. and from 3:00 p.m. to 4:00 p.m., Monday to Friday, on the north side of Ascot Avenue, between St. Clair Gardens and Dufferin Street;
- (9) parking be prohibited at other times Monday to Friday, and all times on Saturday and Sunday on the north side of Ascot Avenue, between St. Clair Gardens and Dufferin Street;
- (10) stopping be prohibited from 8:00 a.m. to 6:00 p.m., Monday to Friday, on the south side of Ascot Avenue from a point 74.5 metres west of Dufferin Street and a point 38.0 metres further west (School Bus Loading Zone); and
- (11) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto, including the introduction in Council of any bills that may be required.

On motion by Councillor Palacio, the Etobicoke York Community Council recommended that City Council adopt the staff recommendations in the Recommendations Section of the report (February 24, 2006) from the Director, Transportation Services, Etobicoke York District.

- (6) the applicant shall, prior to construction, obtain any Building Permits for stairs, retaining walls, guards, fire separations, plumbing and drainage, HVAC, basement renovations, change in occupancy and of any effected work related to the Ontario Building Code.

(Councillor Mammoliti declared an interest in this matter, in that his spouse owns property in the area.)

- (1) undertake a cumulative air quality assessment of all sources impacting Ward 6, including the following:
 - trans-boundary sources,
 - local industrial smokestack sources,
 - local industrial fugitive sources,
 - local mobile sources (road vehicles, trains etc.), and
 - local area sources; and
- (2) report to the June 13, 2006 meeting of the Etobicoke York Community Council, on the feasibility of conducting a cumulative local air quality modeling project in Ward 6, in consultation with local community stakeholders and the Industrial Association, to evaluate and verify all emissions inputs of air contaminants and their dispersion and concentration; and
- (3) identify a source of funding for this project.

3.75 Lay-by areas in front of condominium buildings along Lake Shore Boulevard West (Ward 6 – Etobicoke-Lakeshore)

On motion by Councillor Grimes, the Etobicoke York Community Council approved the following motion (April 4, 2007):

3.76 Request for Increase in Speed Limit from 60 km/h to 70 km/h on Lake Shore Boulevard West, north of the Gardiner Expressway and west of the Humber River (Ward 6 – Etobicoke-Lakeshore)

WHEREAS the posted speed limit on Lake Shore Boulevard West on the section running parallel, and to the north of the F. G. Gardiner Expressway and west of the Humber River is 60 km/h; and

WHEREAS there are few opportunities to affect the flow of traffic along this portion of Pine Street; and

WHEREAS the residents of Pine Street have indicated a definite and well defined need for the introduction of a one-way northbound operation on Pine Street between Lawrence Avenue West and Church Street;

NOW THEREFORE BE IT RESOLVED THAT the Director, Transportation Services, Etobicoke York District, be requested to conduct a poll of the residents of Pine Street between Lawrence Avenue West and Church to determine community support to convert this two-way street to one-way northbound, and report back with the results of the poll.
