### 1.1 Election of Chair and Vice-Chair

The Clerk's representative assumed the Chair and called for nominations for Chair. Councillor Miheve nominated Councillor Filion, who accepted. There being no further nominations, the Clerk's representative declared nominations closed.

#### **Confirmation of Minutes**

On motion by Fiona Nelson, the Minutes of the meeting of the Board of Health on November 28, 2005 were confirmed.

## **Chair/MOH Announcements:**

Councillor Filion, Chair, Board of Health, presented a Certificate of Recognition to Toronto Public Health employee, Diana Baxter, Health Planner, on behalf of the Board of Health, for her recent academic achievement. Diana received the gold medal for achieving the highest overall grade average in her class in the Diploma in Public Administration program, offered at the City of Toronto, through the University of Western Ontario, which program covers areas such as organizational management and behaviour as well as policy processes at the local government level.

## **1.2** Presentation – The Toronto Diabetes Atlas

A presentation on the Toronto Diabetes Atlas was provided by Dr. Richard Glazier, Staff Scientist, Inner City Health Research Unit, Department of Family and Community Medicine, University of Toronto, and from Gillian Booth, Centre for Research on Inner City Health, St. Michael's Hospital.

The Board of Health received the presentation and background material from Dr. Richard Glazier, Staff Scientist, Inner City Health Research Unit, Department of Family and Community Medicine, University of Toronto, and from Gillian Booth, Centre for Research on Inner City Health, St. Michael's Hospital, regarding The Toronto Diabetes Atlas.

# 1.3 Update on City Council Approved Toronto Public Health 2006 – 2010 Capital Plan and Budget

The Board of Health considered a report (January 6, 2006) from the Medical Officer of Health, providing an update on the Toronto Public Health (TPH) 2006 - 2010 Capital Plan and Budget approved at the City Council meeting of December 8 - 9, 2005.

## Recommendation:

It is recommended that the Medical Officer of Health report to the Board of Health through the Board of Health Budget Subcommittee on a revised 5-year capital plan for Toronto Public Health in the Spring of 2006.

The Board of Health adopted the staff recommendation in the Recommendations Section of the report (January 6, 2006) from the Medical Officer of Health.

## 1.4 2006 Community Investment Program Budgets

The Board of Health considered a report (January 6, 2006) from the Medical Officer of Health, seeking approval for the 2006 budget request for investment programs reporting through the Board of Health, including AIDS Prevention, Drug Prevention and Student Nutrition.

### Recommendations:

It is recommended that:

- (1) the 2006 Operating Budget request for the Community Partnership and Investment Programs Service Envelope under the purview of the Board of Health in the amount of \$5.862 million gross and net, comprised of a base budget of \$4.725 million gross and net and New/Enhanced service requests of \$1.137 million for the Student Nutrition Program be approved;
- (2) the report be forwarded to the Budget Advisory Committee for consideration; and
- (3) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.
- A. Councillor Miheve moved that the Board of Health recommend to the Budget Advisory Committee that:
  - (1) the Budget Advisory Committee adopt the staff recommendations in the Recommendation Section of the report (January 6, 2006) from the Medical Officer of Health, as follows:

- (3) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

1.7 Public Health Agency of Canada funding for "A Skills Building Workshop: The Impact of Crack Smoking and Crystal Methamphetamine Use on Hepatitis C Transmission of Drug Users in Ontario"

transmission and crack smoking and crystal methamphetamine for staff of Ontario Needle Exchange Programs and other relevant staff;

- an amount of \$68.0 thousand gross and \$68.0 thousand in federal funding revenue be added to the 2006 Toronto Public Health Operating Budget to support the development of the Skills Building Workshop;
- this report be forwarded to Budget Advisory Committee for consideration in the 2006 Budget process; and
- (4) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

- (3) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

### 1.10 Reducing Children's Exposures on Board School Buses – Ontario and Toronto

The Board of Health considered a report (January 4, 2006) from the Medical Officer of Health, examining children's exposure to air pollutants on board school buses and consider actions that can be taken nationally, provincially and locally to reduce these exposures.

#### Recommendations:

#### It is recommended that:

- (1) request that Environment Canada establish a multi-year Healthy School Bus Fund to support programs developed by provincial governments and other organizations that are directed at the dual goals of reducing childhood exposure to diesel-related air pollutants and improving local air quality;
- (2) request that the Ontario Ministry of the Environment establish a multi-year Healthy School Bus Program that has the dual goals of reducing childhood exposure to diesel-related air pollutants and improving local air quality by:
  - (a) ensuring the retirement of all pre-1994 model year school buses by 2007;
  - (b) encouraging the replacement or retrofitting of all 1994-2003 model year school buses by 2011;
  - (c) encouraging the use of catalyzed diesel particulate filters when retrofitting 1994-2003 model year school buses;
  - (d) encouraging the installation of closed crankcase filtration devices in all school buses in Ontario;
  - (e) supporting demonstration projects that promote the development of alternative technologies and fuels; and
  - (f) developing, in collaboration with Natural Resources Canada, the Ontario School Bus Association, and Ontario school boards, a module on proper idling, fuel management, and low emission driving practices, to be included in the provincial training program for school bus operators:
- (3) encourage Toronto school boards to work with their school bus operators to develop:
  - (a) Healthy School Bus Plans that identify the actions that can be taken to reduce childhood exposure to diesel-related air pollutants;
  - (b) formal school bus idling policies designed to reduce childhood exposure to diesel-related air pollutants;
  - (c) education for school bus operators that emphasizes proper idling and fuel management practices;
- (4) send copies of this report to all Ontario Medical Officers of Health, the GTA Clean Air Council, the Canadian Partnership for Children's Health and Environment (CPCHE), the Association of Local Public Health Agencies, the Canadian Public Health Association (CPHA), the Ontario School Bus Association (OSBA) which represents the school bus operators in the province, and the Ontario Public Health Association (OPHA); and
- (5) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

The Board of Health also considered a communication (January 18, 2006) from Karen Buck.

The Board of Health considered a communication (November 25, 2005) from the City Clerk, advising that City Council, at its meeting on November 24, 2005, referred Consolidated Clause 6(a) in Works Committee Report 9, entitled "Draft Terms of Reference for the Peer Review of the Biosolids and Residuals Master Plan Decision Making Model" to the Board of Health.

#### A. Councillor Fletcher moved that the Board of Health recommend that:

- (1) the report (September 28, 2005) from the Acting General Manager, Toronto Water and the Medical Officer of Health contained Consolidated Clause 6a, Works Committee Report 9, be referred back to the General Manager, Toronto Water and the Medical Officer of Health, in order to:
  - (a) allow the Medical Officer of Health, Deputy City Manager Fareed Amin and the General Manager, Toronto Water, to amend the draft Terms of Reference for the Peer Review of the Biosolids and Residuals Master Plan Decision Making Model, to include the following:
    - (i) guiding principles of the Main Treatment Plant Environmental Assessment Mediation Agreement;
    - (ii) the Peer Review Panel to mediate with signatories to the Main Treatment Plant – Environmental Assessment – Mediation Agreement;

- (iii) the Peer Review Panel address:
  - (a) assumptions within the Mediation Agreement; and
  - (b) completeness and correctness of the information that informed decisions in the Master Plan;
- (iv) a prerequisite for the Peer Review Panel must be a full working knowledge of biosolids use and facilitation skills;
- (v) public consultation take place as part of the peer review;
- (b) report back to the Works Committee and the Board of Health on the revised draft Terms of Reference for the Peer Review of the Biosolids and Residuals Master Plan Decision Making Model;
- (2) Deputy City Manager Fareed Amin be urged to expedite the creation of the 100 percent Biosolid Beneficial Use Committee adopted by City Council in 2005, and that the Medical Officer of Health and Toronto Public Health staff be involved; and
- (3) the report from the Peer Review Panel be submitted to the City's 100 percent Biosolid Beneficial Use Committee, prior to the report being considered by the Works Committee and the Board of Health.
- B. Councillor Davis moved that the Board of Health also request the Medical Officer of Health, Deputy City Manager Fareed Amin and the General Manager, Toronto Water, to amend the draft Terms of Reference for the Peer Review of the Biosolids and Residuals Master Plan Decision Making Model to provide greater flexibility in terms of the amount of time allocated for the steps of the peer review process and to ensure that the process is as transparent as possible to include stakeholders throughout.
