Confirmation of Minutes

On motion by Valerie Sterling, the Minutes of the meeting of the Board of Health on February 27, 2006 were confirmed.

3.1 Annual Report from the Toronto Food Policy Council (TFPC)

The Board of Health considered a report (March 27, 2006) from the Medical Officer of Health, presenting the Toronto Food Policy Council's annual report outlining major activities during 2005.

Recommendation:

It is recommended that this report be received for information.

Janice Etter, Community Co-Chair, and Dr. Wayne Roberts, Project Co-ordinator, Toronto Food Policy Council gave a brief presentation.

The Board of Health:

- (1) received the presentation from Janice Etter, Community Co-Chair, and Dr. Wayne Roberts, Project Co-ordinator, Toronto Food Policy Council; and
- (2) received the report (March 27, 2006) from the Medical Officer of Health.

3.2 Toronto Public Health and Integrated Service Planning for Children

The Board of Health considered a report (March 28, 2006) from the Medical Officer of Health, providing an overview of Toronto Public Health's participation in the City's integrated service planning for children and the City's planning for Best Start, which report includes a summary of how the issues and recommendations identified in both "The Health of Toronto's Young Children: First Two Reports" and the "Improving the Mental Health of Young Children in Toronto: Needs Assessment and Literature Review" will be linked to this planning. The report also seeks Board of Health endorsement of the "Best Start Plan - Toronto Vision for Children".

Recommendations:

It is recommended that:

- (1) the Board of Health endorse the Toronto Best Start Network's *Best Start Plan – Toronto Vision for Children*;
- (2) the Medical Officer of Health report back to the Board of Health on the specific services that Toronto Public Health will provide in the Best Start Hubs, including any resource implications;

- (3) the Board of Health ask the Federal Government to complete and make public a health impact assessment of their child care funding policy prior to implementation; and
- (4) the appropriate City officials be authorized and directed to take the necessary action to give effect hereto.
- A. Valerie Sterling moved that the Board of Health adopt the staff recommendations in the Recommendations Section of the report (March 28, 2006) from the Medical Officer of Health, with Recommendation (1) being deleted and replaced with the following instead:
 - “(1) the Board of Health endorse the Toronto Best Start Network’s Best Start Plan – Toronto Vision for Children, Consultation and Planning Phase 2006-2011;”.

3.3 Early Child Development Family Abuse Prevention Project Actions to Prevent Physical Punishment of Children

The Board of Health considered a report (March 28, 2006) from the Medical Officer of Health, providing a summary and accomplishments to date of the Early Child Development Family Abuse Prevention Project activities focused on the prevention of physical punishment of children and the promotion of positive discipline.

Recommendations:

It is recommended that:

- (1) the Board of Health request the Ontario Ministers of Children and Youth Services, Health and Long-Term Care, and Health Promotion to:
 - (a) recognize physical punishment of children as a form of violence that puts children at risk for abuse and other social and emotional challenges;

- (b) ensure that physical punishment prevention is an integral part of programs mandated to reduce child abuse;
 - (c) incorporate strategies to reduce physical punishment of children in the Healthy Children Program Standards of the “Mandatory Health Programs and Services Guidelines” as a way of reaching the public health goal of increasing the percentage of children and youth who meet physical, cognitive, communication, and psychosocial developmental milestones; and
 - (d) sustain funding for child abuse prevention initiatives, such as the Toronto Public Health Physical Punishment Prevention Project;
- (2) the Board of Health request the Ontario Minister of Education to amend the Ontario Education Act to prohibit the use of physical punishment as a form of correction, as has happened in all provinces and territories except for Ontario, Manitoba, and Alberta;
 - (3) this report be forwarded to the General Managers of City of Toronto Children’s Services, Parks, Forestry and Recreation, Shelter, Housing and Support, and the City Librarian for their information and for consideration of adopting a position and policy on physical punishment of children and youth;
 - (4) this report be forwarded to the Canadian Community Health Survey Division of Statistics Canada to request ongoing surveillance and reporting of public knowledge, attitudes, and behaviour related to discipline and physical punishment of children at the local, provincial, and national level in order to inform program planning;
 - (5) this report be forwarded to the Canadian Centre of Excellence for Child Welfare:
 - (a) to commend them for providing relevant data on the incidence of maltreatment which includes the incidence of physical abuse resulting from physical punishment; and
 - (b) to request that they continue their nation-wide study examining the incidence of reported child maltreatment and the characteristics of children and families investigated by Canadian child welfare services;
 - (6) this report be forwarded to all public health units in Ontario and the Association of Local Public Health Agencies with a copy of the Toronto Public Health Position and Policy on Physical Punishment of Children to encourage them to take similar action;

- (7) this report be forwarded to the Toronto District School Board, the Toronto Catholic District School Board, the French Public District School Board, the French Catholic District School Board, the Ontario Public Health Association, the Canadian Public Health Association, and the Public Health Agency of Canada with a copy of the Toronto Public Health Position and Policy on Physical Punishment of Children for their information; and
- (8) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

- (1) adopt the staff recommendations in the Recommendations Section of the report (March 28, 2006) from the Medical Officer of Health; and
 - (2) continue to support the repeal of Section 43 of the Criminal Code of Canada.

3.4 Sole Source Contract for 100% Provincially Funded Incredible Years Parent, Teacher and Child Programs

The Board of Health considered a report (March 22, 2006) from the Medical Officer of Health, seeking Council authority to exceed the \$500,000 limit to enter into a sole contract with The Incredible Years Organization for the provision of training,

consultation, and program materials related to The Incredible Years Parent, Child and Teacher Programs.

Recommendations:

It is recommended that:

- (1) the Medical Officer of Health be authorized to award and execute a purchase of service contract in 2006 with The Incredible Years in the amount of \$200,000 USD including all taxes and charges; and
- (2) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

The Board of Health:

- I. recommended that the Policy and Finance Committee adopt the staff recommendations in the Recommendations Section of the report (March 22, 2006) from the Medical Officer of Health, as follows:

3.5 Donated Funds in Support of Animal Services

The Board of Health considered a report (March 28, 2006) from the Medical Officer of Health, seeking authority for Toronto Animal Services to receive and use specified bequests, donations and grants; and to receive approval to amend the 2006 Toronto Public Health (TPH) Operating Budget accordingly.

Recommendations:

It is recommended that:

- (1) a grant in the amount of \$10,000 from PetSmart Charities of Canada Incorporated be accepted for the pre-adoption spay/neuter program for dogs and cats;
- (2) the Medical Officer of Health be authorized to execute an agreement between the City and PetSmart Charities of Canada Incorporated (referred to in Recommendation 1) in such form that is satisfactory to the City Solicitor and upon such terms and conditions that are satisfactory to the Medical Officer of Health;
- (3) a bequest of \$64,000 bequest be accepted and used for improvements to the adoption program in the West Region Animal Centre;
- (4) the balance of the funds in the Animal Control (York) Reserve Fund be transferred to the 2006 TPH Operating Budget - Animal Services Program for the purpose of assisting animals in the care and custody of Toronto Animal Services;
- (5) once the balance of funds in the Animal Control (York) Reserve Fund is zero, that authorization be granted for the closure and the deletion of the reserve account from Municipal Code 227 (Reserves and Reserve Funds);
- (6) an additional amount of \$86,000 gross expenditure and additional \$86,000 revenue be added to the 2006 Toronto Public Health Operating Budget Animal Services Program for improvements to the Animal Services Program;
- (7) the Medical Officer of Health report back to the Board of Health on appropriate policies and financial mechanisms to facilitate the receipt and use of grants and donations for Toronto Animal Services;
- (8) this report be forwarded to the Policy and Finance Committee on April 11, 2006 due to time constraints for the use of the funding;
- (9) that leave be granted for the introduction of any necessary bills in Council to give effect thereto; and
- (10) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

- (10) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

3.7 Coyote Sightings/Incidents in the City of Toronto in 2005

The Board of Health considered a report (March 28, 2006) from the Medical Officer of Health, providing information on reported sightings and incidents related to coyotes in 2005 and the resulting actions taken by Animal Services staff.

Recommendations:

It is recommended that the requirement for annual reporting of coyote sightings/incidents be discontinued, since the number of coyote sightings has dropped and none were considered a safety threat to the community in 2005.

3.8 Pandemic Influenza Plan for the City of Toronto

The Board of Health considered a report (April 4, 2006) from the Medical Officer of Health, presenting an update on the status of pandemic influenza preparedness since November 2005.

3.16 Request for Proposed Pilot Project to Suspend Flouridation of Toronto's Drinking Water for Biosolids Improvement

The Board of Health considered a communication (March 16, 2006) from Karen Buck and Karey Shinn, Co-Chairs, The Ashbridges Bay Treatment Plant Neighbourhood Liaison Committee, requesting that the addition of fluoride (hydrofluorosilic acid) to Toronto's drinking water be stopped (suspended) for the time period beginning April 1, 2006 to September 30, 2006 in order to monitor the pH (of the drinking water) and the metals levels in the biosolids; and further requesting that the Department of Health through direction of the Board of Health consider this request and provide a response to the Co-Chairs in April 2006.

On motion by Fiona Nelson, and in accordance with Section 38, New Business, of By-law No. 1-1998 to govern the proceedings of the Board of Health for the City of Toronto Health Unit, the Board of Health, by two-thirds vote, decided to consider a request from Fiona Nelson regarding a request for Meeting with the Four Local Health Committee Members.

The Board of Health considered the following Resolution adopted by the Toronto East York Local Health Committee, submitted by Fiona Nelson, Board Member:

“That Board of Health Members be invited to meet with members of the four Local Health Committees on Monday, June 19, 2006 to discuss and promote advocacy of Local Health Committee priority issues. The meeting will be from 11:30 a.m. to 1 p.m., before the scheduled Board of Health meeting.”

On motion by Fiona Nelson, the Board of Health accepted the invitation to meet with the members of the four Local Health Committees and directed that the meeting be held on June 19, 2006 from 11:30 a.m. to 1:00 p.m., before the scheduled Board of Health meeting on that date.

3.20 Petition to the Federal Leaders and Provincial Premiers to Honour the Child Care Agreements

On motion by Fiona Nelson, and in accordance with Section 38, New Business, of By-law No. 1-1998 to govern the proceedings of the Board of Health for the City of Toronto Health Unit, the Board of Health, by two-thirds vote, decided to consider a request from Fiona Nelson regarding a Petition to the Federal Leaders and Provincial Premiers to Honour the Child Care Agreements.

The Board of Health considered the following Petition (April 10, 2006) adopted by the Toronto East York Local Health Committee, submitted by Fiona Nelson for endorsement by the Board of Health:

“To Stephen Harper, Provincial Premiers and Federal Opposition Leaders:

Honour the Child Care Agreements

We are calling on you to work together to honour the promise of a national child care program. The place to start is by protecting the early learning and child care agreements between the Government of Canada and the provinces. The federal-provincial agreements on child care were negotiated in good faith. They lay a foundation for a full system of early learning and child care that can meet the needs of all Canadian families. Cancelling them sets back the development of a national child care program for years to come, leaving families with young children to fend for themselves.

Breaking federal-provincial child care agreements would be a breach of public trust and would lead to a cut of almost \$4 billion from child care funding. The federal election results were not a mandate to turn back the clock on child care. We welcome and support your election promise of income support for families, a taxable family allowance and a tax credit for employers, but we also strongly support early learning and child care services that are high quality, available and affordable. Families need both income supports and publicly funded child care services. We call on all governments to protect and enhance progress on child care.

We also strongly recommend that both programs (income support and publicly funded child care) be legislated as soon as possible.”

On motion by Fiona Nelson, the Board of Health endorsed the Petition (April 10, 2006) adopted by the Toronto East York Local Health Committee.
