Confirmation of Minutes

On motion by Fiona Nelson, the Minutes of the meeting of the Board of Health on May 15, 2006 were confirmed.

Chair/MOH Announcements:

The Medical Officer of Health announced that Dr. Fran Scott, Director and Associate Medical Officer of Health, has recently been appointed as Director, Community Medicine Residency Program, at the University of Toronto. The Medical Officer of Health also advised that Dr. Fran Scott, will still be employed by Toronto Public Health, but in a different role, which will take into account her recent appointment by the University of Toronto.

5.1 Access to Environmental Information

The Board of Health considered a report (June 5, 2006) from the Medical Officer of Health, reporting on a review of access to environmental information in Toronto, and propose a mechanism for additional consultation and future implementation of strategies to increase municipal and public access to such information.

Recommendations:

It is recommended that:

- (1) the Medical Officer of Health, in collaboration with the Executive Environment Team:
 - (a) identify what environmental information currently held by the City could be shared within the corporation and what could be made available to the public, and develop and implement plans to make this information more available and accessible; and
 - (b) report to the Board of Health early in 2007 on progress in making environmental information currently held by the City more accessible within the corporation and to the public;
- (2) the Medical Officer of Health, in collaboration with the Executive Environment Team:
 - (a) consult with stakeholders in the business community, labour groups, environmental and health organizations and community groups to identify information needs, barriers and opportunities for enhanced access to environmental information:
 - (b) report to the Board of Health early in 2007 on the results of the stakeholder consultation with the recommendations for future action;
- (3) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

- A. Councillor Filion moved that the Board of Health adopt the staff recommendations in the Recommendations Section of the report (June 5, 2006) from the Medical Officer of Health.
- B. Councillor Fletcher moved that the Board of Health adopt the following amendment to staff Recommendation (1):
 - "that staff recommendation (1) be amended by adding the following recommendation (1) (c):
 - "(1)(c) that a Community-Right-To-Know (CRTK) pilot project be undertaken at a City facility, with the following parameters:
 - (i) select a facility that uses 'priority' toxic substances;
 - (ii) track toxic substance use and discharge through a 'materials account balance' method;
 - (iii) develop and implement a pollution prevention plan; and
 - (iv) report tracking and pollution prevention plans and activities to the public;".
- C. Valerie Sterling moved that staff recommendation (2)(a) be deleted and replaced with the following recommendation instead:
 - "(2)(a) consult with stakeholders in the business community, labour groups, environmental and health organizations and community groups to identify information needs, barriers and opportunities for enhanced access to environmental information, as well as addressing the potential next steps identified in the report entitled 'Access to Environmental Information: Preventing Pollution, Avoiding Risks'.

- D. Councillor Mihevc moved that the Board of Health endorse the following principles to guide the City's development of a Community Right To Know (CRTK) strategy, which strategy will:
 - (a) provide consistent and timely information on toxic chemicals used, stored and released in Toronto by location and facility;
 - (b) encourage and support economically and environmentally sustainable business practices through pollution prevention planning and toxic use reduction activities;
 - (c) focus on toxic chemicals that contribute to one or more of the following:
 - (i) occupational and environmental cancer;
 - (ii) poor air quality in Toronto;
 - (iii) damaging children's health; and
 - (iv) prevalence of Persistent Organic Pollutants in our environment;
 - (d) generate information disclosure from facilities that are highly likely to use and/or release toxic chemicals based on the above criteria and are located where people live; and
 - (e) ensure an efficient, effective system for reporting and retrieving information such as a searchable web-based database.
- E. Councillor De Baermaker moved that the Board of Health:
 - (1) support and request the Medical Officer of Health to work with other City staff to expand the City's online "Environmental Portal" to include the following information in a searchable format:
 - (a) sewer-use by-law and pesticide by-law non-compliance/infraction incidences;
 - (b) notices and information on Environmental Assessments underway in Toronto;
 - (c) applications and decisions on provincial Certificates of Approval to discharge to air or other environmental mediums in Toronto; and
 - (d) formal City submissions to other levels of government regarding environmental instruments

and policy (e.g. waste oil comment and nuclear energy comment); and

- (2) request the Medical Officer of Health to report to the Board of Health meeting on February 2007, on the following:
 - (i) investigate a process and opportunities to make the pollution prevention plans and their results under the sewer-use by-law publicly available; and
 - (ii) explore options for enhanced reporting on pesticide products applied on outdoor properties in the City;
 - (iii) outline ways and means to ensure that any Right To Know program be self-financing to the greatest extent possible; and
 - (iv) address the issues raised in the communications filed with the Board of Health and by those persons who addressed the Board of Health at its meeting on June 19, 2006.

Councillor Fletcher moved that the Board of Health request the Medical Officer of Health to provide an update at the Board of Health meeting on September 13, 2006, and at its first meeting in 2007, on the following points outlined in the communication (June 19, 2006) from the Toronto Environmental Alliance:

 - (ii) further measures which can be undertaken resulting from the Community Right to Know (CRTK) pilot project; and
 - (iii) the principles to guide the City's development of a CRTK strategy.

5.2 2006 Smoke-Free Ontario Initiative Funding

The Board of Health considered a report (June 5, 2006) from the Medical Officer of Health, seeking approval to receive 100% provincial base funding in the amount of \$2,357,532 and one-time funding in the amount of \$265,000 for the period of January 1, 2006 to December 31, 2006 from the Ministry of Health Promotion (Smoke-Free Ontario) to enhance Toronto Public Health's Tobacco Control programs.

Recommendations:

It is recommended that:

- an amount of \$255,900 gross expenditures and \$394,582 revenue, for a net reduction of \$138,682, and two positions be added to the Toronto Public Health 2006 Operating Budget to support the 2006 Smoke Free Ontario Initiatives;
- (2) one-time funding of \$265,000 gross expenditures and \$265,000 revenue, for zero net impact, be added to the Toronto Public Health 2006 Operating Budget to carry-forward 2005 Provincial funding in support of the tobacco prevention initiatives;
- (3) that the Board of Health advocate to the Ministry of Health Promotion to increase 100% funding to fully support inspection and enforcement activities at the current level;
- (4) this report be forwarded to the Budget Advisory Committee and Policy and Finance Committee for its consideration; and
- (5) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Councillor Fletcher, and in accordance with Section 38, New Business, of By-law No. 1-1998 to govern the proceedings of the Board of Health for the City of Toronto Health Unit, the Board of Health, by two-thirds vote, decided to consider a request from Councillor Fletcher, regarding a request for review under the Environmental Bill of Rights of the Certificate of Approval issued by the Ontario Ministry of the Environment to the Portlands Energy Centre

 - (2) that the City of Toronto request the current Ontario Government to revisit the recommendations of the Ontario Advisory Committee on Environmental Standards Committee and consider the more health protective standard be required.
- B. Fiona Nelson moved that the Board of Health endorse the following recommendations in the communication (May 10, 2004) from Ruth Grier, Co-Chair, Toronto Cancer Prevention Coalition, Occupational and Environmental Carcinogens Working Group:
 - (1) that the City of Toronto test and report information on tritium and other radionuclides both in the raw water of Lake Ontario and in Toronto's drinking water and include these results in your annual report on drinking water required by the Ontario Drinking Water Standards; and
 - (2) that the City of Toronto request that the current Ontario Government revisit the recommendations of the Ontario Advisory Committee on Environmental Standards Committee and consider the more health protective standard be required.
