The Works Committee rose and observed a moment of silence in memory of the Victims of September 11, 2001 (9/11).

Confirmation of Minutes

On motion by Councillor Palacio, the Minutes of the meeting of the Works Committee held on July 5, 2006, were confirmed.

6.1 Appointment of Councillor Harvey Barron to the Works Committee

The Works Committee considered a communication (August 11, 2006) from the City Clerk advising that City Council on July 25, 26 and 27, 2006, appointed Councillor Harvey Barron to the Works Committee, to replace former Councillor Gerry Altobello, for a term of office ending November 30, 2006, and until his successor is appointed.

The Works Committee received the communication from the City Clerk.

Report 6, Clause 40(a)

6.2 CEAT Public Consultation on Terms of Reference for Environmental Assessment of a Long-Term Post-Division Solid Waste Management System

The Works Committee considered a report (August 25, 2006) from the General Manager, Solid Waste Management Services providing an update on the progress of the Community Environmental Assessment Team with respect to the communications, outreach, stakeholder engagement and public consultation plan.

Recommendations:

It is recommended that:

- (1) the General Manager, Solid Waste Management Services, be authorized to issue a request for proposals to hire a facilitator to plan and co-ordinate public consultation sessions outside of the City of Toronto in connection with the City's Environmental Assessment of a long-term post-diversion solid waste management system; and
- (2) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

Philip Knox Chair, CEAT, addressed the Works Committee.

On motion by Councillor Carroll, the Works Committee:

(A) recommended that the staff recommendations in the Recommendations Section of the report (August 25, 2006) from the General Manager, Solid Waste Management Services be deleted and replaced with the following:

"It is recommended that:

- (1) the resignations of David Evans and Ian Caldwell from the City of Toronto's Community Environmental Assessment Team be received;
- (2) City Council appoint replacement members from the existing pool of Community Environmental Assessment Team candidates for the term of the project; all members to be appointed conditional on entering into an agreement with the City of Toronto covering such topics as honoraria, treatment of confidential information, conflict of interest and other City policies, in a form satisfactory to the City Solicitor, and providing a biography to be available to the public;
- (3) the General Manager, Solid Waste Management Services, be authorized to take all expedient steps, including a sole source procurement process following consideration of a minimum of three candidates, in order to hire a public facilitation consultant or company to plan and co-ordinate public consultation sessions outside of the City of Toronto in connection with the City's Environmental Assessment of a long-term post-diversion solid waste management system; and
- (4) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto."; and
- (B) requested Councillor Carroll, as Chair of the Works Committee and Community Environmental Assessment Team Nominating Panel, in consultation with the other Nominating Panel members (i.e., Deputy Mayor Bussin and Councillors Giambrone and Pitfield), to review the list of remaining interviewed candidates and forward a recommended list of up to five candidates under confidential cover to the City Clerk for inclusion with this Clause when it is considered by Council at its meeting on September 25, 2006.

6.3 2005 Expenditures Against Sole Source Contract 47009985 – Ontrac Equipment

The Works Committee considered a report (August 21, 2006) from the General Manager, Solid Waste Management Services and the Director, Purchasing and Materials Management identifying the 2005 expenditures to Solid Waste Management Services sole source equipment maintenance vendors and including a request for authority to increase the 2005 contract target value for Contract No. 47009985 - Ontrac Equipment from \$450,000.00 to \$650,000.00.

Recommendations:

It is recommended that:

- (1) staff be authorized to amend the sole source blanket contract 47009985 (for the period January 1, 2005-December 31, 2005) for Ontrac Equipment Services Inc., by increasing its total value of \$450,000.00 by \$200,000.00 to \$650,000.00; and
- (2) the appropriate officials be authorized and directed to take the necessary actions to give effect thereto.

On motion by Councillor De Baeremaeker, the Works Committee recommended that City Council adopt the staff recommendations in the Recommendations Section of the report (August 21, 2006) from the General Manager, Solid Waste Management Services.

6.4 2007 Divisional Estimated Budget Requests for Waste Diversion Programs

The Works Committee considered a report (August 15, 2006) from the General Manager, Solid Waste Management Services respecting the City divisions' 2007 estimated budget submissions for waste diversion programs, and requesting submission of new waste diversion plans, covering 2007 to 2010, by City Agencies, Boards, Commissions, Divisions and Schools.

Recommendations:

It is recommended that:

- (1) the Works Committee approve the 2007 estimated budget amounts for divisional waste diversion programs, subject to review and approval by the 2007 budget review process; and
- (2) City Agencies, Boards, Commissions and Divisions and Schools be required to submit a four-year waste diversion plan (2007 to 2010) to the General Manager, Solid Waste Management Services by December 31, 2006, that will outline how Council's waste diversion targets will be met, and to submit annual updates at the end of each year to the General Manager, Solid Waste Management Services.

On motion by Councillor Del Grande, the Works Committee recommended that City Council adopt the staff recommendations in the Recommendations Section of the report (August 15, 2006) from the General Manager, Solid Waste Management Services.

6.5 Recycling of Fluorescent Tubes and Other Light Bulbs Containing Hazardous Materials

The Works Committee considered a report (August 15, 2006) from the General Manager, Solid Waste Management Services responding to the request of the Works Committee on July 5, 2006, to report on the status and effectiveness of the light bulb recycling programs in place at City facilities and facilities operated by Toronto agencies, boards and commissions, and on the feasibility of developing a corporate policy for the safe and efficient recycling of fluorescent lamps, metal halide light bulbs or other light bulbs that contain mercury or other potentially hazardous materials such as mercury and other gases.

Recommendation:

It is recommended that the City's Waste Diversion Team work with the City's Agencies, Boards, Commissions and Divisions to implement recycling programs for fluorescent lamps or light bulbs containing hazardous materials, where required, and that the General Manager of Solid Waste Management Services report back to the Works Committee in August 2007 regarding the progress of this implementation.

On motion by Councillor Ainslie, the Works Committee recommended that City Council adopt the staff recommendations in the Recommendations Section of the report (August 15, 2006) from the General Manager, Solid Waste Management Services.

Report 6, Clause 4

6.6 Recycling Container Capacity

The Works Committee considered the following:

 Report (August 23, 2006) from General Manager, Solid Waste Management Services providing the results of the City's recycling container capacity pilot and recommending a new collection container system for Blue Box materials for single-family homes.

Recommendations:

It is recommended that:

- (1) a semi-automated recycling cart pilot that provides residents with a large wheeled cart to store and set out their Blue Box materials be implemented at approximately 1,000 homes in the downtown core this fall in order to confirm operational acceptability;
- (2) approval be granted to roll-out a City-wide semi-automated cart system for Blue Box materials for single-family homes between fall 2007 and fall 2008, subject to pre-approval of \$28.5 million in capital funds and \$330,000.00 in 2007 operating funds and confirmation from the pilot that carts are operationally acceptable in the downtown core; and
- (3) if the General Manager of Solid Waste Management Services concludes that the pilot in the downtown core demonstrated that certain areas are not suitable for cart collection, a further report be submitted to the Works Committee outlining the type of collection system for those areas.
- (ii) Communication (September 11, 2006) from Councillor Paula Fletcher, Ward 30, Toronto-Danforth, respecting excess packaging and submitting recommendations in regard thereto.

The following persons addressed the Works Committee:

The Works Committee:

- (A) recommended to the Policy and Finance Committee that:
 - (1) City Council adopt the staff recommendations in the Recommendations Section of the report (August 23, 2006) from the General Manager, Solid Waste Management Services;

(2) the Provincial Government be requested to immediately review the situation regarding excess packaging, including requirements for plastics, with a view to amending Provincial regulations and legislation or the *City of Toronto Act* to reduce excess packaging; and limit plastics used in Ontario to ones that are recyclable; and

(Motion by Councillor Fletcher)

(3) the results of the City's task force on excess packaging be forwarded to the new Public Works and Infrastructure Committee;

(Motion by Councillor Fletcher)

- (B) requested:
 - (a) the City Manager to report to the appropriate Standing Committee on what steps are available to include source reduction, reuse and/or recycling considerations into the City's procurement requirements in any purchase of service or RFP issued by the City; and

(Motion by Councillor Fletcher)

- (b) the General Manager, Solid Waste Management Services to include the following programs in the 2007 Solid Waste Management Services budget submission for consideration during the 2007 budget process:
 - Bag Limit Reduction from 6 to 4 every two weeks;
 - Enforcement of Mandatory Waste Diversion By-law;
 - Multi-Unit Levy;

- Door-to Door Recycling at town homes;
- Reuse Centre at Ingram Transfer Station; and
- addition of three new materials to the Blue Box System;

and further that the provision of SSO collection in multi-unit buildings be included in the Solid Waste Management Services Budget request as soon as processing capacity is available.

6.7 Status of the Pilot Study for Green Bin Collection from City Facilities and Feasibility of Implementing a Green Bin Program for all City Agencies, Boards, Commissions and Divisions

The Works Committee considered a report (August 15, 2006) from the General Manager, Solid Waste Management Services responding to the request of the Works Committee on July 5, 2006, to report on the status of the pilot study for Green Bin Collection from City facilities and on the possibility of implementing a Green Bin program permanently for City Agencies, Boards, Commissions and Divisions.

Recommendation:

It is recommended that this report be received for information only.

Rod Muir, Waste Diversion Toronto, addressed the Works Committee.

On motion by Councillor Giambrone, the Works Committee received the report from the General Manager, Solid Waste Management Services.

6.8 Planning Study for an Expanded SSO Processing System Status Report

The Works Committee considered a report (August 25, 2006), addressed to the SSO Sub-Committee of the Works Committee, from the General Manager, Solid Waste Management Services providing an update of the progress-to-date on the status of Toronto's SSO programs and processing contracts and submitting a number of recommendations on how to proceed.

Recommendations:

It is recommended that:

- (1) the General Manager, Solid Waste Management Services be directed to complete the Planning Study for an Expanded Public SSO Processing System by evaluating the potentially suitable City-owned sites identified to date, including planned public consultation, and determining the preferred system that could be developed using the City-owned sites identified to date;
- (2) concurrent with the completion of the study described in Recommendation (1), the General Manager, Solid Waste Management Services, in consultation with appropriate staff from Planning and Facilities and Real Estate Divisions, be directed to conduct a preliminary evaluation of the implications, advantages and disadvantages of expanding the study to include other appropriate public and private lands and report back with:
 - (a) the results of the study described in Recommendation (1) including the identification of the preferred system that could be developed using City-owned sites;
 - (b) an assessment, in general terms (i.e., without identifying specific sites), of options for other appropriate public and private lands and a discussion of the advantages and disadvantages of expanding the study to include those lands; and
 - (c) a recommendation as to whether the City should proceed with a system using only City-owned sites identified to date or expand the study to include other appropriate public and private lands;
- (3) the General Manager, Solid Waste Management Services be authorized to negotiate and enter into agreements with the City's current SSO processing contractors to amend the current SSO processing agreements, and/or negotiate and enter into agreements with other SSO processing contractors, as required to meet the City's SSO processing needs, for a term of three to five years and on terms and conditions satisfactory to the General Manager, Solid Waste Management Services, and in a

form satisfactory to the City Solicitor, provided however that the prices shall not exceed the prices shown in Attachment 1 – Confidential Pricing Information;

- (4) the General Manager, Solid Waste Management Services be authorized to explore opportunities with other municipalities and public bodies and agencies for SSO processing capacity and report back with the results of the discussions;
- (5) the General Manager, Solid Waste Management Services be authorized to terminate negotiations with any preferred respondent under RFP 9155-03-5280 issued October 17, 2003, for the Provision of Processing Capacity for Source Separated Organic Material if an agreement has not been finalized by November 30, 2006, or, if no agreements have been finalized by that date, to cancel the RFP process; and
- (6) if the negotiations described in Recommendation (5) do not result in sufficient capacity, the General Manager, Solid Waste Management Services, in co-operation with the Director, Purchasing and Materials Management Division, be authorized to issue a request for proposals for processing capacity at public or private facilities in Ontario for up to 100,000 tonnes per year of SSO and options for up to 100,000 tonnes per year of five to seven years and as otherwise described in Attachment 2 Key Terms of Request for Proposals.

On motion by Councillor Giambrone, the Works Committee recommended that:

- (a) City Council adopt Recommendations (1), (3), (4), (5) and (6) in the Recommendations Section of the report (August 25, 2006) from the General Manager, Solid Waste Management Services;
- (b) Recommendation (2) be referred to Council without recommendation, pending the re-opening by City Council of Council's amendment under part (a) of Recommendation (2) contained in Clause 23c of Report 2 of the Works Committee, headed "Planning Study for an Expanded Public Source Separated Organic Processing System Recommendations Regarding Sites and Technologies", adopted by City Council on June 27, 28, and 29, 2006; and
- (c) Appendix 2 Key Terms of Request for Proposals be amended by deleting the date "January 2010" referred to item (6) under the heading "Contract Term", and replacing it with the date "June 2008", so that it now reads as follows:

"Contracts will be for a five-year term beginning as early as possible but no later than June 2008. At the discretion of the

General Manager, Solid Waste Management Services, the contract terms will be extended for up to two additional 12-month periods."

6.9 Customs-Trade Partnership Against Terrorism Requirements at City of Toronto Solid Waste Management Transfer Stations

The Works Committee considered a report (August 25, 2006) from General Manager, Solid Waste Management Services respecting Customs-Trade Partnership Against Terrorism (C-TPAT) Requirements at City of Toronto Solid Waste Management Transfer Stations.

Recommendations:

It is recommended that:

- (1) the General Manager, Solid Waste Management Services be authorized to register the City of Toronto in the C-TPAT program in co-operation with Republic Services Inc.;
- (2) up to approximately \$250,000.00 be included annually in ongoing operating costs within the operating budget of Solid Waste Management Services under Transfer Services for monitoring, data storage and security charges;
- (3) approval be given to reallocate funds within Solid Waste Management Services Transfer Station Asset Management Capital Project (Account CSW353) to install new physical security requirements at the Transfer Stations, (i.e., fencing, gates, security cameras, and associated cabling); and
- (4) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Councillor Giambrone, the Works Committee recommended to the Policy and Finance Committee that City Council adopt the staff recommendations in the Recommendations Section of the report (August 25, 2006) from the General Manager, Solid Waste Management Services.

6.10 Legal Proceedings to Recover Payment of Sums Due Under Contract to Purchase White Goods and Other Scrap Metals

The Works Committee considered a confidential report (August 16, 2006) from the City Solicitor respecting legal proceedings to recover payment of sums due under contract to purchase white goods and other scrap metals, such report to be considered in camera as the subject matter relates to litigation or potential litigation.

6.12 Infrastructure Improvements in the Fort York and Railway Lands West Neighbourhoods Class Environmental Assessment Study (Ward 19, Trinty-Spadina and Ward 20, Trinity-Spadina)

The Works Committee considered the following:

(i) Report (August 28, 2006) from the General Manager, Transportation Services respecting the findings and recommendations of the Infrastructure Improvements in the Fort York and Railway Lands West Neighbourhoods Class Environmental Assessment Study and requesting authority to file the Environmental Study Report (ESR) in the public record in accordance with the Municipal Class Environmental Assessment.

Recommendations:

It is recommended that:

- (1) authority be granted to the General Manager, Transportation Services to file the Environmental Study Report (ESR) for the Infrastructure Improvements in the Fort York and Railway Lands West Neighbourhoods Class Environmental Assessment Study in the public record and to give public notification of such filing in accordance with the requirements of the Municipal Class Environmental Assessment (EA); and
- (2) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.
- (ii) Communication (August 9, 2006) from the Toronto Pedestrian Committee advising that the Committee on July 20, 2006, received a presentation from the Friends of Fort York respecting the proposed rebuilding of the Bathurst Street Bridge to accommodate a future streetcar on Fort York Boulevard (formerly Bremner Boulevard); and that the Toronto Pedestrian Committee supported the concerns of the Friends of Fort York as stated in their communication (July 20, 2006) and requested the Works Committee, when it considers the Environmental Study Report on the proposed rebuilding of the Bridge, that a headroom condition be attached to its approval.

 (iii) Communication (September 6, 2006) from Deputy Mayor Sandra Bussin, Chair, Roundtable on a Beautiful City forwarding the following recommendations of the Roundtable with respect to the Bathurst Street Bridge:

> "The Roundtable, having considered information and a presentation on the Environmental Assessment Process for a portion of the Railway Lands that includes the Bathurst Street Bridge, and recognizing the importance of achieving design excellence at this location, requested that:

- (i) the Chief Planner and Executive Director, City Planning, in consultation with the Manager of Heritage Preservation Services, and the Museum Administrator, Fort York National Historic Site, report to the appropriate Standing Committee prior to approving the design of the Bathurst Street Bridge on the following:
 - (1) the proposed design of the bridge in relation to the historic context of the location;
 - (2) appropriate aesthetic considerations that should be incorporated into the design; and
 - (3) ways in which the importance of the pedestrian and bicycle connections will be acknowledged, protected and extended in the future plan;
- (ii) the Chief Planner and Executive Director, City Planning report to the appropriate Standing Committee on altering the Environmental Assessment Process to ensure that design becomes a primary factor in that decision-making process; and
- (iii) this matter be forwarded to the Toronto Transit Commission for consideration."

Mr. Stephen A. Otto, Friends of Fort York, addressed the Works Committee and filed a written submission.

Mr. Mitch Stambler, Manager, Service Planning, Toronto Transit Commission answered questions from Members of the Works Committee.

Councillor De Baeremaeker moved that City Council approve, in principle, that the headroom at the south end of any new bridge is equal to or better than what exists there now subject to the completion of the Environmental Assessment, which was carried on the following recorded vote:

AGAINST: Councillors Carroll, Fletcher and Giambrone - 3

The foregoing motion by Councillor De Baeremaeker was **subsequently** withdrawn later in the meeting and replaced with the following motion, which was carried:

"That the General Manager, Transportation Services and the Chief General Manager of the Toronto Transit Commission, in consultation with the Friends of Fort York and other interested stakeholders, through the process of detail design, examine all possible methods to maximize the vertical clearance under the Bathurst Street Bridge and to create a safe, functional and attractive environment for pedestrians and cyclists."

- (2) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.";
- (b) City Council adopt the recommendations of the Roundtable on a Beautiful City contained in the communication (September 6, 2006) from Deputy Mayor Sandra Bussin, Chair, as follows:

"The Roundtable, having considered information and a presentation on the Environmental Assessment Process for a portion of the Railway Lands that includes the Bathurst Street Bridge, and recognizing the importance of achieving design excellence at this location, requested that:

- (iii) this matter be forwarded to the Toronto Transit Commission for consideration."; and

(c) the General Manager, Transportation Services and the Chief General Manager of the Toronto Transit Commission, in consultation with the Friends of Fort York and other interested stakeholders, through the process of detail design, examine all possible methods to maximize the vertical clearance under the Bathurst Street Bridge and to create a safe, functional and attractive environment for pedestrians and cyclists."

Report 6, Clause 7

6.13 Pedestrian Crossover Review (Part II) – Minor Arterial Roadways (All Wards)

The Works Committee considered a report (August 24, 2006) from the General Manager, Transportation Services respecting the review of pedestrian crossovers on major arterial roadways; providing the results of the assessment of pedestrian crossovers on minor arterial roadways; and responding to further recommendations of the Works Committee.

Recommendations:

It is recommended that:

- (1) approval in principle be granted for replacement of the pedestrian crossovers, identified in Appendix 1, with traffic control signals to be designed by Transportation Services staff;
- (2) pedestrian crossovers, identified in Appendix 2, continue as a pedestrian crossing facility with suggested enhancements to flashing beacons, signs and pavement markings;
- (3) the implementation strategy for pedestrian crossover replacements and visibility enhancements on minor arterial roadways, outlined in Appendix 5, be approved;
- (4) a copy of this report be sent for information to the Toronto Police Service, the Ministry of Transportation for Ontario and the Ontario Traffic Conference; and
- (5) the appropriate City officials be authorized and directed to take the necessary action to give effect to the foregoing, including the introduction in Council of any Bills that may be required.

On motion by Councillor Giambrone, the Works Committee recommended that City Council adopt the staff recommendations in the Recommendations Section of the report (August 24, 2006) from the General Manager, Transportation Services.

Report 6, Clause 8

6.14 Proposed Zebra Crosswalk Policy (All Wards)

The Works Committee considered a report (August 22, 2006) from the General Manager, Transportation Services requesting Council approval to adopt zebra crosswalk markings as the standard crosswalk marking treatment for all signalized intersections and pedestrian crossovers in the City of Toronto.

Recommendations:

It is recommended that:

- (1) zebra crosswalk markings be adopted as the standard crosswalk marking treatment for signalized intersections and pedestrian crossovers;
- (2) Transportation Services Division staff be directed to install zebra crosswalk markings at all signalized intersections and pedestrian crossovers in conjunction with road reconstruction and resurfacing projects within the Division's annual Capital Works Program, and in conjunction with all new traffic control signal and pedestrian crossover installations;
- (3) this report be forwarded to the Toronto Pedestrian Committee for its information; and
- (4) the appropriate City officials be authorized and directed to take the necessary action to give effect to the foregoing, including the introduction of any Bills that may be required.

On motion by Councillor Fletcher, the Works Committee recommended that City Council adopt the staff recommendations in the Recommendations Section of the report (August 22, 2006) from the General Manager, Transportation Services.

Report 6, Clause 9

6.15 Proposed Mid-block Pedestrian Signal on Royal York Road, South of Government Road (Ward 5, Etobicoke-Lakeshore)

The Works Committee considered a report (August 24, 2006) from the General Manager, Transportation Services requesting approval to install a mid-block pedestrian signal on Royal York Road, south of Government Road.

Recommendations:

It is recommended that:

(1) a mid-block pedestrian signal be installed on Royal York Road, 21.0 metres south of Government Road; and

(2) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto, including the introduction in Council of any bills that may be required.

On motion by Councillor Giambrone, the Works Committee recommended that City Council adopt the staff recommendations in the Recommendations Section of the report (August 24, 2006) from the General Manager, Transportation Services.

Report 6, Clause 10

6.16 Housekeeping Amendments to Various Traffic By-laws (All Wards)

The Works Committee considered a report (August 25, 2006) from the General Manager Transportation Services respecting housekeeping amendments to various City traffic by-laws with respect to entries which are incorrect or no longer applicable.

Recommendations:

It is recommended that:

- (1) the changes, additions and deletions to the various traffic by-laws outlined in the Appendices 1-37 be adopted; and
- (2) the appropriate City officials be requested to take any action necessary to give effect to the foregoing, including the introduction in Council of any Bills that may be required.
 On motion by Councillor Giambrone, the Works Committee recommended that City Council adopt the staff recommendations in the Recommendations Section of the report (August 25, 2006) from the General Manager, Transportation Services.

Report 6, Clause 11

6.17 Proposed Speed Limit Increase on Lake Shore Boulevard West between the Humber River and a Point 450.0 metres West of the Humber River, for Westbound Traffic (Ward 6, Etobicoke-Lakeshore)

The Works Committee considered the following:

(i) Report (August 24, 2006) from the General Manager, Transportation Services proposing an increase to the speed limit from 60 km/h to 70 km/h on the westbound section of Lake Shore Boulevard West between the Humber River and the Toronto Transit Commission streetcar underpass (450.0 metres west of the Humber River) north of the F.G. Gardiner Expressway.

Recommendations:

It is recommended that:

- (1) the speed limit for westbound Lake Shore Boulevard West, between the Humber River and the Toronto Transit Commission streetcar underpass, north of the F.G. Gardiner Expressway, be increased from 60 km/h to 70 km/h; and
- (2) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto, including the introduction in Council of any bills that may be required.
- (ii) Communication (September 8, 2006) from Councillor Mark Grimes, Ward 6, Etobicoke-Lakeshore, in support of the staff recommendations.

On motion by Councillor Giambrone, the Works Committee recommended that City Council adopt the staff recommendations in the Recommendations Section of the report (August 24, 2006) from the General Manager, Transportation Services.

Report 6, Clause 12

6.18 F.G. Gardiner Expressway, Dowling Avenue to Highway 427 – State of Good Repair Needs and Budget Implications (Wards 5 and 6, Etobicoke-Lakeshore, and Wards 13 and 14, Parkdale-High Park)

The Works Committee considered a report (August 24, 2006) from the General Manager, Transportation Services providing information regarding work to be done to bring the City of Toronto's portion of the former Queen Elizabeth Way, now F.G. Gardiner Expressway, to a state of good repair and to outline the budget implications of undertaking this work.

Recommendations:

It is recommended that:

(1) this report be received for information; namely that, in the absence of increased funding targets, the only way for the Transportation Services Division to be able to

implement improvements to the F.G. Gardiner Expressway corridor is to draw funding away from future committed state of good repair work in other areas; and

(2) this report be forwarded to the Policy and Finance Committee for information.

On motion by Councillor Giambrone, the Works Committee adopted staff recommendation (1) in the Recommendations Section of the report (August 24, 2006) from the General Manager, Transportation Services; and directed that the report be forwarded to the Policy and Finance Committee for information, in accordance with Recommendation (2).

(Policy and Finance Committee; c. Acting Deputy City Manager – September 11, 2006)

Report 6, Clause 40(h)

6.19 St. Clair Avenue West Transit Improvement Project – Impact on State of Good Repair Capital Projects (Ward 11, York South-Weston; Ward 17, Davenport; Ward 21, St. Paul's; and Ward 22, St. Paul's)

The Works Committee considered a report (August 24, 2006) from the General Manager, Transportation Services responding to various requests by Council on July 25, 26, and 27, 2006, to report on the capital projects that could be impacted to accommodate incremental aesthetic improvements (decorative lighting, hydro undergrounding and full sidewalk reconstruction) on St. Clair Avenue West between Yonge Street and Gunns Road, in conjunction with the TTC Transit Improvement Project. Recommendations:

It is recommended that:

- (1) improvements involving the undergrounding of hydro plant, enhancement of decorative lighting and extension of sidewalk work to mid-block areas, not proceed given fixed affordability targets and, instead, continue with only overhead hydro plant modifications;
- (2) should the Works Committee recommend as an alternative to Recommendation (1), to proceed with the incremental aesthetic improvements (decorative lighting, hydro undergrounding and full sidewalk reconstruction including mid-block locations), that the associated funding not be drawn against future committed Transportation state-of-good repair programs;

- (3) should the Works Committee decide, as an alternative to Recommendations (1) and (2) above, to proceed with the incremental aesthetic improvements (decorative lighting, hydro undergrounding and full sidewalk mid-block reconstruction), that it advise the General Manager, Transportation Services as to which Wards' future committed Transportation state-of-good repair roadworks should get deferred over the 2007-2009 timeframe in order to fund these improvements; and
- (4) this report be forwarded to the Policy and Finance Committee for information.

On motion by Councillor Carroll, the Works Committee:

- (a) referred the report (August 24, 2006) from the General Manager, Transportation Services to the Budget Advisory Committee so that decisions regarding funding for the 2007 to 2010 portion of the St. Clair Avenue West undergrounding can be considered as part of the Budget Advisory Committee's 2007 Capital Budget deliberations; and
- (b) requested the General Manager, Transportation Services to meet with appropriate staff from Toronto Hydro, Enbridge Gas and the TTC to finalize funding issues and limit the impact on the City's Transportation Capital Budget.

Councillor Del Grande requested that he be recorded as being opposed to the motion by Councillor Carroll.

(Budget Committee; General Manager, Transportation Services; Deputy City Manager and Chief Financial Officer; c. Acting Deputy City Manager – September 11, 2006)

Report 6, Clause 40(i)

6.20 Pavement Degradation Fees (All Wards)

The Works Committee considered a report (August 28, 2006) from the General Manager, Transportation Services providing a comparison of current practices in other municipalities in the application of pavement degradation fees, and recommending an approach for developing pavement degradation fees for the City of Toronto. Recommendations:

It is recommended that:

- (1) an option for pavement degradation fees be pursued for the City of Toronto; and
- (2) the Transportation Services Division report back on the findings of a study of the impact of utility cuts on the performance of City of Toronto pavements, a fee structure for pavement degradation, impacts of such fees and a strategy for implementation.

On motion by Councillor Giambrone, the Works Committee recommended that City Council adopt the staff recommendations in the Recommendations Section of the report (August 28, 2006) from the General Manager, Transportation Services, subject to adding the words "in January 2007" after the words "report back", so that the recommendation now reads as follows:

"(2) the Transportation Services Division report back in January 2007 on the findings of a study of the impact of utility cuts on the performance of City of Toronto pavements, a fee structure for pavement degradation, impacts of such fees and a strategy for implementation."

6.21 Durham Boundary Facilities Agreement – Kingston Road Bridge Over the Rouge River (Ward 44, Scarborough East)

The Works Committee considered a report (August 18, 2006) from the General Manager, Transportation Services respecting the execution of an agreement between the Region of Durham and the City of Toronto for the cost-sharing and maintenance of the Kingston Road Bridge over the Rouge River and the stretch of Kingston Road between the easterly end of the bridge and Altona Road in Pickering.

Recommendations:

It is recommended that:

(1) authorization be granted to execute an agreement between the City of Toronto and the Region of Durham, generally in accordance with the terms and conditions contained in the draft agreement appended to this report; and (2) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Councillor De Baeremaeker, the Works Committee recommended that City Council adopt the staff recommendations in the Recommendations Section of the report (August 18, 2006) from the General Manager, Transportation Services.

Report 6, Clause 14

6.22 Mississauga Boundary Facilities Agreement (Ward 3, Etobicoke Centre, Wards 5 and 6, Etobicoke-Lakeshore)

The Works Committee considered a report (August 18, 2006) from the General Manager, Transportation Services respecting the execution of an agreement between the City of Mississauga and the City of Toronto for the cost-sharing and maintenance of bridge structures and road facilities along the Cities' mutual boundary.

Recommendations:

It is recommended that:

- (1) authorization be granted to execute an agreement between the City of Toronto and the City of Mississauga, generally in accordance with the terms and conditions contained in the draft agreement appended to this report; and
- (2) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Councillor Fletcher, the Works Committee:

(i) recommended that City Council adopt the staff recommendations in the Recommendations Section of the report (August 18, 2006) from the General Manager, Transportation Services; and (ii) requested the General Manager, Toronto Water to report to the appropriate Standing Committee on the establishment of a protocol for dealing with the City of Mississauga on the issue of water boundaries.

(General Manager, Toronto Water; c. Acting Deputy City Manager – September 11, 2006)

Report 6, Clause 15

6.23 Municipal Access Agreement for Telecommunications Installations – Metro Fibrewerx Inc. (All Wards)

The Works Committee considered a report (August 21, 2006) from the General Manager, Transportation Services requesting authorization to enter into an agreement with Metro Fibrewerx Inc. to enable this telecommunications firm to install and maintain fibre optic and other cable, conduit and ancillary plant in City of Toronto streets pursuant to the terms and conditions negotiated to address City interests.

Recommendations:

It is recommended that:

- (1) approval be given to enter into a Municipal Access Agreement with Metro Fibrewerx Inc., subject to the firm providing verification that it has been licensed as a Canadian Carrier by the Canadian Radio and Television-Telecommunications Commission (CRTC) pursuant to the Telecommunications Act, to authorize the construction, installation, maintenance and operation of fibre optic and other cables, conduit and ancillary plant in the City of Toronto public highways, and incorporating the terms as set out in this report and such other terms and conditions as may be satisfactory to the General Manager of Transportation Services and the City Solicitor; and
- (2) the appropriate City officials be authorized and directed to take the necessary action to implement the foregoing, including the introduction in Council of any Bills that may be required.

On motion by Councillor Giambrone, the Works Committee recommended that City Council adopt the staff recommendations in the Recommendations Section of the report (August 21, 2006) from the General Manager, Transportation Services.

Report 6, Clause 16

6.24 Municipal Access Agreement for Telecommunications Installations – Rogers Communications Inc. (All Wards)

The Works Committee considered the following:

- (i) Confidential Report (August 28, 2006) respecting a Municipal Access Agreement for Telecommunications Installations – Rogers Communications Inc. (All Wards), such report to be considered in camera as the subject matter relates to solicitor/client privilege.
- (ii) Confidential communication (September 11, 2006) from Councillor Howard Moscoe, Ward 15, Eglinton-Lawrence.

Councillor Howard Moscoe, Ward 15, Eglinton-Lawrence, addressed the Works Committee and requested that discussion on the report and communication take place in camera.

Councillor Giambrone moved that, in accordance with the Municipal Act, 2001, the Works Committee meet privately to discuss the confidential report and communications, in that the subject matter relates to solicitor/client privilege.

The Works Committee recessed at 12:05 p.m. to meet in camera.

The Works Committee adjourned its private meeting at 12:35 p.m., and immediately reconvened in public session.

On motion by Councillor Giambrone, (on behalf of Councillor Moscoe), the Works Committee:

(i) recommended that City Council adopt the staff recommendations in the Recommendations Section of the confidential report (August 28,

2006) from the General Manager, Transportation Services, with the exception of Item (11) under the heading "Summary of Key Terms", which was forwarded to Members of Council under separate cover; and further that, in accordance with the Municipal Act, discussions pertaining to this report be held in camera as the subject matter may relate to solicitor/client privilege.

- (ii) provided confidential direction to the General Manager, Transportation Services; and further requested that a report be submitted directly to Council for its meeting on September 25, 2006, on the outcome of the direction; and
- (iii) requested the General Manager, Transportation Services to report to the new Public Works and Infrastructure Committee on the following:
 - all fees paid by each of the present carriers on a per metre basis, including permit and access fees, and that the carriers be categorized on the basis of fees paid to the City;
 - the establishment of a category structure based on fees paid to the City of Toronto on the premise of the need to cover the costs of processing applications; and
 - carriers be offered the opportunity to bump specific applications to the high speed installation category on a voluntary basis.

6.25 Regent Park Revitalization Project – Agreement with Toronto Community Housing Corporation for the Installation of Community Energy Distribution Piping in Various Public Streets (Ward 28, Toronto Centre-Rosedale)

The Works Committee considered a report (August 24, 2006) from the General Manager, Transportation Services requesting authorization to enter into an Agreement with the Toronto Community Housing Corporation for the installation and maintenance of a community energy system (district heating and cooling) within various existing and future public highways to serve the Regent Park Revitalization Project and, potentially, Moss Park.

Recommendations:

It is recommended that:

- (1) approval be given to enter into an Agreement with Toronto Community Housing Corporation (TCHC) to authorize the construction, installation, maintenance and operation of a community energy system, including hot and chilled water distribution piping and ancillary plant in City of Toronto streets generally under the terms and conditions set out in this report and such other terms and conditions as may be satisfactory to the City Solicitor and General Manager, Transportation Services; and
- (2) the appropriate City officials be authorized and directed to take the necessary action to implement the foregoing, including the introduction in Council of any Bills that may be required.

On motion by Councillor Giambrone, the Works Committee recommended that City Council adopt the staff recommendations in the Recommendations Section of the report (August 24, 2006) from the General Manager, Transportation Services.

Report 6, Clause 18

6.26 Exemption from On-Street Parking Permit Fees for Motorized Scooters and Motorcycles

The Works Committee considered a report (August 18, 2006) from the General Manager, Transportation Services requesting authority to exempt motorized scooters and motorcycles from on-street permit parking fees.

Recommendations:

It is recommended that:

- (1) the City of Toronto's relevant On-Street Permit Parking By-Laws be amended to exempt motorized scooters and motorcycles, as defined by the Ontario Highway Traffic Act, from on-street permit parking fees;
- (2) the City of Toronto's relevant On-Street Permit Parking By-Laws be amended to allow motorized scooters and motorcycles to be parked on a street lawfully designated under the permit parking program, with a valid permit, at an angle, but not more than sixty (60) degrees to the curb and the permit is to be affixed to the handle bar of the motorized scooter or motorcycle with a cable tie; and
- (3) the appropriate City officials be authorized and directed to take whatever action is necessary to implement the foregoing, including the introduction in Council of any Bills that are required.

The Works Committee:

(A) recommended that the staff recommendations in the Recommendations Section of the report (August 18, 2006) from the General Manager, Transportation Services be deleted and replaced with the following:

"It is recommended that:

- the City of Toronto's relevant On-Street Permit Parking By-Laws be amended to exempt motorized scooters and motorcycles, as defined by the Ontario Highway Traffic Act, from on-street permit parking fees;
- (2) the City of Toronto's relevant On-Street Permit Parking By-Laws be amended to allow motorized scooters and motorcycles to be parked on a street lawfully designated under the permit parking program, with a valid permit, at an angle, of at least 45 degrees, but not more than 60 degrees to the curb, and the permit is to be affixed to the handle bar of the motorized scooter or motorcycle with a cable tie;
- (3) the City of Toronto's relevant parking by-laws be amended to allow motorcycles, as defined in the Ontario Highway Traffic Act, to park, where on-street parking is lawfully allowed, at an angle of at least 45 degrees, but not more than 60 degrees to the curb; and

(4) the appropriate City officials be authorized and directed to take whatever action is necessary to implement the foregoing, including the introduction in Council of any Bills that are required."; and

(Motion by Councillor Fletcher)

- (B) requested:
 - (a) the General Manager, Transportation Services to report to the January 2008 meeting of the Public Works and Infrastructure Committee following a review of the new permit parking for motorized scooter and motorcycles; and

(Motion by Councillor Fletcher)

(b) the General Manager, Transportation Services, in consultation with appropriate City officials, the Toronto Parking Authority and the Toronto Police Service, to report to the new Public Works and Infrastructure Committee, or appropriate Standing Committee, on policy options and recommendations related to exempting or reducing standard parking fees on all onstreet parking meters or machines and on-street permit parking fees for ultra-small vehicles (e.g., smart cars), and/or vehicles with environmentally friendly power systems (e.g., hybrid, electric).

(Motion by Councillor Palacio)

(General Manager, Transportation Services; c. Acting Deputy City Manager – September 11, 2006)

Report 6, Clause 19

The Chair appointed Councillor Giambrone Acting Chair and vacated the Chair.

6.27 Staff Participation in Melbourne Walk21 2006 Conference (All Wards)

The Works Committee considered a report (August 22, 2006) from the General Manager, Transportation Services respecting staff participation in the Melbourne Walk21 2006 Conference.

Recommendations:

It is recommended that:

- (1) authority be granted for Daniel Egan, Manager of Pedestrian and Cycling Infrastructure, Transportation Services Division to travel to Melbourne, Australia to represent the City of Toronto at the Walk21 2006 Conference at a cost not to exceed \$4,425.00, provided from the Transportation Services 2006 Operating Budget, Cost Centre TP0276; and
- (2) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Councillor Carroll, the Works Committee recommended that City Council adopt the staff recommendations in the Recommendations Section of the report (August 22, 2006) from the General Manager, Transportation Services, subject to amending Recommendation (1) to read as follows:

"(1) authority be granted for Daniel Egan, Manager of Pedestrian and Cycling Infrastructure, Transportation Services Division and the General Manager, Transportation Services to travel to Melbourne, Australia to represent the City of Toronto at the Walk21 2006 Conference at a cost not to exceed \$10,000.00, provided from the Transportation Services 2006 Operating Budget Cost Centre TP0276, with a view towards professional development and in order to host that conference in the City of Toronto in 2007; and."

Report 6, Clause 20

Councillor Carroll resumed the Chair.

6.28 Traffic Control and Traffic Calming Implementation Review (All Wards)

The Works Committee considered the following:

(i) Report (August 23, 2005) from the General Manager, Transportation Services respecting the long-term effects and risks of implementing traffic control and traffic calming measures that do not meet the City's own policies, criteria and warrants.

Recommendations:

It is recommended that this report be received for information.

(ii) Communication (July 27, 2006) from Larry Perlman respecting the City of Toronto's current Traffic Calming Policy.

The following persons addressed the Works Committee:

- Larry Perlman; and
- Councillor Doug Holyday, Ward 3, Etobicoke Centre.

Councillor Carroll, on behalf of Councillor Holyday, moved that the General Manager, Transportation Services be requested to report to the new Public Works and Infrastructure Committee on:

- (a) the feasibility of adding a statement to the traffic calming measures pertaining to the polling policy with respect to emergency service risks; and
- (b) the funding impacts with respect to warranted versus unwarranted traffic calming measures.

Councillor Barron moved that the General Manager, Transportation Services be requested to report to the new Public Works and Infrastructure Committee on the feasibility of amending the traffic control and traffic calming measures using a more holistic community-based strategy.

Councillor Fletcher moved that:

(1) part (a) of the motion by Councillor Carroll, on behalf of Councillor Holyday, be amended by adding the following words:

"should the statement not be in the letter";

(2) the General Manager, Transportation Services be requested to report to the new Public Works and Infrastructure Committee on:

- (a) new warrants looking at a reduction of the speed from 50 kilometres per hour to 40 kilometres per hour, and on the speed limit to be posted;
- (b) reducing the number of cars per day from 1,000 to 800, and that the warrants include any local factors that may need to be included, such as schools, short-cuts, etc.;
- (c) causes and damage from most costly to least costly by Community Council area for 2004 and 2005 affecting all emergency vehicles; and
- (3) the Chief Planner and Executive Director, City Planning be requested to look at requiring community-based traffic calming in all rezoning applications.

Councillor Palacio moved that the General Manager, Transportation Services be requested to ensure that any communication that is sent out is translated into different languages at the discretion of the local Councillor.

Councillor Del Grande, on behalf of Councillor Holyday requested that recorded votes be taken on all motions.

Upon the question of the adoption of part (1) of the motion by Councillor Fletcher amending part (a) of the motion by Councillor Carroll, on behalf of Councillor Holyday, **it was carried on the following recorded vote**:

The Chair declared part (a) of her motion, on behalf of Councillor Holyday, redundant.

(i) Report (August 29, 2006) from the Deputy City Manager and Chief Financial Officer and the General Manager, Toronto Water respecting the 2007 Interim Water and Wastewater Rate; advising that the Ontario Regulation 244/02 under the Municipal Act, 2001, provides that any by-law respecting water and sewer rates expires on December 31 of the year following the year in which the by-law was passed; and seeking authorization to continue the 2006 water and sewer rates, approved as part of By-law No. 1074-2005, respecting water rates and sewer service rates, until Council adopts the 2007 Water and Wastewater Operating Budget and new rates have been approved.

Recommendations:

It is recommended that:

- (1) the 2006 water and sewer service rates as provided for in By-law No. 1074-2005 be continued until Council adopts the 2007 Water and Wastewater Operating Budget, the requisite 21-day public notice period for new rates has been given, and Council adopts the new rates; and

THAT the City of Toronto be asked to recognize in its future funding plans for water related works the capital needs of TRCA identified in the 2006 submission as being \$41 million, 2006-2015, the capital requirement for funding for land acquisition for source water protection as being at a minimum of \$2 million annually and future growth in operating requirements, at least at the rate of inflation, all in support of the City's objectives to implement the Wet Weather Flow Management Master Plan and the Remedial Action Plan;

AND FURTHER THAT the City of Toronto be so advised."

On motion by Councillor Del Grande, the Works Committee:

- recommended that City Council adopt the staff recommendations in the Recommendations Section of the report (August 29, 2006) from the Deputy City Manager and Chief Financial Officer and General Manager, Toronto Water.

 - Part B: Jes-Chem Ltd., product designation PAM C-49 at a cost of \$1,572,955.00 including all applicable charges and taxes for the supply and delivery of polyelectrolytes to thicken waste activated sludge at the Ashbridges Bay Treatment Plant, having submitted the most effective performance at the lowest evaluation cost; and
- (2) the appropriate City officials be authorized and directed to take necessary action to give effect thereto.

- (2) staff be directed to review past billing records of customers who are not connected to the sewer system and are currently receiving a rebate and to notify those who may qualify for a one time rebate, or waiver on future water billings equivalent to the sewer service charge that has been paid for the period commencing on the later of the date that City of Toronto By-law 660-1999 came into force (November 1, 1999) or the date that the consumer became responsible for payment of water bills in connection with the property;
- (3) the General Manager, Toronto Water and the Deputy City Manager and Chief Financial Officer report on any changes necessary to the Sewer Rebate provided for in Article I of Toronto Municipal Code Chapter 849-14 Water and Sewage Services through Toronto Water's annual Water and Wastewater Rate setting report to Works Committee; and

(4) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto, including the introduction in Council of any bills that may be required.

On motion by Councillor Giambrone, the Works Committee recommended that City Council adopt the staff recommendations in the Recommendations Section of the report (August 16, 2006) from the General Manager, Toronto Water.

- (3) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

- (3) the General Manager, Toronto Water, incorporate the costs associated with the implementation of the Mandatory Downspout Disconnection Program in the forthcoming 2007 Toronto Water Capital and Operating Budget submissions; and
- (4) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto, including introducing in Council any Bills which may be required;",

subject to the necessary funding being approved in the 2007 Capital and Operating Budgets, and included as part of the 2007 Water and Wastewater Rate Budget approval process, which was carried on the following recorded vote:

- AGAINST: Councillors Del Grande and Palacio 2

Councillor Fletcher moved that the General Manager, Toronto Water, be requested to report to the appropriate Standing Committee on the effect that the Downspout Disconnection Program has on improving the water quality in the City's streams, rivers and Lake Ontario, **which was carried**.

Councillor Del Grande moved the General Manager, Toronto Water undertake a consultation process to obtain feedback from the residents of the City of Toronto on what the next steps should be with respect to the Mandatory Downspout Disconnection Program, such consultation include an opportunity to make deputations to the Community Councils, **which was lost on the following recorded tie vote**:

AGAINST: Councillors Ainslie, De Baeremaeker, Fletcher, and Giambrone - 4

- (2) the General Manager, Toronto Water, upon completion of the Class Environmental Assessment study, report to Works Committee on the adjustments which may be necessary to the WWFMP implementation schedule and the implications for Toronto Water's Capital Program, Planning and Budget; and
- (3) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.
- (ii) Communication (September 8, 2006) from Margaret Buchinger, Chair, Policy and Advocacy Team, Don Watershed Regeneration Council.
- (iii) Communication (September 8, 2006) from Adele Freeman, Director, Watershed Management, and Deborah Martin-Downs, Director, Ecology, Toronto and Region Conservation Authority.
- (iv) Communication (September 11, 2006) from Councillor Janet Davis, Co-Chair, Wet Weather Flow Master Plan Implementation Advisory Committee (IAC), advising that the IAC is recommending that the City adopt the staff recommendation to undertake one comprehensive Class Environmental Assessment, subject to the following conditions:
 - (1) the Class Environmental Assessment will examine and consider a range of options;
