City Council met in the Council Chamber, City Hall, Toronto.

CALL TO ORDER - 9:37 a.m.

S4.1 Mayor Miller took the Chair and called the Members to order.

The special meeting opened with *O Canada*.

S4.2 NOTICE OF SPECIAL MEETING

Mayor Miller read the following Notice of Special Meeting:

"A special meeting of City Council will be held on March 29, 30 and 31, 2006, and will continue, as necessary on April 3, 5, 6 and 7, 2006, in the Council Chamber, 100 Queen Street West, Toronto at 9:30 a.m., for the following purposes:

- (1) to consider the City of Toronto 2006 Operating Budget;
- (2) to introduce and enact General Bills; and
- (3) to introduce and enact a confirming by-law for this special meeting."

S4.3 **PETITION**

Councillor Lindsay Luby submitted a petition (undated), entitled "Petition for Brig's Law", containing approximately 1,637 signatures, in support of an amendment to the Criminal Code to make intentional harm of a law enforcement animal an indictable offence.

The above petition was received and considered with Motion J(1), moved by Councillor Lindsay Luby, seconded by Councillor Soknacki, respecting a request for an amendment to the Criminal Code regarding intentional harm to law enforcement animals.

Councillor Kelly declared his interest in Policy and Finance Committee Report 2, Clause 1, headed "City of Toronto 2006 Budget Advisory Committee Recommended Tax Supported Operating Budget", as it pertains to the Budget for the Toronto Police Service Administrative Command [Recommendation (A)(133)], in that his spouse is employed as a translator.

Councillor Mihevc declared his interest in Policy and Finance Committee Report 2, Clause 1, headed "City of Toronto 2006 Budget Advisory Committee Recommended Tax Supported Operating Budget", as it pertains to the Budget for the Shelter, Support and Housing Administration Division [Recommendation (A)(24)], in that his spouse is employed at the East York Family Resource Centre in that it receives funding.

Councillor Pitfield declared her interest in Motion J(2), moved by Councillor Silva, seconded by Deputy Mayor Pantalone, regarding 90 Stadium Road – Ontario Municipal Board Hearing, as she is a member of a yacht club on Stadium Road.

Councillor Shiner declared his interest in Policy and Finance Committee Report 2, Clause 1, headed "City of Toronto 2006 Budget Advisory Committee Recommended Tax Supported Operating Budget", as it pertains to the Budget for the Parks, Forestry and Recreation Division [Recommendation (A)(17)], in that a member of his family is employed by the Division for the summer; and in Motion J(7), moved by Councillor Fletcher, seconded by Councillor Davis, regarding MPAC Reform - Request to Establish an Assessment Monitoring Group, in that he has a relative who works for the Municipal Property Assessment Corporation.

Councillor Walker declared his interest in Policy and Finance Committee Report 2, Clause 1, headed "City of Toronto 2006 Budget Advisory Committee Recommended Tax Supported Operating Budget", as it pertains to the Toronto Port Authority, in that his daughter is employed in a management position with the Authority.

S4.6 Policy and Finance Committee Report 2, Clause 1, headed "City of Toronto 2006 Budget Advisory Committee Recommended Tax Supported Operating Budget".

- (3) five minutes to speak, with a five-minute extension permitted;
- (4) all motions to be prepared in advance of the Member speaking;
- (5) vote on Clause 1; and
- (6) vote on Clause 2.

Council concurred in the proposal by Councillor Soknacki.

Councillor Shiner, at 10:49 a.m., moved that Council vary the order of its proceedings to provide that §27-28E, Questioning to Obtain Facts, of Chapter 27, Council Procedures, of the City of Toronto Municipal Code be waived and that Members of Council be permitted a further period of five minutes to ask questions, the vote upon which was taken as follows:

- (a) Councillor Shiner moved that the Clause be amended by amending the Program Recommendations, as recommended by the Policy and Finance Committee:
 - (1) to provide that:
 - (a) all program budgets for City divisions, agencies, boards and commissions be approved at 99.5 percent of the Policy and Finance Committee recommended level, thereby reducing expenditures by \$37 million;
 - (b) \$11 million of the \$37 million be allocated to increase the subsidy to the Toronto Transit Commission (TTC), and the TTC be requested not to implement the fare increase;
 - (c) the balance of \$26 million be considered as a Contingency Account; and
 - (d) City divisions, agencies, boards and commissions who are unable to achieve this reduction be able to seek Council approval for an additional allocation from the contingency account; and
 - (2) by adding the following:

"That the City Manager and the Deputy City Manager and Chief Financial Officer be requested to:

- (a) report to Council for its meeting on June 27, 2006, through the Policy and Finance Committee, outlining their recommendations on service priorities and a plan to review our current service delivery models, prior to consideration of the 2007 budget; and
- (b) report to Council for its meeting on June 27, 2006, through the Policy and Finance Committee, on any proposed service changes which may be required to achieve a '0' base budget for 2007."

Councillor Watson in the Chair.

(b) Councillor Del Grande moved that, recognizing the need for Toronto businesses to be competitive and maintaining Council's promise not to tax business if it could be so avoided, the Clause be amended by amending the Program Recommendations, as recommended by the Policy and Finance Committee, by deleting the following words from Program Recommendation (A)(6) of the Policy and Finance Committee:

"and a Commercial, Industrial, and Multi-residential tax increase of 1.0 percent or \$18.352 million be approved (after assessment growth);",

so that Program Recommendation (A)(6) now reads as follows:

"(6) a residential property tax increase of 3.0 percent or \$37.232 million;".

(c) Councillor Thompson moved that the Clause be amended by amending the Program Recommendations, as recommended by the Policy and Finance Committee, for Social Development, Finance and Administration, by adding the following:

"That the City Manager be directed to develop appropriate performance measures on the outcomes of City and community programming in priority neighbourhoods, in conjunction with the Centre of Criminology and other relevant research initiatives, and report to Council, through the Community Services Committee, on the implementation of these performance measures as part of the report on the implementation of the Toronto Strong Neighbourhoods Strategy coming forward in June 2006."

(d) Councillor Minnan-Wong moved that the Clause be amended by amending the Program Recommendations, as recommended by the Policy and Finance Committee, by adding the following:

- (1) City Council support the principle of zero-based Budgeting in all City divisions, agencies, boards and commissions; and
- (2) the City Manager be requested to report to the Policy and Finance Committee on opportunities for zero-based Budgeting within the City and all of its divisions, agencies, boards and commissions, and all divisions, agencies, boards and commissions being reviewed on a three-year, rolling basis."

(1) report to the July 25, 2006 meeting of City Council, through the Policy and Finance Committee, providing a list of the following:

- (c) services in Part (a), above, that could also be provided by the private sector; and
- (2) report to the next meeting of the Policy and Finance Committee on the progress and status of performance measures for services performed by the City."
- (f) Councillor Palacio moved that the Clause be amended by amending the Program Recommendations, as recommended by the Policy and Finance Committee:
 - (1) for the Office of the Mayor [Recommendation (A)(97)] by a reduction of 5 percent, and applying the savings to the Clean and Beautiful City Initiative; and
 - (2) for City Council [Recommendation (A)(98)] by reducing the Councillors' Office Budget by 5 percent, and applying the savings to the Clean and Beautiful City Initiative.
- (g) Councillor Ford moved that the Clause be amended by amending the Program Recommendations, as recommended by the Policy and Finance Committee:
 - (1) for Children's Services [Recommendation (A)(2)] by discontinuing the publication of the Annual Report Card on Children, for a savings of \$10,000.00;
 - (2) for Culture [Recommendation (A)(7)] by eliminating the current open position of Manager, Arts Services, for a maximum savings of approximately \$127,920.00 [\$104,000.00 + benefits];
 - (3) for Emergency Medical Services [Recommendation (A)(12)] by eliminating the "Outdoor Exercise During Heat and Smog Alerts" brochure production, for a savings of \$2,000.00;
 - (4) for Homes for the Aged [Recommendation (A)(16)] by discontinuing the Annual Report Card on Homes for the Aged, for a savings of \$6,000.00;

- (5) for Parks, Forestry and Recreation [Recommendation (A)(17)] by:
 - (a) eliminating the Seniors' Recreation Strategy brochure;
 - (b) eliminating the Community Access and Equity brochure, for a savings of \$2,500.00; and
 - (c) eliminating the provision of free golf passes for Members of Council and staff, for a potential savings of \$15,000.00;
- (6) for Shelter, Housing and Support Administration [Recommendation (A)(22)] by:
 - (a) eliminating the free "three bottles of wine a day" program in Shelter Services, for a savings of \$43,000.00; and
 - (b) eliminating the free cigarettes program in Shelter Services, for a savings of \$20,000.00;
- (7) for the 3-1-1 Customer Service Strategy [Recommendation (A)(35)] by eliminating the 3-1-1 project, for a savings of \$389,000.00;
- (8) for Fire Services [Recommendation (A)(48)] by discontinuing the "Connections" newsletter, for a savings of \$10,000.00;
- (9) for Solid Waste Management Services [Recommendation (A)(57)] by discontinuing the "Waste Watch" newsletter, for a savings of \$226,991.00;
- (10) for Transportation Services [Recommendation (A)(63)] by:
 - (a) discontinuing the "City Routes" newsletter, for a savings of \$219,521.00;
 - (b) reducing the City-wide sidewalk snow removal budget by \$7.0 million; and
 - (c) eliminating City-wide mechanical leaf pick-up;
- (11) for Corporate Communications [Recommendation (A)(73)] by:
 - (a) discontinuing the "Inside Toronto" employee newsletter, for a savings of \$17,500.00;
 - (b) eliminating the City news clipping service from Bowdens, for a savings of \$40,000.00;

- (c) removing the Metroland papers from the clipping package to save on Bowdens charges, due to the ongoing duplication of articles from all Mirror and Guardian papers;
- (d) reducing the number of clipping package copies that the Mayor's office receives from 19 to 2; and
- (e) eliminating the clipping package service to 85 City staff;
- (12) for Facilities and Real Estate [Recommendation (A)(75)] by reducing the plant watering service in City buildings, for a savings of \$100,000.00;
- (13) for City Council [Recommendation (A)(98)] by:
 - (a) reducing the Councillors' Global budget to \$30,000.00 $(\$53,100.00 30,000.00 = \$23,100.00 \times 44 = \$1,016,400.00)$, for a savings of approximately \$1.0 million;
 - (b) reducing the Councillors' staff budget by one position $[53k + benefits = $65,190.00 \times 44 = $2,868,360.00]$, for a savings of approximately \$2.8 million per year;
 - (c) reducing the number of Executive Assistants in each Councillor's office to one, for a savings of approximately \$70,000.00 per year;
 - (d) reducing the City Council food and beverage budget from \$80,000.00 to \$25,000.00, for a savings of \$55,000.00;
 - (e) reducing the Community Councils' hospitality budgets from \$30,000.00 to \$15,000.00, for a savings of \$15,000.00;
 - (f) eliminating the following items from the Councillors' office budgets:
 - (i) newspapers, books and magazine subscriptions, for a savings of approximately \$14,000.00;
 - (ii) conference travel, for a savings of approximately \$29,913.00;

 - (iv) gas and mileage, for a savings of approximately \$38,700.00;

- (v) transit passes and tokens for staff, for a savings of approximately \$3,300.00;

- (14) for the City Clerk's Office [Recommendation (A)(81)] by adding the following:

"That the City Clerk be requested to give written notice from the City to Rogers Centre/SkyDome no later than December 31, 2006, that the City's skybox lease will terminate on March 31, 2007, for a savings of approximately \$77,000.00.";

- (15) for the Mayor's Office [Recommendation (A)(97)] by reducing the office staff by one position, for a savings of approximately \$76,086.00 per year (\$58,586.00 average salary and benefits);
- (16) for Toronto Public Health [Recommendation (A)(99)] by reducing the number of Blackberry devices in use by Public Health by 50 percent, for a savings of approximately \$47,254.00;

- (17) for Exhibition Place [Recommendation (A)(105)] by:

- (h) Councillor Di Giorgio moved that the Clause be amended by amending the Program Recommendations, as recommended by the Policy and Finance Committee, by adding the following:
 - "That the City Manager be requested to include, in any future reports that examine the benefits of increased contracting out, the historical annual increases that exist in the contract amounts over a 20-year period."
- (i) Councillor Cowbourne moved that the Clause be amended by amending the Program Recommendations, as recommended by the Policy and Finance Committee, for Social Development, Finance and Administration, by amending Recommendation (A)(26) of the Policy and Finance Committee to include programs for youth at risk, provided by the following Local Arts Service Organizations, in the new and enhanced requests for youth programs and services:
 - (1) Scarborough Arts Council;
 - (2) Urban Arts;
 - (3) Arts Etobicoke; and
 - (4) Lakeshore Arts.
- (j) Councillor Kelly moved that the Clause be amended by amending the Program Recommendations, as recommended by the Policy and Finance Committee:
 - (1) for Parks, Forestry and Recreation [Recommendation (A)(21)] by inserting, after the words "highest priorities", the words "and equity between the four administrative districts", so that Program Recommendation (A)(21) now reads as follows:
 - "(21) Parks, Forestry and Recreation's future new service priorities be considered in the context of Council's highest priorities and equity between the four administrative districts and within an affordable fiscal framework.";
 - (2) for the Toronto Police Service [Recommendation (A)(138)] by inserting, after the words "the criteria for redeployment", the words "including equity between the four administrative districts", so that Program Recommendation (A)(138) now reads as follows:
 - "(138) the Chief of Police be requested to report back to the Budget Advisory Committee prior to the start of the 2007 Budget process on the new staffing strategy with respect to the redeployment of 200 positions to uniformed positions, namely the criteria for redeployment including equity between the four administrative districts, whom to redeploy, to and from which department, which services will be impacted or eliminated to accommodate this redeployment, and the resultant impact on base policing activity; and":

- (3) for Municipal Licensing and Standards [Recommendation (A)(52)] by increasing the Net amount by \$317,300.00, so that the new Net amount now reads "4,858.0";
- (4) for the Clean and Beautiful City Secretariat [Recommendation (A)(45)] by deleting this budget category and transferring the funds, in the amount of \$317,300.00 gross and \$317,300.00 net, to the 2006 Operating Budget for Municipal Licensing and Standards; and
- (5) for the City Clerk's Office, by deleting Program Recommendation (A)(86) and inserting instead the following:
 - "(86) the City Clerk's Office to provide secretariat support to the following Committees, effective May 1, 2006:
 - (a) Steeles Avenue Sub-committee;
 - (b) Works Committee Community Partnership Sub-Committee; and
 - (c) Gardiner Lake Shore Corridor Task Force."
- (k) Councillor Lindsay Luby moved that the Clause be amended by amending the Program Recommendations, as recommended by the Policy and Finance Committee, for the Community Partnership and Investment Program, by deleting Recommendation (A)(143) of the Policy and Finance Committee and inserting instead the following:
 - "(143) additional funding of \$25,000.00 for the Toronto Region Research Alliance (TRRA) be conditional on TEDCO matching the amount resulting in \$50,000.00 funding to TRRA; and that \$25,000.00 of that be used in support of the Information and Communication Technology (ICT) Sector Marketing Program approved by City Council and that TRRA work with the City and the Greater Toronto Marketing Alliance (GTMA) on the development of the program;".
- (l) Councillor Rae moved that the Clause be amended by amending the Program Recommendations, as recommended by the Policy and Finance Committee:
 - (1) for the Community Partnership and Investment Program, by adding the following:
 - "That \$100,000.00 of funding from the Major Cultural Organizations Grants Program within the 2006 Approved Budget for the Community Partnership and Investment Program designated to Pride Toronto be immediately released, pending an appropriate application being submitted and all the grant criteria being met."; and

- (2) for Capital and Corporate Financing Non Program, to provide that the Mayor's Homeless Initiative Reserve draw of \$1.469 million and the Capital Revolving Fund Reserve draw of \$9.525 million recommended in Appendix C of Report 3, entitled "Reserve Contribution to the 2006 Operating Budget", be reversed and replaced by a draw of \$9.525 million from the Homes for the Aged Capital Reserve Fund and a further draw of \$1.469 million from the Social Housing Stabilization Reserve Fund.
- (m) Councillor Pitfield moved that the Clause be amended by amending the Program Recommendations, as recommended by the Policy and Finance Committee, by:
 - (1) deleting Recommendation (A)(6) of the Policy and Finance Committee and addressing the resulting variance by implementing an across-the-board reduction in the Operating Budget (all programs) of 0.733% (\$55.584 million) with no reduction to service levels, to eliminate the 3% residential tax increase and the 1% business tax increase; and
 - (2) adding the following:

"That:

- (a) the following improvements be included in the 2007 budget process:
 - (i) modified, zero-based budget process 1/3 of Toronto's budget examined each year;
 - (ii) value for money audits;
 - (iii) protection of fixed assets; and
 - (iv) Council to set 3 to 5 priorities not 9; and
- (b) a 1 percent efficiency target be set for the 2006 Operating Budget."
- (n) Councillor Nunziata moved that the Clause be amended by amending the Program Recommendations, as recommended by the Policy and Finance Committee, for Social Development, Finance and Administration, by adding the following:

"That, with the approval of the new/enhanced funding of Neighbourhood Action Community Development in the Social Development, Finance and Administration budget to allow the City to begin implementing the Neighbourhood Action Plans in all the thirteen priority neighbourhoods, City staff ensure the local police divisions, the local Councillor and communities are directly involved in the planning process."

(o) Councillor Hall moved that:

- (1) Part (2)(b) of motion (a) by Councillor Shiner be amended by deleting the words "to Council for its meeting in June 2006, through the Policy and Finance Committee", and inserting instead the words "through the 2007 Operating Budget process", so that Part (2)(b) of motion (a) now reads as follows:
 - "That the City Manager and the Deputy City Manager and Chief Financial Officer report through the 2007 Operating Budget process, on any proposed service changes which may be required to achieve a '0' base budget for 2007."; and
- (2) the Clause be amended by amending the Program Recommendations, as recommended by the Policy and Finance Committee, for Parks, Forestry and Recreation, by adding the following:

"That the General Manager, Parks, Forestry and Recreation, be requested to report to the Economic Development and Parks Committee by June 2006, on the progress of the implementation of the Parks, Forestry and Recreation's new structure based on the Common Grounds report."

- (p) Councillor Moscoe moved that Part (5) of motion (j) by Councillor Kelly be amended by adding the "Parc Downsview Park Operating Protocol Committee" to the secretariat support provided by the City Clerk's Office.
- (q) Councillor De Baeremaeker moved that the Clause be amended by amending the Program Recommendations, as recommended by the Policy and Finance Committee, for the Community Partnership and Investment Program, by adding \$65,000.00 to the grant for the Royal Agricultural Winter Fair to restore the principle of their grant equalling their rent, as approved by City Council in 2005.
- (r) Councillor Augimeri moved that:
 - (1) Part (5) of motion (j) by Councillor Kelly be amended by adding the "Toronto Centre for the Arts Board of Directors" to the secretariat support provided by the City Clerk's Office; and
 - (2) the Clause be amended by amending the Program Recommendations, as recommended by the Policy and Finance Committee, for Parks, Forestry and Recreation and Social Development, Finance and Administration, to provide that the Youth Apprenticeship program "Training in the Trades", be given the highest priority amongst the list of youth programs that the City is forwarding

for funding consideration under the recently announced provincial youth-at-risk initiatives, and staff be directed to do as much as possible to prepare for start up of this program to be implemented as soon as Provincial funds are allocated.

 - (a) The zoning by-law and site plan are approved generally in accordance with the instruments before the Ontario Municipal Board, but amended as set out hereunder. The height of the tower element will be decreased to 22 storeys (70.5 metres), plus mechanical penthouse, from the currently proposed 24 storeys. The mechanical penthouse on the tower element will not exceed 5.2 metres in height or 40 percent of the roof area of the tower element.
 - (b) The site plan and zoning by-law to be approved will also be amended to increase the step back of the ninth floor of the portion of the building adjacent to Stadium Road to 3 metres.
 - (c) The site plan will be revised to show a setback at the southwest corner of the site of 6 metres in width, of which 4.5 metres would be unencumbered, with 1.5 metres subject to a building overhang from the third floor up (approximately 5.8 metres in height), being a total area of approximately 6 X 7.6 metres for the purposes of a parkland (trail) dedication, all as discussed with staff.
 - (d) A reasonable public connection through the north end of the site between the Martin Goodman Trail and Stadium Road, consistent with the site plan, will be provided.
 - (e) An irrigation system for street trees will be installed and operated at the owner's expense, subject to the terms set out below in the section 37 agreement, such that the owner will be responsible for any costs in excess of \$20,000.00.

- (f) The applicant will enter into a section 37 agreement, including the following terms and conditions:
 - (i) Applicant will provide the irrigation system set out in paragraph (e) above, provided that it is an extension of the system on the development site.
 - (ii) Applicant will provide a cash payment for parks improvements in the immediate vicinity of the site, provided that the total cost thereof, together with the irrigation system in paragraph (e) above, does not exceed \$825,000.00.
 - (iii) In consideration of the foregoing, the City will provide Monarch with an encroachment agreement and limiting distance agreement respecting adjacent City lands, as discussed with staff, which would permit the construction of the development contemplated by the site plan. The City will also provide an agreement for tiebacks and a park occupation permit and any other permits required to permit Monarch to occupy a portion of the park to the south of the site (including the "crane swing" overhead) for a temporary period of two years (during construction).
- (2) the City Solicitor and other City staff be authorized to make the necessary revisions to the zoning bylaw, enter into such agreements and take all such other actions as may necessary to give effect to Council's direction as outlined in the confidential report.

- (d) updating of the Canadian Recreational Water Quality Guidelines; and

WHEREAS the approved funding is directed at sharing the cost of the Beaches Management Symposium, which may include travel expenses and disbursements for experts and authorities to speak and participate at the Symposium; and

WHEREAS Her Majesty the Queen in Right of Ontario, represented by the Minister of the Environment, who is responsible for the Ontario Ministry of the Environment and, specifically, the MOE requires that the City enter into a Memorandum of Understanding on certain express terms and conditions; and

WHEREAS there is urgent need to conclude arrangements with the MOE, in order to ensure the receipt of the Funds by the City before MOE's fiscal year end 2005/2006; and

WHEREAS staff are seeking Council approval to receive the Funds and authority for the General Manager, Toronto Water to enter into and execute the Agreements on behalf of the City;

WHEREAS the Etobicoke Sports Hall of Fame inducted Ken Cox into its Sports Hall of Fame, a prestigious roster of local athletes; and

WHEREAS Ken Cox devoted his entire life to minor sports and youth in the Lakeshore area that will leave a lasting legacy with Faustina Sports Club and he will be sorely missed by many Faustina members, friends and the many hockey players that went through the Faustina organization; and

WHEREAS Ken Cox's legacy leaves Faustina Sports Club a pillar of the Lakeshore community, with a solid foundation and a history of making hockey affordable for all kids;

WHEREAS Fred started his community activism as far back as the 1970's as Office Manager for the Stop Spadina Campaign and began his teaching career at York University, instructing classes in Acting Techniques, Theatrical Production, Playwrighting, Ancient and Modern Drama, Medieval Drama, and the drama component of a Foundations course in Ancient Egyptian, Grecian, and Roman ritual; and

WHEREAS along the way he mentored many of our Canadian artists such as Albert Shultz, Kate Hennig, Glenn Morley, Kelly Wolfe, Francesca Accinelli, David Mesiano, John Catucci and Mike Ng Nahrgang, as well as numerous teachers who will touch the lives of generations to come; and

WHEREAS Fred was the Founding Member and Artistic Director of Vanier College Productions at York University, serving as an alternative to and/or in tandem with all Fine Arts faculties; and

WHEREAS Fred was also the Founding Chairman of the Toronto Theatre Alliance, serving as Chair for two years, and in 1971, while employed as a writer and director at Global Village Theatre in downtown Toronto, together with Roy Fleming, Leonard McHardy, Brian Robinson and Terri Kuhl, he instituted and devised a forum where the producing bodies of Toronto could deal with issues and problems endemic to the industry; and

WHEREAS Fred touched the lives of many Canadians with his talents in stage direction and production, with shows like the Ontario Bicentennial Showcase in 1984, Toronto Children's Chorus opera productions for the 1986 World's Fair in Vancouver, writing and staging the Olympic Torch Relay Ceremonies across Canada

in 1988, the first International Treble Choral Festival staged in Firenza (Florence) Italy in 1995, and the Toronto City Hall Review from 1975-1981; and

WHEREAS as a composer, author, playwright, adjudicator and librettist, many communities have been and continue to offer his works throughout Canada; and

WHEREAS Fred was commissioned in 1990, by the Toronto Children's Chorus, to write an original libretto for a Winter Piece with music by Ruth Watson Henderson, and was also known for such works as Nuts and Bolts and Rusty Things (Simon & Pierre), One Potato Too (Young People's Theatre), Anna's Pet (Mermaid Theatre) The Technicolour Wizard and Behind the Wrinkles (Lampoon Puppet theatre); and

WHEREAS Fred's unique knowledge of 'word sound' and imagery led him from poetry to fable and the original concept of the much put upon camel 'Hoshmakaka', who then became the centre of the story of 'The Last Straw', which was first performed as a Sung Fable featuring Ben Heppner and the Toronto Children's Chorus and subsequently recorded by CBC records as a 28 minute piece on the album 'Along the Road to Bethlehem';

Report (March 28, 2006) from the City Solicitor, entitled "The Release of Agreements from Phase III of Block 20/23 in the Railway Lands Central, Ward 20 (Trinity-Spadina)". (See Minute S4.10, Page 68):

Purpose:

To obtain authority to release certain agreements from Phase III of Block 20/23 in the Railway Lands Central.

Financial Implications and Impact Statement:

There are no financial implications resulting from the adoption of this report.

Recommendation:

It is recommended that authority be granted to release Phase III of Block 20/23 in the Railway Lands from the development agreements listed in Appendix "B" to the City Solicitor's report dated March 28, 2006 (subject to the preconditions set out in Appendix "B"), and that authority also be granted to enter into the necessary replacement agreement.

Background:

The blocks within Railway Lands Central (as shown on Appendix "A") are subject to a number of agreements to secure the necessary hard and soft infrastructure and other matters respecting their development.

Concord Adex Developments Corp. ("Concord Adex") is the owner of Block 20/23, which it is developing as condominiums in Phases I, II and III. Phase I is the northwest quadrant, Phase II is the southwest quadrant and Phase III is the east half of the Block. Concord Adex expects to convey the residential units in Phase III during the month of April, 2006. Concord Adex has requested the City to release certain development agreements prior to these conveyance dates.

Comments:

Appendix "B" contains a summary of each of the agreements Concord Adex has requested the City to release from Phase III of Block 20/23 and my comments upon the request. I am recommending that the agreements be released subject to certain conditions, which relate to City officials confirming that certain matters have been satisfied and the execution of a replacement agreement.

City Council has previously authorized the release of these same agreements in respect of Blocks 19 and 21 and Phases I and II of Block 20/23.

Conclusion:

It is appropriate for City Council to authorize the release of the agreements listed in Appendix "B" and that authority also be granted to enter into the necessary replacement agreement.



The 1994 Acknowledgement Agreement

Under this Agreement, the parties confirmed their rights and obligations pursuant to the terms of the 1986 Stadium Precinct Agreement and, among other matters, agreed to two major terms, namely: (1) the parties agreed to a cost sharing formula for hard and soft infrastructure for all of the lands west of Spadina, and (2) the owner agreed to advance the construction of the Community Park from the date stipulated in the Stadium Precinct Agreement to such time as the owner had sold at least 50 percent of its development blocks within either the Railway Lands West or the Railway Lands Central. This park construction trigger was met with the subsequent conveyances to CLC and, thereafter, to Concord Adex. As the construction of this park has since been secured in the Subdivision Agreement for the Railway Lands West dated September 24, 2003, I am recommending that this Agreement be released from Phase III of Block 20/23.

The 1994 Railway Lands Central Agreement

Section 3.1, which is the only section imposing a positive obligation on the owner, requires the owner to provide the Southern Linear Park on that part of Block 20/23 abutting the north side of Lakeshore Boulevard West. As this obligation is currently being addressed as part of the site plan conditions for the development of Phase III, it is appropriate to release Phase III from the Agreement.

The 1994 Environmental Agreement (the "1994 Environmental Agreement")

This agreement provides that any site plan applications for Block 20/23 must address certain environmental issues applicable to those Blocks. The requirements include an obligation to submit certain studies to the satisfaction of the Commissioner of Urban Development Services and to undertake all excavation work in accordance with approved soil and groundwater management plans under the supervision of an environmental specialist consultant. Certain ongoing obligations such as a requirement that warning clauses respecting air quality and noise are to be registered on title and that non-glare glass be used above 35 metres also apply to Block 20/23.

The 1994 Environmental Agreement stipulates that it shall be discharged against each block as it is developed provided that all ongoing obligations are secured by a site specific development agreement. I am therefore recommending that the 1994 Environmental Agreement be released from Phase III of Block 20/23 provided: the Chief Planner advises that all required studies have been submitted to the Chief Planner's satisfaction; that the required environmental compliance certificates are delivered; and, Concord Adex enters into a replacement agreement, to be registered against the Phase III Block 20/23 lands, securing the ongoing obligations in respect of that part of the Block.

1994 Heritage Agreement

This Agreement contains provisions related to archaeological resources. As Concord Adex advises that Block 20/23 has been fully excavated, it is appropriate to release this agreement upon confirmation from the appropriate staff that all heritage obligations have been performed in respect of the Block.

1994 Escrow Agreement

This Agreement provides for the deposit into escrow of park and street conveyances. As the Escrow Agreement is registered against the title to the park and streets to be conveyed to the City and as deeds have been delivered to the escrow agent, I recommend that the Escrow Agreement be released from Phase III of Block 20/23.

The 1997 Acknowledgement Agreement re Stadium Precinct Agreement

There are no outstanding obligations in this Agreement as it simply acknowledges the 1997 release of the owner's obligations under the Stadium Precinct Agreement to provide Tower Park East and Tower Park West at the base of the CN Tower. This was done to permit the expansion of the building at the base of the CN Tower. As this Agreement was originally registered against Block 20/23 because of the 1994 Acknowledgement Agreement, I recommend that it be released from Phase III of Block 20/23 upon the release of the 1994 Acknowledgement Agreement.

The 1997 Cityplace Central and Cityplace West Acknowledgement Agreement

Concord Adex is asking for a release of the obligations relating to public art as set forth in Article 4 of this Agreement. It is appropriate to release these obligations from Phase III upon confirmation from the appropriate staff that all public art obligations have been performed in respect of Phase III.

The 1998 Acknowledgement Agreement re Closing of Station Street

There are no outstanding obligations in this agreement as it simply acknowledges the fulfilment of a condition contained in the Stadium Precinct Agreement. As this Agreement was originally registered against Block 20/23 because of the 1994 Acknowledgement Agreement, I recommend that it be released from Phase III of Block 20/23 upon the release of the 1994 Acknowledgement Agreement.
