The Bid Committee considered a report (May 24, 2007) from the General Manager, Transportation Services and the Director, Purchasing and Materials Management, advising on the results of Tender Call 124-2007 issued for the Local Road Resurfacing, in accordance with specifications as required by Transportation Services, and requesting authority to award a contract to the recommended bidder.

Recommendation:

The Executive Director of Technical Services and the Director of Purchasing and Materials Management recommend that authority be granted to award Contract 07SC-08RD, Tender Call 126-2007, for McCowan Road, Major Road Resurfacing and Concrete Median Extension; Town Centre Court, Local Road Resurfacing, to Furfari Paving Co. Recommendation:

The Executive Director of Technical Services and the Director of Purchasing and Materials Management Division recommend that authority be granted to award Contract 07FS-08S, Tender Call 131-2007, for the Birchmount Road Bridge over CPR Rail Line, Structural Rehabilitation to Belor Construction Ltd., in the total amount of \$2,399,563.00, net of GST, having submitted the lowest bid.

The Bid Committee considered a report (May 16, 2007) from the Executive Director, Technical Services and the Director, Purchasing and Materials Management, advising on the results of Tender Call 107-2007 issued for the reconstruction and widening of Bathurst Street from Shallmar Boulevard to Lawrence Avenue West, in North York District, in accordance with specifications as required by Technical Services and requesting authority to award a contract to the recommended bidder.

Recommendation:

The Executive Director of Technical Services and the Director of Purchasing and Materials Management recommend that authority be granted to award Contract 07NY-01RD, Tender Call 107-2007, for reconstruction and widening on Bathurst Street from Shallmar Boulevard to Lawrence Avenue West, to Trisan Construction, in the amount of \$5,278,361.55 net of GST having submitted the lowest bid.

22.7 Contract 07FS-06S, Tender Call 123-2007 Maple Leaf Drive Bridge over Black Creek Drive, Maple Leaf Drive and Queen's Drive Bridges over Black Creek Structure Rehabilitation (Wards 11 and 12 York South-Weston)

The Bid Committee considered a report (May 25, 2007) from the Executive Director, Technical Services and the Director, Purchasing and Materials Management, advising of the results of Tender Call 123-2007 issued for the Structural Rehabilitation of the Maple Leaf Drive Bridge over Black Creek Drive, Maple Leaf Drive and Queen's Drive Bridges over Black Creek in accordance with specifications as required by Technical Services, and requesting authority to award a contract to the recommended bidder.

Recommendation:

The Executive Director of Technical Services and the Director of Purchasing and Materials Management recommend that authority be granted to award Contract 07FS-06S, Tender Call 123-2007 to Bridgecon Construction Ltd., in the total amount of \$3,187,600.00 net of GST, for the Structural Rehabilitation of Maple Leaf Drive Bridge over Black Creek Drive, Maple Leaf Drive and Queen's Drive Bridges over Black Creek, having submitted the lowest bid.

On motion by Abdi Nur, the Bid Committee adopted the staff recommendation in the Recommendation Section of the report (May 25, 2007) from the Executive Director, Technical Services and the Director, Purchasing and Materials Management.

22.8 Request for Proposal No. 9117-07-7073 Expansion of the Dufferin Reservoir Professional Engineering Services

The Bid Committee considered a report (May 17, 2007) from the Executive Director, Technical Services and the Director, Purchasing and Materials Management, advising on the results of the Request for Proposals (RFP) 9117-07-7073 for the provision of professional engineering services for the Expansion of the Dufferin Reservoir, and requesting authority to enter into an agreement with the recommended proponent.

Recommendations:

The Executive Director of Technical Services and the Director of Purchasing and Materials Management recommend that authority be granted to enter into an agreement in the amount of \$1,338,815 net of GST, including provisional items, disbursements, contingencies, to GENIVAR Ontario Inc. having submitted the highest scoring proposal, for the provision of professional engineering services for the Expansion of the Dufferin Reservoir as follows:

- a) For the pre-design and detailed design, an amount not to exceed \$351,175.00 including provisional items and, disbursements. This amount includes a contingency allowance of \$46,000, for additional services, if necessary and authorized by the Executive Director, Technical Services; and
- b) For services during construction including general office administration and site supervision services, an amount not to exceed \$962,607.00 including provisional items and disbursements for a construction period of up to 104 weeks. This amount includes a contingency allowance of \$126,000.00, to cover resident staff services during construction beyond a period of 104 weeks, at a rate not to exceed \$7,300.00 per week including disbursements, if necessary and authorized by the Executive Director, Technical Services; and
- c) For the post-construction services, an amount not to exceed \$25,033.00 of including disbursements and including a contingency allowance of \$3,000.00 for additional services, if necessary and authorized by the Executive Director, Technical Services.

On motion by Abdi Nur, the Bid Committee adopted the staff recommendations in the Recommendation Section of the report (May 17, 2007) from the Executive Director, Technical Services and the Director, Purchasing and Materials Management.
