Confirmation of Minutes

On motion by Don Altman, the minutes of the meeting of the Bid Committee held on July 4, 2007, were confirmed.

26.1 Contract 07NY-314WP, Tender Call 94-2007 - Trenchless Rehabilitation of Sewer Service Connections within Hoggs Hollow Community - North York District (Ward 25 – Don Valley West)

The Bid Committee considered a report (June 19, 2007) from General Manager, Toronto Water and the Director, Purchasing and Materials Management, advising on the results of Tender Call 94-2007 issued for the Trenchless Rehabilitation of Sewer Service Connection within Hoggs Hollow Community-North York District, in accordance with specifications as required by Toronto Water, and requesting authority to award a contract to the recommended bidder.

Recommendation:

The General Manager of Toronto Water and the Director of Purchasing and Materials Management recommend that authority be granted to award Contract 07NY-314WP, Tender Call 94-2007 to D. M. Robichaud Ltd., in the amount of \$4,217,400.00 net of GST, for the Trenchless Rehabilitation of Sewer Service Connection within Hoggs Hollow Community - North York District, having submitted the only bid.

On motion by Anthony Paolini, the Bid Committee adopted the staff recommendation in the Recommendation Section of the report (June 19, 2007) from General Manager, Toronto Water and the Director, Purchasing and Materials Management.

26.2 Contract 07FS-15S, Tender Call 155-2007 Davenport Road Underpass/C.P.R. North of Dupont Street Bridge Rehabilitation (Ward 20 – Trinity Spadina and Ward 22–St. Paul’s)

The Bid Committee considered a report (June 19, 2007) from the Executive Director, Technical Services and the Director, Purchasing and Materials Management, advising on the results of Tender Call 155-2007 issued for the Structural Rehabilitation of the Davenport Road Underpass of C.P.R. north of Dupont Street, in accordance with specifications as required by Technical Services, and requesting authority to award a contract to the recommended bidder.

Recommendation:

The Executive Director of Technical Services and the Director of Purchasing and Materials Management recommend that authority be granted to award Contract 07FS-15S, Tender Call 155-2007 to Grascan Construction Ltd./Torbridge Construction Ltd., in the amount of \$2,236,000.00, net of GST for the Structural Rehabilitation of the Davenport Road Underpass of C.P.R. north of Dupont Street having submitted the lowest bid.

26.3 Contract 07EY-09RD, Tender Call 164-2007 Resurfacing of Algoma and Milton Streets, and Rehabilitation of Melrose Street including Sanitary Sewers/Services on Melrose Street and Milton Street and Storm Sewers on Melrose Street (Ward 6 Etobicoke – Lakeshore)

The Bid Committee considered a report (June 19, 2007) from the Executive Director, Technical Services and the Director, Purchasing and Materials Management, advising on

the results of Tender Call 164-2007 issued for the Resurfacing of Algoma and Milton Streets, and Rehabilitation of Melrose Street including Sanitary Sewers/Services on Melrose Street and Milton Street and Storm Sewers on Melrose Street, in accordance with specifications as required by Technical Services, and requesting authority to award a contract to the recommended bidder.

Recommendation:

The Executive Director of Technical Services and the Director of Purchasing and Materials Management recommend that authority be granted to award Contract 07EY-09RD, Tender Call 164-2007, for the Resurfacing of Algoma and Milton Streets, and Rehabilitation of Melrose Street including Sanitary Sewers/Services on Melrose Street and Milton Street and Storm Sewers on Melrose Street, to Pave-All Limited, in the amount of \$2,470,364.27, net of GST having submitted the lowest bid.

On motion by Wayne Scott, the Bid Committee adopted the staff recommendation in the Recommendation Section of the report (June 19, 2007) from the Executive Director, Technical Services and the Director, Purchasing and Materials Management.

26.4 Contract 07TE-323WS, Tender Call 169-2007 Water Service Line Replacements at Various Locations within the Toronto-East York District (Wards 14, 18, 19, 20, 21, 22, 27, 28, 29, 30, 31 and 32)

The Bid Committee considered a report (June 26, 2007) from the General Manager, Toronto Water and the Director, Purchasing and Materials Management, advising on the results of Tender Call 169-2007 issued for the Water Service Line Replacements at Various locations within the Toronto – East York District, in accordance with specifications as required by Toronto Water, and requesting authority to award a contract to the recommended bidder.

Recommendation:

The General Manager of Toronto Water and the Director of Purchasing and Materials Management recommend that authority be granted to award Contract 07TE-323WS, Tender Call 169-2007 to Rabcon Contractors, in the amount of \$1,064,620.00 net of GST, for the Water Service Line Replacements at Various Locations within the Toronto-East York District, having submitted the lowest bid.

On motion by Anthony Paolini, the Bid Committee adopted the staff recommendation in the Recommendation Section of the report (June 26, 2007) from the General Manager, Toronto Water and the Director, Purchasing and Materials Management.

26.5 Contract 07EY-324WS, Tender Call 170-2007 Water Service Line Replacements at Various Locations within the Etobicoke - York District (Wards 1, 2, 4, 5, 6, 7, 12, 13 and 17)

The Bid Committee considered a report (June 29, 2007) from the General Manager of Toronto Water and the Director, Purchasing and Materials Management, advising on the results of Tender Call 170-2007 issued for the Water Service Line Replacements at various locations within the Etobicoke –York District, in accordance with specifications as required by Toronto Water, and requesting authority to award a contract to the recommended bidder.

Recommendation:

The General Manager of Toronto Water and the Director of Purchasing and Materials Management recommend that authority be granted to award Contract 07EY-324WS, Tender Call 170-2007, to Utility Force Inc., in the amount of \$582,300.00 net of GST, for the Water Service Line Replacements at various locations within the Etobicoke-York District having submitted the lowest bid.

On motion by John Liotta, the Bid Committee adopted the staff recommendation in the Recommendation Section of the report (June 29, 2007) from the General Manager of Toronto Water and the Director, Purchasing and Materials Management.

26.6 Contract 07TE-327WS, Tender Call 172-2007 Water Service Line Replacements at Various Locations within the Toronto-East York District (Wards 27, 28, 29, 30, 31 and 32)

The Bid Committee considered a report (June 26, 2007) from the General Manager, Toronto Water and the Director, Purchasing and Materials Management, advising on the results of Tender Call 172-2007 issued for the Water Service Line Replacements at Various locations within the Toronto – East York District, in accordance with specifications as required by Toronto Water, and requesting authority to award a contract to the lowest bidder.

Recommendation:

The General Manager of Toronto Water and the Director of Purchasing and Materials Management recommend that authority be granted to award Contract 07TE-327WS, Tender Call 172-2007, to Utility Force Inc., in the amount of \$689,950.00 net of GST, for the Water Service Line Replacements at Various Locations within the Toronto - East York District, having submitted the lowest bid.

On motion by Anthony Paolini, the Bid Committee adopted the staff recommendation in the Recommendation Section of the report (June 26, 2007) from the General Manager, Toronto Water and the Director, Purchasing and Materials Management.

26.7 Contract 07SC-322WP, Tender Call 176-2007 - The Full Length Trenchless Rehabilitation of Existing Gravity Sewers – Scarborough District (Wards 35, 36, 37, 38, 39, 40, 43 and 44)

The Bid Committee considered a report (June 29, 2007) from the General Manager of Toronto Water and the Director, Purchasing and Materials Management, advising on the results of Tender Call 176-2007 issued for the Full Length Trenchless Rehabilitation of Existing Gravity Sewers – Scarborough District, in accordance with specifications as required by Toronto Water, and requesting authority to award a contract to the lowest bidder.

Recommendation:

The General Manager of Toronto Water and the Director of Purchasing and Materials Management recommend that authority be granted to award Contract 07SC-322WP, Tender Call 176-2007, to Insituform Technologies Ltd. in the amount of \$1,710,076.70 net of GST, for the Full Length Trenchless Rehabilitation of Existing Gravity Sewers – Scarborough District having submitted the lowest bid.

On motion by Anthony Paolini, the Bid Committee adopted the staff recommendation in the Recommendation Section of the report (June 29, 2007) from the General Manager of Toronto Water and the Director, Purchasing and Materials Management.
