On motion by Laurie McQueen, the minutes of the meeting of the Bid Committee held on August 1, 2007, were confirmed.

# 30.1 Request for Quotation 3907-07-5143 Building Repairs for Various Hostels Locations on an As-Required Basis (Wards – All)

The Bid Committee considered a report (July 23, 2007) from the General Manager of Shelter, Support and Housing Administration and the Director of Purchasing and Materials Management, advising on the results of the Request for Quotation 3907-07-5143 issued for the provision of all labour, equipment and material necessary for Building Repairs for various Hostels locations on an as-required basis, and requesting authority to award a contract to the recommended bidder.

#### Recommendation:

The General Manager, Shelter, Support and Housing Administration and the Director of Purchasing and Materials Management recommend that authority be granted to award a contract to B. E. Gilmore Contracting Group Inc., being the lowest bid received, for the period from date of award to May 31, 2008 for a total amount not to exceed \$202,500.00, net of GST, which includes a miscellaneous amount for materials of \$5,677.50, with an option to renew for an additional 2 two-year periods, up to a total amount of \$405,000.00, net of GST for each option term at the sole discretion of the General Manager, Shelter, Support and Housing Administration. Should the options to renew be exercised, then the General Manager, Shelter, Support and Housing Administration will instruct the Chief Purchasing Official to process the necessary contract renewals under the same terms and conditions, for a total potential cost of \$1,012,500.00, net of GST for the period from the date of award until May 31, 2012.

#### **Recommendation:**

The Executive Director of Technical Services and the Director of Purchasing and Materials Management recommend that authority be granted to award a contract for Contract 07NY-05WS, Tender Call 208-2007, watermain replacements on Citation Drive, Palomino Crescent, Bunty -Lane, Wycliffe Crescent, Bomarc Road and Whitelock Crescent to CG Construction Services Ltd., in the amount of \$1,233,921.00, net of GST, having submitted the lowest bid.

## 30.6 Request for Quotation 0211-07-0077 Detergents, Disinfectants and Floor Care Products (Wards – All)

The Bid Committee considered a report (August 1, 2007) from the Director of Purchasing and Materials Management, advising on the results of the Request for Quotation 0211-07-0077 for the supply and delivery of detergents, disinfectants and floor care products to various City Store warehouse locations within the City of Toronto, in accordance with the specifications as required by the Materials Management and Stores, and requesting authority to award a contract to the recommended bidder.

#### Recommendations:

The Director of Purchasing and Materials Management recommends that:

- 1. authority be granted to award the contract for the supply and delivery of detergents, disinfectants and floor care products to Mister Chemical, being the lowest bidder, for the period from the date of award to May 31, 2008 for a total of \$181,188.54, net of GST, with the option to renew for an additional three separate one-year periods; and
- 2. should the options to renew be exercised, the Manager of Materials Management and Stores will instruct the Director of Purchasing and Materials Management to process the necessary contract renewals under the same terms and conditions to exercise the three separate one-year periods ending May 31, 2009 (\$188,652.81, net of GST), May 31, 2010 (\$192,222.54, net of GST) and May 31, 2011 (\$197,983.33, net of GST). The total potential contract award for all four years identified in this report is \$758,047.23, net of GST.

### Recommendation:

The Executive Director of Technical Services and the Director of Purchasing and Materials Management recommend that authority be granted to award Contract 07NY-11WS, Tender Call 204-2007, for replacement of watermains on Baycrest Avenue, Khedive Avenue, Rajah Street and Sultana Avenue, in North York District, to Sam Rabito Construction Ltd. in the amount of \$1,273,696.24, net of GST, having submitted the lowest bid.
