Recommendations:

The Director of Purchasing and Materials Management Division recommends that:

1. Authority be granted to award a contract for the Provision of Concrete Cutting Services Complete with Operator to Accrue Contracting Ltd. being the lowest bidder for North York, and Toronto East York Districts and the only bidder for

Scarborough and Etobicoke York Districts, from the date of award to October 31, 2008 for a total amount of \$377,250.00 net of GST, with the option to renew for two (2) additional separate (1) one year periods, at the sole discretion of the City. Should the option to renew be exercised, the General Manager of Toronto Water, will instruct the Director of Purchasing and Materials Management to process the necessary contract renewals under the same terms and conditions for the period from November 1, 2008 to October 31, 2009 in the amount of \$518,500.00 net of GST and from November 1, 2009 to October 31, 2010 in the amount of \$534,000.00 net of GST. The total potential contract award identified in this report including option years is \$1,429,750.00 net of GST.
