### Recommendation:

The Acting Director of Purchasing and Materials Management recommended that:

1. authority be granted to award Contract 08SC-02RD, Tender Call 81-2008 to Furfari Paving Co. Ltd., in the amount of \$1,486,824.75 net of GST, for the Pharmacy Avenue Major Road Resurfacing – 25m North of Finch Avenue East to 25m South of McNicoll Avenue, Scarborough District having submitted the lowest bid in conformance with the tender requirements.

Professional Engineering Services for Creek Design and Rehabilitation Study to Remove Sanitary Sewer Maintenance Holes from being in contact with Stream Channel (Various Wards)

The Bid Committee considered a report (May 16, 2008) from the Acting Director of Purchasing and Materials Management, advising on the results of Request for Proposal (RFP) 9117-07-7146 for the provision of contracted professional services related to Creek Design & Rehabilitation Study to remove sanitary sewer maintenance holes from being in contact with stream channels in the City of Toronto, and requesting authority to enter into an agreement with the recommended proponent.

### Recommendations:

The Acting Director of Purchasing and Materials Management recommended that:

1. authority be granted to enter into an agreement in the total amount of \$856,920.00 net of GST, including provisional items, disbursements and contingencies, with Aquafor Beech Limited having submitted the highest scoring proposal meeting

the requirements of the RFP to provide engineering services for study, preliminary design, detailed design, construction contract administration and post construction services related to Creek Design and Rehabilitation Study to remove sanitary sewer maintenance holes from being in contact with stream channel, as follows:

- a. for the channel analysis, preliminary design and detailed design, an amount not to exceed \$340,170.00 net of GST including provisional items and disbursements. This amount includes a contingency allowance of \$56,695.00 net of GST for additional services if necessary and authorized by the General Manager of Toronto Water;
- b. for services during construction including general office administration and site engineering services, an amount not to exceed \$516,750.00 net of GST including provisional items and disbursements for a construction period of up to 52 weeks.

On motion by Anna Alcamo, the Bid Committee adopted the staff recommendation in the Recommendation Section of the report (May 16, 2008) from the Acting Director of Purchasing and Materials Management.

### 71.10 Request for Proposal 9145-08-7004 - Selection of Advertising Agency Services – Toronto Public Health (All Wards)

The Bid Committee considered a report (May 21, 2008) from the Acting Director of Purchasing and Materials Management, advising on the results of Request for Proposal (RFP) 9145-08-7004 and requesting authority to enter into an agreement with the recommended proponent to provide advertising agency services to Toronto Public Health (TPH).

### Recommendation:

The Acting Director of Purchasing and Materials Management recommended that:

1. authority be granted to enter into an agreement with Axmith, McIntyre, Wicht Ltd., in the amount of \$400,000.00 net of GST from the date of award to June 30, 2009, having submitted the highest scoring proposal meeting the requirements of the RFP, with the option to extend the contract for an additional two separate one year periods from July 1, 2009 to June 30, 2010 (\$400,000.00 net of GST) and July 1, 2010 to June 30, 2011 (\$400,000.00 net of GST) at the sole discretion of the Medical Officer of Health. Should the option to renew be exercised, then the Medical Officer of Health will request the Acting Director, Purchasing and Materials Management to process the necessary contract renewals under the same terms and conditions. The total potential contract award is \$1,200,000.00 net of GST.

The Acting Director of Purchasing and Materials Management recommended that:

1. authority be granted to award a contract for Request for Quotation 1201-08-5097, issued for the Traffic Signal Controller Conversions at various existing locations to Beacon Utility Contractors Limited who submitted the lowest bid meeting specifications in the amount of \$657,248.00 net of GST.

On motion by Mae Maracle, the Bid Committee adopted the staff recommendation in the Recommendation Section of the report (May 21, 2008) from the Acting Director of Purchasing and Materials Management.

Maintenance Inspections/Repairs and Periodic Mandatory Commercial Vehicle (P.M.C.V) Inspections on Class 8 Truck Tractors (All Wards)

The Bid Committee considered a report (May 20, 2008) from the Acting Director of Purchasing and Materials Management, advising the Bid Committee on the results of the Request for Quotation (RFQ) 6102-08-3042 for the supply all labour, materials and equipment necessary to perform Maintenance Inspections/Repairs and Periodic Mandatory Commercial Vehicle (P.M.C.V) Inspections on Class 8 Truck Tractors for a one year period with the option to renew for three additional separate one year periods, all in accordance with specifications as requested by Solid Waste Management Services.

### Recommendation:

The Acting Director of Purchasing and Materials Management recommended that:

1. authority be granted to award a contract for the supply of all labour, materials and equipment necessary to perform Maintenance Inspections/Repairs and Periodic Mandatory Commercial Vehicle (P.M.C.V) Inspections on Class 8 Truck Tractors to Parante Garage, being the lowest bidder meeting specifications for the period from date of award to May 31, 2009 for a total cost of \$182,666.38 net of GST, with the option for three (3) additional separate one (1) year periods at the sole discretion of the General Manager of Solid Waste Management Services. Should the options to renewed be exercised, then the General Manager of Solid Waste Management Services will request the Acting Director of the Purchasing and Materials Management Division to provide the necessary contract renewals under the same terms and conditions to exercise the three (3) additional one (1) period ending May 31, 2010 (\$152,997.93 net of GST), May 31, 2011 (\$157,207.15 net of GST) and May 31, 2012 (\$161,885.13 net of GST). The total potential contract award including the options years identified in this report is \$654,756.59 net of GST.

On motion by Darren Delorey, the Bid Committee adopted the staff recommendation in the Recommendation Section of the report (May 20, 2008) from the Acting Director of Purchasing and Materials Management.
