The Bid Committee considered a report (June 2, 2008) from the Acting Director of Purchasing and Materials Management, advising the Bid Committee on the results of Tender Call 82-2008 issued for the Structural Rehabilitation of the Skyway Avenue Bridge over Mimico Creek, south of Dixon Road and east of International Boulevard, in accordance with specifications as required by Technical Services, and requesting the authority to award a contract to the recommended bidder.

#### 73.8 Request for Quotation 6718-08-3055 - Full Elevator Maintenance Service

The Bid Committee considered a report (June 5, 2008) from the Acting Director of Purchasing and Materials Management, advising on the results of the Request for Quotation issued for the supply of all labour, equipment and materials necessary for Full Elevator Maintenance Service, for various City of Toronto Buildings for a sixty (60) month service period from July 1, 2008 to June 30, 2013 and requesting authority to award contracts to the recommended bidders.

#### Recommendations:

The Acting Director of Purchasing and Materials Management recommends that:

1. Authority be granted to award contracts for the supply of all labour, equipment, and materials necessary for Full Elevator Maintenance Service,

for various City of Toronto Buildings for the period from July 1, 2008 to June 30, 2013 to the following bidders:

- a) Kone Inc., in the amount of \$2,808,510.00 net of GST, for elevating devices being the lowest bidder in the following Divisions: Emergency Medical Services (EMS), Toronto Long-Term Care Homes and Services, Children Services, Shelter, Support and Housing (except for 291 Sherbourne St.-Robertson House), Parks, Forestry and Recreation, Economic Development, Culture and Tourism (EDCT), Toronto Water (except for 9 Leslie Street Ashbridges Bay Treatment Plant), Facilities and Real Estate (except for 40 College Street Police Headquarters, 100 Queen Street West City Hall and 55 John Street Metro Hall); and
- b) Otis Canada Inc. in the amount of \$1,927,915.35 net of GST being the lowest bidder in the following Divisional locations: Shelter, Support and Housing: 291 Sherbourne St. Robertson House, Toronto Water: 9 Leslie Street Ashbridges Bay Treatment Plant, Facilities and Real Estate: 40 College Street Police Headquarters, 100 Queen Street West City Hall and 55 John Street Metro Hall.

Refer to Appendix A for detailed results. The total potential cost of these awards to the City net of GST is \$4,736,425.35.

Ltd., in the amount of \$1,513,240.00, net of GST, having submitted the lowest bid meeting specifications in conformance with the Tender requirements.
