Confirmation of Minutes

On motion by Don Altman, the minutes of the meeting of the Bid Committee held on June 25, 2008, were confirmed.

76.1 Request for Quotation 3907-08-5044, Construction of Lee Centre Park, Lee Centre Drive, Toronto

The Bid Committee considered a report (June 16, 2008) from the Acting Director of Purchasing and Materials Management, advising the Bid Committee on the results of the Request for Quotation (RFQ) 6907-08-3026 and requests the Bid Committee authorize staff to award a contract to the recommended bidder for the provision of Mobile Fueling Service, Low Sulphur Coloured Diesel Fuel for a one (1) year period (date of award to May 31, 2009) with the option to renew for three (3) additional separate one (1) year periods, all in accordance with specifications as requested by Fleet Services.

Recommendation:

The Acting Director of Purchasing and Materials Management recommends that:

1. The Bid Committee authorize staff to award a contract for the provision of Mobile Fueling Service, Low Sulphur Coloured Diesel Fuel to Alpha Oil Inc., being the lowest bid received meeting specifications for the period from date of award to May 31, 2009 for a total cost of \$146,625.00 net of GST and subject to weekly adjustments based on the Bloomberg Oil Buyers Guide, with the option for three (3) additional separate one (1) year periods at the sole discretion of the Director of Fleet Services. Should the options to renew be exercised, then the Director of Fleet Services will request the Director of the Purchasing and Materials Management Division to provide the necessary contract renewals under the same terms and conditions to exercise the three (3) additional, separate one (1) periods ending May 31, 2010 (\$146,625.00 net of GST), May 31, 2011 (\$146,625.00 net of GST) and May 31, 2012 (\$146,625.00 net of GST). The total potential contract award including the option years identified in this report is \$586,500.00 net of GST.

The Bid Committee considered a report (June 19, 2008) from the Acting Director of Purchasing and Materials Management, advising on the results of Tender Call 95-2008 issued for Port Union Road Construction and Streetscaping – Lawrence Avenue East to North of Bridgend Street, Lawrence Avenue Sidewalk Construction – 100m East of Bridgeport Street to 200m East of Bridgeport Street, Scarborough District in accordance with specification as required by Technical Services, and requesting the authority to award a contract to the recommended bidder.

Recommendation:

The Acting Director of Purchasing and Materials Management recommends that:

1. Authority be granted to award Contract No. 08SC-06RD, Tender Call 95-2008 to Lafarge Paving & Construction Limited, in the amount of \$704,877.59 net of GST, for Port Union Road Construction and Streetscaping – Lawrence Avenue East to North of Bridgend Street and Lawrence Avenue Sidewalk Construction - 100m East of Bridgeport Street to 200m East of Bridgeport Street, Scarborough District having submitted the lowest bid in conformance with the Tender requirements.

Recommendation:

The Acting Director of Purchasing and Materials Management recommends that:

1. Authority be granted to award Contract No. 08FS-07S, Tender Call 117-2008 for the Rehabilitation of the Eglinton Avenue West Bridge over Beltline, east of Spadina Road to Bridgecon Construction Ltd., in the amount of \$2,797,400.00 net of GST having submitted the lowest bid in conformance with the Tender requirements.

Recommendation:

Authority be granted to award Contract 08NY-01WS, Tender Call 84-2008, for Watermain Replacements on Brian Drive, Calderon Crescent, Drewry Avenue, Muirhead Drive and Old Sheppard Avenue to F.D.M Contracting Co. Ltd., in the amount of \$1,832,391.00 net of GST, having submitted the lowest bid meeting specifications in conformance with the Tender requirements.

Recommendation:

The Acting Director of Purchasing and Materials Management recommends that:

1. Authority be granted to award Contract No. 08NY-19RD, Tender Call 118-2008, for Yonge Street median modification and widening of southbound lane to provide longer storage length for left turning traffic to Hwy. 401 East in North York District to Pave-All Limited, in the amount of \$530,953.40 net of GST,

having submitted the lowest bid meeting specifications in conformance with the Tender requirements.

Authority be granted to award Contract 08NY-115TR, Tender Call 132-2008, to Supply, Replace, and Adjust Frames, Grates and Covers for Maintenance Holes and Catchbasins, to Miconi Construction Ltd., in the amount of \$651,938.20, net of GST, having submitted the lowest bid meeting specifications in conformance with the Tender requirements.

The Acting Director of Purchasing and Materials Management recommends that:

1. Authority be granted to award Contract 08EY-16WP, Tender Call 126-2008 to Rymall Construction Inc., in the amount of \$1,578,713.19 net of GST, for the Sanitary Sewer Replacement on Cabernet Circle, Moselle Drive, Oakfield Drive and Tizzard Avenue, having submitted the only bid and meeting specifications in conformance with the Tender requirements.

On motion by Wayne Scott, the Bid Committee adopted the staff recommendation in the Recommendation Section of the report (June 20, 2008) from the Acting Director of Purchasing and Materials Management.
