The Bid Committee met on Wednesday, August 6, 2008 in Meeting Room A, 2nd Floor, City Hall, commencing at 2:00 p.m.

Confirmation of Minutes

On motion by Laurie McQueen, the minutes of the meeting of the Bid Committee held on July 30, 2008, were confirmed.

81.1 Contract Award - Request for Quotation 6125-08-3131 - Provision of Tire Inspections, Installation, & Road Service (Wards: All)

The Bid Committee considered a report (July 17, 2008) from the Acting Director of Purchasing and Materials Management, advising on the results of the Request for Quotation (RFQ) 6125-08-3131 and requesting the Bid Committee to authorize staff to award a contract to the recommended bidder for the Provision of Tire Inspections, Installation and Road Service for a two (2) year period with the option to renew for three (3) additional separate one (1) year periods, all in accordance with specifications as requested by Fleet Services.

Recommendation:

The Acting Director of Purchasing and Materials Managements recommends that:

1. The Bid Committee authorize staff to award a contract for the provision of Tire Inspections, Installation and Road Service to J.F. Tire Service Inc., being the only bid received meeting specifications for the period from August 1, 2008 to July 31, 2010 for a total cost of \$1,762,603.20 net of GST, with the option to renew for three (3) additional, separate one (1) year periods at the sole discretion of the Director of Fleet Services. Should the options to renew be exercised, then the Director of Fleet Services will request the Director of the Purchasing and Materials Management Division to provide the necessary contract renewals under the same terms and conditions to exercise the three (3) additional, separate one (1) year periods ending July 31, 2011 in the amount of \$925,366.68 net of GST, July 31, 2012 in the amount of \$953,127.68 net of GST and July 31, 2013 in the amount of \$991,252.79 net of GST. The total potential contract award including the option years identified in this report is \$4,632,350.35 net of GST.

The Bid Committee considered a report (July 30, 2008) from the Acting Director of Purchasing and Materials Management, advising on the results of RFQ 3707-08-0202 for the supply of all labour, equipment and materials required for Site preparation and Installation of Soil Amendment at various locations throughout the City of Toronto from date of award to December 31, 2008, with the option to renew for two (2) additional separate one (1) year periods, and requesting authority to award a contract to the recommended bidder.

Recommendation:

The Acting Director of Purchasing and Materials Management recommends that:

1. The Bid Committee grant authority to award a contract for Site Preparation and Installation of Soil Amendment at various locations throughout the City of Toronto, to Lomco Limited being the lowest bidder meeting specifications, for the period from date of award to December 31, 2008 for a total cost of \$ 453,000.00 net of GST, with the option to renew for two (2) additional one (1) year periods at the sole discretion of the City of Toronto.

Should the options to renew be exercised, then the General Manager of Parks, Forestry and Recreation will request the Director of Purchasing and Materials Management to provide the necessary contract renewals under the same terms and conditions to exercise the two (2) addition separate one (1) year periods, January 1, 2009 to December 31, 2009 at \$475,650.00 net of GST and January 1, 2010 to December at \$499,432.50 net of GST.

The total potential contract award including option years identified in this report is \$1,428,082.50 net of GST.

The Bid Committee considered a report (July 30, 2008) from the Acting Director of Purchasing and Materials Management, advising on the results of the Request for Quotation (RFQ) 6113-08-3093 and requesting the Bid Committee to authorize staff to award a contract to the recommended bidder for the supply and delivery of one (1) Latest Model, Cab and Chassis with Sewer Combination Machine and one (1) Latest Model, Cab and Chassis with Dedicated Hydro Excavator, all in accordance with specifications as requested by Fleet Services Division.

Recommendation:

The Acting Director of Purchasing and Materials Management recommends that:

1. The Bid Committee authorize staff to award a contract for the supply and delivery of one (1) latest model, cab and chassis with sewer combination machine and one (1) latest model, cab and chassis with dedicated hydro excavator to The Equipment Specialist Inc., in the total amount of \$796,478.40 net of GST, having submitted the lowest bid meeting specifications.

Authority be granted to award Contract No. 08FS-50WP, Tender Call 128-2008, for the Construction of Burke Brook/Sherwood Creek Channel and Fish Passage Restoration to Dynex Construction Ltd., in the amount of \$524,727.08 net of GST, having submitted the lowest bid meeting specifications in conformance with the tender requirements.

Recommendation:

The Acting Director of Purchasing and Materials Management recommends that:

Authority be granted to award REOI 3903-08-5041 to establish a roof repair and replacement contractor roster list with Applewood Roofing & Sheet Metal Ltd., Trinity Roofing Ltd., Nortex Roofing Ltd., and Flynn Canada Ltd., for work at various Parks, Forestry and Recreation buildings within the City of Toronto, being the highest scoring proponents satisfying the requirements of the REOI, each in an amount up to \$1,000,000.00 net of GST, from the date of award until December 31, 2008, with options to renew each contract at the sole discretion of the General Manager, Parks Forestry and Recreation, for two additional one-year periods in an amount up to \$1,000,000.00 each year net of GST.
