The Bid Committee adopted the staff recommendation in the Recommendation Section of the report (November 7, 2008) from the Acting Director of Purchasing and Materials Management.

Report (November 7, 2008) from the Acting Director of Purchasing and Materials Management, advising on the results of the Request for Quotation (RFQ) 6034-08-7152 for digester cleaning at Ashbridges Bay Treatment Plant (ABTP) and sludge holding tank cleaning at Highland Creek Treatment Plant (HCTP) and requesting authority to award a contract to the recommended bidder.
