7.2 Union Station - Pedestrian Planning Initiatives

Jeff Bateman, Senior Planner, Transportation Planning, City Planning Division, gave a presentation respecting Union Station – Pedestrian Planning Initiatives, and responded to questions from Committee members.

The Committee thanked Jeff Bateman for his presentation.

On motion by Elizabeth Walker, the Toronto Pedestrian Committee decided to invite GO Transit to a future meeting of the Committee to discuss Union Station – Pedestrian Planning Initiatives and to answer any questions members may have.

7.3 Pedestrian Collision Study and Collision Summary Leaflet

The Toronto Pedestrian Committee considered a report (January, 2007) from Mike Brady, Manager, Transportation Services Division, Traffic Safety Unit, titled "City of Toronto Pedestrian Collision Study" prepared by Transportation Services Division, Traffic Data Centre and Safety Bureau.

The Toronto Pedestrian Committee also considered the Pedestrian Collision Summary Leaflet for the period January 1–June 30, 2007, prepared by Transportation Services, Traffic Management Centre, Traffic Safety Unit.

Mike Brady, Manager, Transportation Services, Traffic Management Centre, Traffic Safety Unit, gave a power point presentation and responded to questions from Committee members.

Police Constable Samantha Rozich, Traffic Services, Safety Programs Office, Toronto Police, addressed the Committee, and responded to questions from Committee members.

Mr. Brady agreed to provide the Committee Secretary with a copy of the full Pedestrian Collision Study for distribution to Members.

The Committee thanked Mike Brady, Manager, Transportation Services, and Police Constable Samantha Rozich, for attending the meeting.

On motion by Dylan Reid, the Toronto Pedestrian Committee deferred this item to a future meeting to enable interested members to receive the full Pedestrian Collision Study and to communicate with each other to generate ideas and prepare a brief report for consideration at the future meeting.

7.4 Transportation Services – Staff Update

The Toronto Pedestrian Committee considered a communication (February 7, 2008) from Daniel Egan, Manager, Pedestrian and Cycling Infrastructure, advising that staff will provide verbal updates on:

- 1. Toronto Walking Strategy;
- 2. Toronto Walking Survey; and
- 3. Walking Website.

The Toronto Pedestrian Committee also had before it a copy of a power point presentation on the Toronto Walking Survey, from Dan Egan, Manager, Pedestrian and Cycling Infrastructure.

1. City of Toronto's Walking Strategy

Dan Egan, Manager, Pedestrian and Cycling Infrastructure, gave a verbal report. Detailed timelines will be provided at the March 18, 2008 meeting.

The working group created to informally draft a vision statement for the City of Toronto's Walking Strategy, comprised of Laurel Fortin, Margaret Hasting-James, Jennifer Niece, Dylan Reid, and Beth Milroy (Minute 6.6), will be holding a brainstorming session. The group will report back to the Toronto Pedestrian Committee on March 18, 2008.

2. Toronto Walking Survey

The verbal report by Jennifer Hyland, Transportation Services Division, on the results of the Toronto Walking Survey, will be given at the March 18, 2008 meeting.

3. City of Toronto Walking Website:

Pauline Craig, City Planning, Transportation Services, gave a verbal update on the City of Toronto Walking Website. The website should be ready by the end of March. Members expressed an interest in previewing the website at its March 18, 2008 meeting.

7.5 Working Groups

The Toronto Pedestrian Committee considered a communication (February 19, 2008) from Fred Sztabinski, Chair, Budget Working Group, Toronto Pedestrian Committee providing an update on the 2008 Operating Budget.

Mr. Sztabinski requested that the City of Toronto Budget Committee be asked to fund a full time trails and pathways planner for the Parks, Forestry and Recreation Division.

The Toronto Pedestrian Committee requested Mr. Sztabinski to draft the letter.

7.6 Six Points Interchange Reconfiguration - Municipal Class Environmental Assessment Study - Notice of Filing of Environmental Study Report.
