# 15.1 New TTC Shelters Leaving Inadequate Sidewalk Space

The Toronto Pedestrian Committee considered a letter (November 11, 2008) from Dylan Reid, Co-Chair, Toronto Pedestrian Committee, regarding sidewalk space required in order to meet full accessibility standards, and the process for selection and placement of new TTC shelters.

On motion by Sean Marshall, the Toronto Pedestrian Committee deferred consideration of this matter until its next meeting on Tuesday, January 20, 2009, and requested the Manager of the Co-ordinated Street Furniture Program to attend the meeting to address this issue.

# 15.2 Motorized Bicycles on Sidewalks

The Toronto Pedestrian Committee considered an e-communication (November 7, 2008) from Dylan Reid, Co-Chair, Toronto Pedestrian Committee, regarding the new kinds of "bicycles" being driven on sidewalks which include both pedals and motors, and proposing that the Toronto Pedestrian Committee recommend to the Public Works and Infrastructure Committee that the relevant by-law be amended to add that no bicycle that includes a motor of any kind be allowed to travel on a sidewalk.

On motion by Councillor Stintz, the Toronto Pedestrian Committee deferred consideration of this matter until its next meeting on Tuesday, January 20, 2009, and requested Daniel Egan, Manager, Pedestrian and Cycling Infrastructure, Transportation Services, to consult with the City Solicitor and make a presentation on e-bikes at the next meeting.
