5. **Yasir Nawaz Kayani** (*Report No. 5633*)
Applicant for Renewal of Taxicab Driver's Licence No. D01-3833194.

The Tribunal renewed Yasir Nawaz Kayani's taxicab driver's licence No. D01-3833194, effective immediately, subject to the following conditions:

- (1) immediately upon being renewed, the licence will be placed on probation for a period of two (2) years;
- (2) prior to each of the next two renewals of the licence, Mr. Kayani must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;

- (3) during the probationary period, if Mr. Kayani incurs any new charges or convictions under the *Highway Traffic Act*, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (4) during the probationary period, if Municipal Licensing and Standards has any concerns with any new *Highway Traffic Act* charges or convictions, those matters and report No. 5633 may be brought back to the Tribunal for a full hearing.

6. Swaranjit Singh Mann (*Report No. 5629*)
Applicant for Renewal of Tow Truck Driver's Licence No. D09-3474436.

The Tribunal renewed Swaranjit Singh Mann's tow truck driver's licence No. D09-3474436, effective immediately, subject to the following conditions:

- (1) immediately upon being renewed, the licence will be placed on probation for a period of two (2) years;
- (2) prior to each of the next two renewals of the licence, Mr. Mann must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;

- (4) during the probationary period, if Municipal Licensing and Standards has any concerns with any new *Highway Traffic Act* charges or convictions, those matters and report No. 5635 may be brought back to the Tribunal for a full hearing.
