
TORONTO LICENSING TRIBUNAL: February 9, 2012
Summary of Decisions
Peacock / Hall / Miskin

1. Kulwant Singh (Report No. 5662)

Applicant for Renewal of Taxicab Driver's Licence No. D01-2001321.

The Tribunal adjourned this matter to April 19, 2012, *peremptory* to Mr. Singh.
(Mr. Singh failed to attend today's hearing.)

2. Tariq Ahmad (Report No. 5643)

Applicant for Renewal of Taxicab Driver's Licence No. D01-2001949.

The Tribunal adjourned this matter to April 19, 2012.

3. Mohamed Salah Abdalla (Report No. 5596)

Applicant for Renewal of Ambassador Taxicab Owner's Licence No. V02-3372151.

The Tribunal renewed Mohamed Salah Abdalla's Ambassador taxicab owner's licence No. V02-3372151, effective immediately, with the following conditions recommended by the City:

- (1) the licence will be suspended for a period of two (2) days;
- (2) immediately upon being renewed, the licence will be placed on probation for a period of three (3) years;
- (3) prior to each of the next three renewals of the licence, Mr. Abdalla must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (4) during the probationary period, if Mr. Abdalla incurs any new charges or convictions under the *Highway Traffic Act* or the Toronto Municipal Code, he must notify Municipal Licensing and Standards, in writing, within three (3) business days; and
- (5) during the probationary period, if Municipal Licensing and Standards has any concerns with any new charges or convictions, those matters and report No. 5596 and any updating material may be brought back before the Tribunal for a full hearing.

The Tribunal ordered Mr. Abdalla to surrender his licence, his photo card and his licence plate to Municipal Licensing and Standards by 9:00 a.m. on February 13, 2012 and pick these up in the morning on February 15, 2012.

4. **Raviraj Selvaratnam** (*Report No. 5687*)
Applicant for a Tow Truck Driver's Licence (Application No. B182653).

The Tribunal denied Raviraj Selvaratnam's application (No. B182653) for a tow truck driver's licence.

5. **Kulwinder Singh** (*Report No. 5456*)
Holder of Taxicab Owner's Licence No. V02-3007201, Plate No. 496.

The Tribunal adjourned this matter to April 26, 2012, *peremptory* to Mr. Singh.

The Tribunal ordered that the condition placed on Mr. Singh's licence by the Tribunal on September 22, 2011 is to continue i.e. that Mr. Singh will not be allowed to drive his taxicab in the interim and until the matter has been resolved before the Tribunal; and the endorsement on his licence prohibiting him from driving shall continue.
