
TORONTO LICENSING TRIBUNAL: March 1, 2012
Summary of Decisions

1. Estate of Nick Longo (*Report No. 5808*)

Stanley A. Fromstein – Estate Trustee during Litigation

Holder of Taxicab Owner's Licence No. V02-4180398 for Taxicab Plate No. 1269.

The Tribunal extended taxicab owner's licence No. V02-4180398, plate No. 1269 in the Estate of Nick Longo for a period of six months (up to September 7, 2012).

2. Kirubaharan Kanagasabapathy (*Report No. 5700*)

Applicant for a Limousine Driver's Licence (Application No. B182233).

The Tribunal approved the following joint recommendation:

Kirubaharan Kanagasabapathy's limousine driver's licence No. B182233 will be renewed, effective immediately, subject to the following conditions:

- (1) immediately upon being renewed, the licence will be placed on probation for a period of three (3) years;
- (2) prior to each of the next three renewals of the licence, Mr. Kanagasabapathy must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (3) during the probationary period, if Mr. Kanagasabapathy incurs any new charges or convictions under the *Highway Traffic Act*, he must notify Municipal Licensing and Standards, in writing, within five (5) business days; and
- (4) during the probationary period, if Municipal Licensing and Standards has any concerns with any new charges or convictions, those matters and report No. 5700 and any updating material may be brought back before the Tribunal for a full hearing.

3. Mahbub Sarder (*Report No. 5576*)

Applicant for Renewal of Taxicab Driver's Licence No. D01-3362471.

The Tribunal adjourned this matter to April 19, 2012, *peremptory* to Mr. Sarder.

4. **Mohammed Dewan** (*Report No. 5694*)
o/a Millennium Driving School
Applicant for Renewal of Driving School Instructor's Licence No. V11-3086459.

The Tribunal approved the following joint recommendation:

Mohammed Dewan's driving school instructor's licence No. V11-3086459 will be renewed, effective immediately, subject to the following conditions:

- (1) immediately upon being renewed, the licence will be placed on probation for a period of two (2) years;
- (2) prior to each of the next two renewals of the licence, Mr. Dewan must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (3) during the probationary period, if Mr. Dewan incurs any new charges or convictions under the *Highway Traffic Act*, he must notify Municipal Licensing and Standards, in writing, within five (5) business days; and
- (4) during the probationary period, if Municipal Licensing and Standards has any concerns with any new charges or convictions, those matters and report No. 5694 and any updating material may be brought back before the Tribunal for a full hearing.

5. **Almazi Rashid** (*Report No. 5646*)
Applicant for Renewal of Taxicab Driver's Licence No. D01-3361525.

The Tribunal renewed Almazi Rashid's taxicab driver's licence No. D01-3361525, effective immediately, subject to the following conditions:

- (1) immediately upon being renewed the licence will be suspended for a period of three (3) days;
- (2) immediately upon being re-instated, the licence will be placed on probation for a period of three (3) years;
- (3) prior to each of the next three renewals of the licence, Mr. Rashid must provide to Municipal Licensing and Standards, at his own expense, an updated abstract of his driving record;
- (4) during the probationary period, if Mr. Rashid incurs any new charges or convictions under the *Highway Traffic Act*, he must notify Municipal Licensing and Standards, in writing, within five (5) business days; and
- (5) during the probationary period, if Municipal Licensing and Standards has any concerns with any new charges or convictions, those matters and report No. 5646

and any updating material may be brought back before the Tribunal for a full hearing.

The Tribunal ordered Mr. Rashid to surrender his licence and photo ID to Municipal Licensing and Standards by 9:00 a.m. on March 2, 2012 and pick these up after 9:00 a.m. on March 5, 2012.
